Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Beach Cities Orthopedic 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Beach Cities Orthopedic 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A - DESCRIPTION OF THE PLAN

The following description of the Beach Cities Orthopedic 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan established by Beach Cities Orthopedic and Beach Cities Orthopedic Surgery Center, LLC (collectively, the “Employer”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan provides for a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Employer. The plan administrator is responsible for the oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance. Capital Bank and Trust Company (the “Trustee”) is responsible for the custody and management of the Plan’s assets.

Due to an acquisition on July 23, 2021 by American Orthopedic Partners LLC (“AOP”), the Plan was frozen effective August 1, 2021. Effective July 14, 2023, the Employer was reacquired by the original members, and a decision to merge the Plan into the AOP plan was reversed. Based upon the advice of legal counsel, the Employer filed an application under the IRS Voluntary Correction Program to correct various Plan failures related to the original acquisition transaction. In addition, legal counsel determined that a partial plan termination had occurred effective July 23, 2021, and all affected participants became fully-vested in their participant accounts. All active employees were reinstated and deemed eligible for the Plan with an effective date of September 1, 2023 (see Notes I and J).

2. Eligibility

Effective September 1, 2023, all non-union and non-leased employees, other than active employees as of September 1, 2023, who are U.S. residents are eligible to participate in the Plan upon one year of employment with the Employer and attainment of age 21, and can enter the Plan on the first day of the plan year and the first day of the seventh month of the plan year. Employees as of September 1, 2023 were automatically eligible to enter the Plan on September 1, 2023 if age 21. Employees who are eligible for participation in the Plan are also eligible for employer safe harbor contributions and employer discretionary profit-sharing contributions.

3. Contributions

Effective September 1, 2023, participants may elect to contribute, on a tax-deferred basis up to 100% of their eligible compensation up to the maximum limitations under the IRC. In addition, effective January 1, 2024, participants may elect to contribution up to 100% on an after-tax Roth basis (see Note I). Participants who had attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Participants may direct contributions, as desired, in any of several investments offered by the Trustee and may change their investment options daily. In addition, the Employer will make safe harbor contributions limited to a maximum of 3% of the participant’s compensation (see Note I).

3. Contributions (continued)

The Employer may also make employer discretionary profit-sharing contributions for each active and eligible participant, in an amount subject to determination on an annual basis by the Board of Directors of the Employer.

4. Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's safe harbor contributions, as well as allocations of the discretionary employer's profit-sharing contribution, if applicable, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Notes Receivable From Participants

Effective September 1, 2023, participants may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance (not to exceed \$50,000 less the highest outstanding loan balance during the prior twelve-month period). The loans are secured by the balance in the participant's account. Prior to July 31, 2024, the amount of loans that a participant can have outstanding at one time shall be determined by the plan administrator (see Note I). Effective July 31, 2024, the amount of loans that a participant can have outstanding at one time is two. All loans shall bear a rate of interest as determined by the plan administrator upon issuance (see Note I). Loans must be paid back within five years of the date of issuance in accordance with terms established by the plan administrator. Loans for the purchase of a principal residence may be paid back over a longer period. Loans are due and payable upon the participant's termination of employment with the Employer.

6. Vesting

Employee contributions, employer safe harbor contributions, rollovers and actual earnings on all such contributions are fully vested at all times. Vesting of discretionary employer profit-sharing contributions and actual earnings thereon, are based upon the participant's years of service with the Employer as follows:

7. Benefit Payments

Upon termination of employment with the Employer, a participant may receive a lump sum disbursement if his or her vested account balance is less than \$1,000. If the vested account balance is between \$1,000 and \$5,000, a lump sum will be distributed directly to an individual retirement account unless the participant elects otherwise. For balances greater than \$5,000, the participant is entitled to a lump sum payment. In the event of death or total and permanent disability, a participant's beneficiary or the participant is entitled to the total value of the participant's account. In addition, upon attaining the later of age 65 or five years of participation in the Plan, participants may receive distributions. Hardship withdrawals are not permitted.

8. Administrative Expenses

Certain expenses of maintaining the Plan are paid from the assets of the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in fair value of investments.

9. Forfeitures

Forfeitures of terminated participants' nonvested accounts may be used to pay plan expenses or may be applied against Employer contributions. During the year ended December 31, 2024, \$6,334 of forfeitures were utilized for Employer contributions. As of December 31, 2024 and 2023, there was \$5,357 and \$6,334, respectively, of unallocated forfeitures included in net assets available for benefits. The Employer discretionary profit-sharing receivable as of December 31, 2024 has been reduced by \$5,626 of forfeitures applied in the subsequent year.

10. Plan Amendments and Termination

Although it has not expressed such intent, the Employer, by action of its Board of Directors, reserves the right, at any time, to amend or terminate the Plan. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

2. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the plan administrator. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

5. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding increase to deductions from net assets.

6. Benefit Payments

Benefits are recorded when paid.

7. Subsequent Events

Plan management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

NOTE C - CERTIFICATION BY TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all of the investment information, including investment income, included in the accompanying financial statements and supplemental schedules has been certified as complete and accurate by the Trustee of the Plan.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Trustee is a party-in-interest with respect to the Plan. Investments are held with and managed by the Trustee. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than direct payment. Additional fees may be paid directly to the Trustee or other parties-in-interest. Notes receivable and the related interest income are considered related party transactions.

NOTE F - INCOME TAX STATUS

The IRS has issued an opinion letter to a service provider utilized by the third-party administrator ("TPA") dated June 30, 2020, that the non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the IRC (see Note I). Although the Plan did not seek a favorable determination letter with respect to the initial adoption of the plan document, nor with any plan amendments or restatements, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expect to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H - PROHIBITED TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Employer failed to remit employee contributions to the Plan on a timely basis, as required by DOL Reg. 2510.3-102, resulting in prohibited transactions. The Employer is in the process of computing the lost earnings related to the late remittances for deposit to the Plan for the year ended December 31, 2024, and has corrected the late remittances to the Plan for the year ended December 31, 2023.

NOTE I - PLAN RESTATEMENT & AMENDMENTS

Effective September 1, 2023, the Employer adopted a non-standardized pre-approved plan of the TPA and the Plan was restated (see Note F). The restatement provided for the following modifications to the Plan's provisions:

- Allow immediate participation for all eligible employees employed as of September 1, 2023 (see Note A-1).
- Year of service will include employment at American Orthopedic Partners (see Note A-1)
- Roth deferrals are allowed effective January 1, 2024 (see Notes A-3).
- Safe harbor election to be determined at Plan year end and minimum 3% of Plan compensation (see Note A-3)
- Loans shall bear interest rate based on plan administrator's determination (see Note A-5).
- Loans minimum amount to be determined by plan administrator (see Note A-5).
- Formal adoption of the Setting Every Community Up for Retirement Enhancement Act ("SECURE") and Coronavirus Aid, Relief, and Economic Security ("CARES") provisions

Effective July 31, 2024, the maximum number of loans outstanding at any one time was increased to two (see Note A-5).

NOTE J - SUBSEQUENT EVENTS

The submission under the IRS Voluntary Correction Program was accepted on April 22, 2025 and no further action is required to be taken for the Plan (see Note A-1).
