Profit Sharing Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule Schedule H, Line 4i - Schedule of Assets (Held at End of Year) for the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following brief description of the S.B.J.S., P.C. Profit Sharing Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan Document for more detailed information.

General: The Plan is a defined contribution plan covering all employees of S.B.J.S., P.C. (the "Company") who have attained age 21 and completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974. The Plan was established January 1, 1995, for the benefit of S.B.J.S., P.C employees.

Administration: S.B.J.S., P.C., the Plan Sponsor, controls and manages the operation and administration of the Plan. Empower Trust Company, LLC serves as the Trustee and Custodian of the Plan. Empower Retirement Services serves as the Recordkeeper of the Plan.

Contributions: Each year, participants may contribute up to the lesser of \$69,000 or 100 percent of compensation, as defined in the Plan, in the form of elective deferrals subject to limitations defined in the Internal Revenue Code. Participants may also elect to roll over any amounts from other qualified retirement plans. The Company contributes a discretionary match of up to 66.7% of the participant's elective deferral not exceeding 6% of a participant's compensation. Additionally, the Plan provides safe-harbor non-elective contributions of 3% of participant's compensation. The matching Company contribution is invested based on the participant's allocation of investments.

The Company also contributes a discretionary profit sharing contribution to the Plan based on profitability. The profit-sharing allocation is based on individual classifications, aggregated into three rate groups which are: (1) physicians, (2) executive management, and (3) others. The profit-sharing contribution for eligible physicians was 6.28% of the participating physicians' compensation for the years ended December 31, 2024 and 2023. The profit-sharing contribution for executive management was 1.00% of the participants' compensation for the years ended December 31, 2024 and 2023. The profit-sharing contribution for other employees was 1.00% of the participants' compensation for the years ended December 31, 2024 and 2023. The contribution is invested based on participants' allocation of investments. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution, the Company's matching contribution, earnings on the participant's investments, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately 100 percent vested in their elective deferral contributions. Vesting of employer contributions is based on years of service. Employer contributions are subject to a graded vesting schedule as follows: two year of service: 20%, three years of service: 40%, four years of service: 60%, five years of service: 80%, and six years of service: 100%. Participants will be 100% vested upon death, disability, or normal retirement of age 65.

Investment Options: All Plan investments are participant-directed. Participants can choose between multiple investment funds and can direct investment among the multiple funds. The investment alternatives differ in the level of potential investment earnings and risk. Participants may change their investment direction and existing investment mix at any time.

Payment of Benefits: On termination of service, a participant whose vested account balance exceeds \$5,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account in of lump-sum amount. If the vested account balance is less than \$5,000 but exceeds \$1,000, the Plan may distribute the account without consent by directly rolling over the account balance. For vested account balances of \$1,000 or less, the Plan may distribute without consent the account balance as a cash-out distribution and mail the check to the participant's most recent address on file. In-service distributions are allowed upon attainment of 50 years of age or for qualified financial hardships as defined by the Plan. Benefits are recorded when paid.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,167 and \$10,473, respectively. These accounts will be first used to pay administrative expenses and then used to reduce future employer contributions. For the years ending December 31, 2024 and 2023, \$8,215 and \$5,165 were used to pay administrative expenses while \$-0- and \$-0- were used to reduce employer contributions, respectively.

Basis of Accounting and Income Recognition: The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates: In preparing financial statements in conformity with generally accepted accounting principles, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract which is stated at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between marker participants at the measurement date. See note 4 for further discussions on fair value.

Note 2. Summary of Significant Accounting Policies, Continued

Purchases and sales are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Operating Expenses: The Plan Sponsor provides certain administrative and accounting services to the Plan at no cost. Certain administrative expenses are paid directly by the Plan Sponsor and include audit, accounting and legal fees. Administrative expenses directly allocable to individual participant-directed accounts are paid from the participant's account.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated the need for disclosures and/or adjustments resulting from subsequent events through September 30, 2025, the date the financial statements were available to be issued. This evaluation did not result in any subsequent events that necessitated adjustments.

Note 3. Information Certified by the Trustee (Unaudited)

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements, which was prepared by the Trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that such information is complete and accurate.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data or correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be relevant and observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: Accounts are primarily consists of mutual funds, common stocks, and exchange-trade funds that are valued on basis of readily determinable market prices. These investments are deemed to be actively traded.

Note 5. Tax Status

Effective January 1, 2021, the Plan was amended and restated by adopting the pre-approved plan designed by CCH Incorporated, DBA ftwilliam.com. On June 30, 2020, the Internal Revenue Service (IRS) determined and informed Administration Partners, LLC by letter that the Plan is designed in accordance with applicable sections of the IRC. The Company properly elected not to file for an individual determination letter and relies on the letter issued to Administration Partners, LLC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to audits by tax authorities; however, there are currently no audits in progress for any tax periods.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by CapSouth Partners, the Plan's investment advisors. Empower Retirement Services is the Plan's Recordkeeper and Empower Trust Company, LLC is the Plan's Trustee and Custodian, and, therefore, transactions with these entities qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and investment advisor services amounted to \$59,238 and \$50,875 for the years ended December 31, 2024 and 2023, respectively.

Note 9. Guaranteed Investment Contract

The Plan entered into a traditional benefit-responsive investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate (1.25% and 1.25% at December 31, 2024 and 2023, adjusted quarterly) that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Great-West Life & Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. Withdrawals from the account prior to the end of the guaranteed interest period may be subject to a market value adjustment.

Additionally, the issuer is permitted to terminate the contract with the Plan and settle at an amount different from the contract value in certain circumstances, such as a material representation to the Plan or a breach of a material obligation under the contract.

Independent Auditor's Report

To the Board of Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of S.B.J.S., P.C. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the S.B.J.S., P.C. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1. Description of Plan

The following brief description of the S.B.J.S., P.C. Profit Sharing Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan Document for more detailed information.

General: The Plan is a defined contribution plan covering all employees of S.B.J.S., P.C. (the "Company") who have attained age 21 and completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974. The Plan was established January 1, 1995, for the benefit of S.B.J.S., P.C employees.

Administration: S.B.J.S., P.C., the Plan Sponsor, controls and manages the operation and administration of the Plan. Empower Trust Company, LLC serves as the Trustee and Custodian of the Plan. Empower Retirement Services serves as the Recordkeeper of the Plan.

Contributions: Each year, participants may contribute up to the lesser of \$69,000 or 100 percent of compensation, as defined in the Plan, in the form of elective deferrals subject to limitations defined in the Internal Revenue Code. Participants may also elect to roll over any amounts from other qualified retirement plans. The Company contributes a discretionary match of up to 66.7% of the participant's elective deferral not exceeding 6% of a participant's compensation. Additionally, the Plan provides safe-harbor non-elective contributions of 3% of participant's compensation. The matching Company contribution is invested based on the participant's allocation of investments.

The Company also contributes a discretionary profit sharing contribution to the Plan based on profitability. The profit-sharing allocation is based on individual classifications, aggregated into three rate groups which are: (1) physicians, (2) executive management, and (3) others. The profit-sharing contribution for eligible physicians was 6.28% of the participating physicians' compensation for the years ended December 31, 2024 and 2023. The profit-sharing contribution for executive management was 1.00% of the participants' compensation for the years ended December 31, 2024 and 2023. The profit-sharing contribution for other employees was 1.00% of the participants' compensation for the years ended December 31, 2024 and 2023. The contribution is invested based on participants' allocation of investments. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution, the Company's matching contribution, earnings on the participant's investments, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately 100 percent vested in their elective deferral contributions. Vesting of employer contributions is based on years of service. Employer contributions are subject to a graded vesting schedule as follows: two year of service: 20%, three years of service: 40%, four years of service: 60%, five years of service: 80%, and six years of service: 100%. Participants will be 100% vested upon death, disability, or normal retirement of age 65.

Investment Options: All Plan investments are participant-directed. Participants can choose between multiple investment funds and can direct investment among the multiple funds. The investment alternatives differ in the level of potential investment earnings and risk. Participants may change their investment direction and existing investment mix at any time.

Payment of Benefits: On termination of service, a participant whose vested account balance exceeds \$5,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account in of lump-sum amount. If the vested account balance is less than \$5,000 but exceeds \$1,000, the Plan may distribute the account without consent by directly rolling over the account balance. For vested account balances of \$1,000 or less, the Plan may distribute without consent the account balance as a cash-out distribution and mail the check to the participant's most recent address on file. In-service distributions are allowed upon attainment of 50 years of age or for qualified financial hardships as defined by the Plan. Benefits are recorded when paid.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,167 and \$10,473, respectively. These accounts will be first used to pay administrative expenses and then used to reduce future employer contributions. For the years ending December 31, 2024 and 2023, \$8,215 and \$5,165 were used to pay administrative expenses while \$-0- and \$-0- were used to reduce employer contributions, respectively.

Basis of Accounting and Income Recognition: The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates: In preparing financial statements in conformity with generally accepted accounting principles, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract which is stated at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between marker participants at the measurement date. See note 4 for further discussions on fair value.

Note 2. Summary of Significant Accounting Policies, Continued

Purchases and sales are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Operating Expenses: The Plan Sponsor provides certain administrative and accounting services to the Plan at no cost. Certain administrative expenses are paid directly by the Plan Sponsor and include audit, accounting and legal fees. Administrative expenses directly allocable to individual participant-directed accounts are paid from the participant's account.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated the need for disclosures and/or adjustments resulting from subsequent events through September 30, 2025, the date the financial statements were available to be issued. This evaluation did not result in any subsequent events that necessitated adjustments.

Note 3. Information Certified by the Trustee (Unaudited)

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements, which was prepared by the Trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that such information is complete and accurate.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data or correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be relevant and observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: Accounts are primarily consists of mutual funds, common stocks, and exchange-trade funds that are valued on basis of readily determinable market prices. These investments are deemed to be actively traded.

Note 5. Tax Status

Effective January 1, 2021, the Plan was amended and restated by adopting the pre-approved plan designed by CCH Incorporated, DBA ftwilliam.com. On June 30, 2020, the Internal Revenue Service (IRS) determined and informed Administration Partners, LLC by letter that the Plan is designed in accordance with applicable sections of the IRC. The Company properly elected not to file for an individual determination letter and relies on the letter issued to Administration Partners, LLC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to audits by tax authorities; however, there are currently no audits in progress for any tax periods.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by CapSouth Partners, the Plan's investment advisors. Empower Retirement Services is the Plan's Recordkeeper and Empower Trust Company, LLC is the Plan's Trustee and Custodian, and, therefore, transactions with these entities qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and investment advisor services amounted to \$59,238 and \$50,875 for the years ended December 31, 2024 and 2023, respectively.

Note 9. Guaranteed Investment Contract

The Plan entered into a traditional benefit-responsive investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate (1.25% and 1.25% at December 31, 2024 and 2023, adjusted quarterly) that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Great-West Life & Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

Note 9. Guaranteed Investment Contract, Continued

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. Withdrawals from the account prior to the end of the guaranteed interest period may be subject to a market value adjustment.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of S.B.J.S., P.C. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the S.B.J.S., P.C. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of Plan

The following brief description of the S.B.J.S., P.C. Profit Sharing Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan Document for more detailed information.

General: The Plan is a defined contribution plan covering all employees of S.B.J.S., P.C. (the "Company") who have attained age 21 and completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974. The Plan was established January 1, 1995, for the benefit of S.B.J.S., P.C employees.

Administration: S.B.J.S., P.C., the Plan Sponsor, controls and manages the operation and administration of the Plan. Empower Trust Company, LLC serves as the Trustee and Custodian of the Plan. Empower Retirement Services serves as the Recordkeeper of the Plan.

Contributions: Each year, participants may contribute up to the lesser of \$69,000 or 100 percent of compensation, as defined in the Plan, in the form of elective deferrals subject to limitations defined in the Internal Revenue Code. Participants may also elect to roll over any amounts from other qualified retirement plans. The Company contributes a discretionary match of up to 66.7% of the participant's elective deferral not exceeding 6% of a participant's compensation. Additionally, the Plan provides safe-harbor non-elective contributions of 3% of participant's compensation. The matching Company contribution is invested based on the participant's allocation of investments.

The Company also contributes a discretionary profit sharing contribution to the Plan based on profitability. The profit-sharing allocation is based on individual classifications, aggregated into three rate groups which are: (1) physicians, (2) executive management, and (3) others. The profit-sharing contribution for eligible physicians was 6.28% of the participating physicians' compensation for the years ended December 31, 2024 and 2023. The profit-sharing contribution for executive management was 1.00% of the participants' compensation for the years ended December 31, 2024 and 2023. The profit-sharing contribution for other employees was 1.00% of the participants' compensation for the years ended December 31, 2024 and 2023. The contribution is invested based on participants' allocation of investments. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution, the Company's matching contribution, earnings on the participant's investments, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1. Description of Plan, Continued

Vesting: Participants are immediately 100 percent vested in their elective deferral contributions. Vesting of employer contributions is based on years of service. Employer contributions are subject to a graded vesting schedule as follows: two year of service: 20%, three years of service: 40%, four years of service: 60%, five years of service: 80%, and six years of service: 100%. Participants will be 100% vested upon death, disability, or normal retirement of age 65.

Investment Options: All Plan investments are participant-directed. Participants can choose between multiple investment funds and can direct investment among the multiple funds. The investment alternatives differ in the level of potential investment earnings and risk. Participants may change their investment direction and existing investment mix at any time.

Payment of Benefits: On termination of service, a participant whose vested account balance exceeds \$5,000 will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account in of lump-sum amount. If the vested account balance is less than \$5,000 but exceeds \$1,000, the Plan may distribute the account without consent by directly rolling over the account balance. For vested account balances of \$1,000 or less, the Plan may distribute without consent the account balance as a cash-out distribution and mail the check to the participant's most recent address on file. In-service distributions are allowed upon attainment of 50 years of age or for qualified financial hardships as defined by the Plan. Benefits are recorded when paid.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,167 and \$10,473, respectively. These accounts will be first used to pay administrative expenses and then used to reduce future employer contributions. For the years ending December 31, 2024 and 2023, \$8,215 and \$5,165 were used to pay administrative expenses while \$-0- and \$-0- were used to reduce employer contributions, respectively.

Basis of Accounting and Income Recognition: The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates: In preparing financial statements in conformity with generally accepted accounting principles, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract which is stated at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between marker participants at the measurement date. See note 4 for further discussions on fair value.

Note 2. Summary of Significant Accounting Policies, Continued

Purchases and sales are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Operating Expenses: The Plan Sponsor provides certain administrative and accounting services to the Plan at no cost. Certain administrative expenses are paid directly by the Plan Sponsor and include audit, accounting and legal fees. Administrative expenses directly allocable to individual participant-directed accounts are paid from the participant's account.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events - The Plan has evaluated the need for disclosures and/or adjustments resulting from subsequent events through September 30, 2025, the date the financial statements were available to be issued. This evaluation did not result in any subsequent events that necessitated adjustments.

Note 3. Information Certified by the Trustee (Unaudited)

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements, which was prepared by the Trustee of the Plan, and furnished to the Plan Administrator. Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data or correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be relevant and observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts: Accounts are primarily consists of mutual funds, common stocks, and exchange-trade funds that are valued on basis of readily determinable market prices. These investments are deemed to be actively traded.

Note 5. Tax Status

Effective January 1, 2021, the Plan was amended and restated by adopting the pre-approved plan designed by CCH Incorporated, DBA ftwilliam.com. On June 30, 2020, the Internal Revenue Service (IRS) determined and informed Administration Partners, LLC by letter that the Plan is designed in accordance with applicable sections of the IRC. The Company properly elected not to file for an individual determination letter and relies on the letter issued to Administration Partners, LLC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to audits by tax authorities; however, there are currently no audits in progress for any tax periods.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by CapSouth Partners, the Plan's investment advisors. Empower Retirement Services is the Plan's Recordkeeper and Empower Trust Company, LLC is the Plan's Trustee and Custodian, and, therefore, transactions with these entities qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and investment advisor services amounted to \$59,238 and \$50,875 for the years ended December 31, 2024 and 2023, respectively.

Note 9. Guaranteed Investment Contract

The Plan entered into a traditional benefit-responsive investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate (1.25% and 1.25% at December 31, 2024 and 2023, adjusted quarterly) that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Great-West Life & Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. Withdrawals from the account prior to the end of the guaranteed interest period may be subject to a market value adjustment.

Additionally, the issuer is permitted to terminate the contract with the Plan and settle at an amount different from the contract value in certain circumstances, such as a material representation to the Plan or a breach of a material obligation under the contract.
