Notes to Financial Statements

(1) Description of the Plan

The following description of the Steamfitters Vacation Fund Local Union #475 (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a multiemployer collectively bargained defined contribution health and welfare plan. The Plan was established in accordance with an agreement entered into among Steamfitters Local Union #475, Mechanical Contractors' Association of New Jersey, and other independent contractors in 1953 to provide a method by which Steamfitters, Journeymen and Apprentices, employed in the bargaining unit encompassed by Local Union #475, would have a portion of their wages withheld and invested in their name. The administration of the Plan is the responsibility of a Board of Trustees, comprised of union and employer trustees. The jurisdiction of the Plan includes Essex and Union Counties, portions of Hunterdon, Mercer, Middlesex, Morris, Somerset and Warren Counties. The Plan covers all members employed under the terms of the collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1947 ("ERISA").

Funding Policy - Contributing employers are required to make contribution to the Plan on behalf of each participant on the basis of a rate fixed by the applicable collectible bargaining agreement in effect. Employee participants are not required to contribute to the Plan. Contributions to the Plan by employers are 10% of participant gross wages.

Benefits - The Plan accumulates contributions made on behalf of participants, credits them with interest, and prepares an annual payment in the subsequent year.

(2) Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Adoption of Recent Accounting Pronouncements - Effective January 1, 2023, the Plan adopted ASC 326 which changed how entities will measure credit losses for certain financial assets that aren't measured at fair value through changes in net assets available to benefits. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing the Plan's exposure to credit risk and the measurement of credit losses. The primary financial asset held by the Plan that is subject to the guidance in ASC 326 is employers' contributions receivable. The impact of the adoption was not considered material to the financial statements and primarily resulted solely in enhanced disclosures.

On July 30, 2025, the FASB issued Accounting Standards Update (ASU) 2025-05, Financial Instruments-Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets. This standard allows entities to elect a practical expedient that assumes that current conditions as of the fiscal year-end do not change for the remaining life of the asset. In addition, the standard provides for consideration of subsequent collections in developing reasonable and supportable forecasts as part of estimating expected credit losses. The Plan elected to early adopt this standard in the reporting period ended December 31, 2024.

Use of Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported, benefits payable and disclosure of contingent assets, and liabilities. Actual results could differ from those estimates.

Notes to Financial Statements

(2) Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information principally provided by the investment custodian.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis.

Employer Contributions - The Plan's policy is to recognize contributions based on the latest executed collective bargaining agreement on an individual employer basis. Contributions from participating employers are based on a percentage of the participating employers' wages for covered employees and are payable to the Plan during the subsequent month. Contributions due but not paid prior to year-end are recorded as contributions receivable. The Plan evaluates participating employers' contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection, including subsequent period collection activity. As of December 31, 2024 and 2023, the Plan did not record a credit loss allowance for employers' contributions receivable.

The Board of Trustees has established a program to review participating employer records in order to determine compliance with contribution provisions of the collective bargaining agreement. As a result of this program, previously unreported contributions are identified related to current and prior fiscal years. However, due to the collection efforts required by the Plan, including litigation, the ultimate realization of any additional contribution receivable cannot be reasonably estimated until the collection process is completed. Accordingly, the Plan primarily recognizes these previously unreported contributions in the fiscal year in which the settlement proceeds are received.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Administrative Expenses - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. The Plan shares certain administrative expenses with related ERISA plans. In computing these allocated costs, various factors were considered, including the time spent, space used, costs incurred, and volume of transactions relating to the Plan in relation to the other plans.

Subsequent Events - The Plan has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.

(3) Vacation Benefits Payable

In accordance with FASB Accounting Standards Codification Topic 965, Health and Welfare Benefit Plans, the liability for vacation benefits payable is not presented on the statement of net assets available for benefits. Vacation benefits payable at December 31, 2024 and 2023 were \$2,766,336 and \$3,342,747, respectively. Vacation benefits payable at December 31, 2024 and 2023 represents calendar year contributions collected from employers for vacation benefits for active participants which were paid annually in January of the subsequent fiscal year.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

(4) Fair Value Measurements (Continued)

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest Bearing Cash Accounts: Valued at amortized cost which approximates fair value.

(5) Related Party and Party-in-Interest Transactions

Certain administrative expenses incurred by Steamfitters Welfare Fund Local Union #475 (the "Welfare Fund") are allocated throughout the year to the various other affiliated funds of Steamfitters Local Union #475. The Plan's share amounted to \$1,127 and \$1,901 for the years ended December 31, 2024 and 2023, respectively.

The Plan pays fees for several arrangements with services providers and affiliated entities. These transactions are considered exempt party in interest transactions under ERISA.

The net amounts due to affiliated Steamfitters Local 475 funds of the Plan at December 31, 2024 and 2023 were (\$717) and (\$1,028), respectively, resulting from the previously described transactions. These amounts are unsecured and are typically repaid in the following fiscal year. The amounts due are as follows:

(6) Tax Status

The Plan is exempt from federal income tax under Section 501(c)(9) of the Internal Revenue Code ("IRC"). The Plan believes it is currently designed and has continued to operate in compliance with applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Plan Termination

Under certain conditions, the Plan may be terminated. Upon termination, the assets then remaining will be subject to the applicable provisions of the Plan then in effect and will be used until exhausted to pay benefits to participants in the order of their entitlement, subject to the provisions of ERISA.

(8) Risks and Uncertainties

Investment Risk - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

Concentration of Credit Risk - The Plan maintains cash accounts at high credit-quality financial institutions. Cash accounts at these financial institutions are insured by the Federal Deposit Insurance Corporation ("FDIC") up to \$250,000. From time to time, the Plan may have amounts on deposit in excess of FDIC limits. Management believes the Plan is not exposed to any significant credit risk on its cash accounts. As of the years ended December 31, 2024 and 2023, the Plan had cash balances in excess of federally insured limits of approximately \$2,627,000 and \$3,160,000, respectively.
