Note 1: Description of Plan

The following description of the JPN Management, Inc. 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of the Company who have completed one year (at least 1,000 hours) of service and are age twenty-one or older. An employee's entry date will be the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following the date you satisfy the above requirements. It is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to make contributions to the Plan subject to IRS annual limit of their pretax compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes a safe harbor matching contribution equal to 100% of employee salary deferrals that do not exceed 3% of compensation defined by the Plan plus 50% of salary deferrals between 3% and 5%. The Company may make a discretionary profit-sharing contribution to the Plan. For 2024, the Company made no profit-sharing contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon and the employer safe harbor matching. Vesting in the Company's profit-sharing contribution portion of their accounts is on a graded vesting scale based on years of service as shown in the schedule below.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum of 50% of their vested balance or \$50,000. Loan terms range from one to five years, unless the loan is to acquire the participant's principal residence. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Interest received on participant notes for the year ended December 31, 2024 totaled \$2,885.

Payment of Benefits

On termination of service due to employment, death, disability, retirement, or other, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of time. The Plan also allows for in-service withdrawals, however, certain criteria outlined in the plan document needs to be met to qualify for this type of withdrawal.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$21 and \$20, respectively. These accounts may be used to pay administrative expenses, offset employer contributions paid or be allocated to plan participants. In 2024, administrative expenses and employer contributions were reduced by \$0 from forfeited nonvested accounts.

Investment Options

The Plan is entirely participant-directed and, as such, upon enrollment in the Plan, a participant may direct employee and employer contributions in any investment option offered in the Plan. Participants may change their investment options at any time. The Plan currently offers various pooled separate accounts and various investments through a brokerage account as investment options.

Secure Act and Secure Act 2.0

The Plan is currently working with their third party administrator to ensure compliance and any required plan changes are made to comply with the Secure Act and the Secure Act 2.0.

Note 2: Summary of Significant Accounting Policies

Date of Management's Review

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable from Participants

Notes Receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make a loan repayment and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Note 3: Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan is a prototype non-standardized plan. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions

taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 4: Information Prepared and Certified by the Custodian (Unaudited)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, AuguStarSM Financial Services, formerly Ohio National Life Insurance Company, the custodian of the Plan, has certified to the completeness and accuracy of the pooled separate account investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related pooled separate accounts investment activity and interest on notes receivables from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. The Plans investments held inside the brokerage accounts reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related brokerage account investment activity reported in the Statement of Changes in Net assets Available for Benefits for the year ended December 31, 2024 is not covered by the certification and thus was subject to full scope audit examination procedures.

Note 5: Related Party and Party-In-Interest Transactions

Certain Plan's investments are pooled separate accounts and managed by AuguStarSM Financial Services, formerly Ohio National Life Insurance Company, the custodian, and therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Fees paid by the Plan amounted to \$36,882 for the year ended December 31, 2024.

Note 6: Plan Termination

Although it has not expressed any intentions to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accrued benefits.

Note 7: Separated Participants

Amounts allocated to withdrawing participants are recorded on the Schedule H of Form 5500 for benefit claims that have been processed and approved for payment prior to December 31, 2024, but not yet paid as of that date.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Fair Value Measurement

The Plan measures, on a recurring basis, its investments at fair value in accordance with FASB codification "Fair Value Measurements and Disclosures," which provides the framework for measuring fair value. That framework provides fair value hierarchy used to classify the inputs used in measuring fair value. That hierarchy prioritizes the inputs used in determining valuations into three levels. The levels of fair value hierarchy are as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible to the Plan for identical assets. These generally provide the most reliable evidence and are used to measure fair value whenever available.

Level 2

Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

Level 3

Inputs to the valuation methodology are unobservable inputs and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

At December 31, 2024 and 2023, the Plan's investments consist of pooled separate accounts and brokerage accounts. Pooled separate accounts are unit investment trusts that hold the variable portfolios that correspond with the Plan's investment choices. The

fair value of the Plan's investment is based on the fair value of the underlying portfolio. The fair value of the underlying portfolio is based on the closing net asset value "NAV" of the corresponding fund shares held. Since the mutual funds are the subaccounts of the separate pooled accounts and they are traded based on the market quoted "NAV" and the accounts are traded/transact based on market quoted "NAV" they are deemed Level 2 investments. Brokerage accounts are based on the underlying investment. Certain investments are based on the closing net asset value "NAV" of the corresponding fund shares held these are deemed Level 2. Other investments within these accounts are based upon the market quoted "NAV" and the accounts are traded/transact based on market quoted "NAV" they are deemed Level 1 investments.

Gains and losses in net assets available for benefits, for years ending December 31, 2024 and 2023, are reported in net appreciation in value of investments.

The Plan's policy is to recognize transfer of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.


