### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements*

We have performed an audit of the accompanying financial statements of the John H. Firmage Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ## Notes to Financial Statements

December 31, 2024

### 1. DESCRIPTION OF PLAN

The plan includes participants from the following companies which comprise a controlled group: John H. Firmage, Inc., Firmco Financial, Inc. and Cullco Water Conditioning Companies, Inc. The following description of the John H. Firmage, Inc. 401(k) Plan (the “Plan”), sponsored by John H. Firmage, Inc., Firmco Financial, Inc., and Cullco Water Conditioning Companies, Inc., now known as Cullco, Inc., (the “Companies”), provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution 401(k) salary reduction plan covering all full-time employees who have completed two months of service and are eighteen years of age or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan. The Board of Trustees determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

#### Contributions

Each year, participants may contribute up to 75% of their compensation up to the limits allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan currently offers a variety of mutual funds as investment options for participants. The Companies may make discretionary matching contributions on an annual basis. The contribution, if made, is allocated to each participant in proportion to his or her compensation as a percentage of the compensation of all participants. Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Companies’ contribution, and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting and Forfeitures

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Companies’ contribution portion of their accounts is based on years of continuous service. A participant begins to vest at 20% per year beginning after the second year of service and is fully vested after six years of service.

If an employee terminates prior to being fully vested, the non-vested portion becomes a forfeiture which is used to offset employer contributions and any administrative expenses. At December 31, 2024, the balance of forfeited account monies not used by the Companies was \$83,566. During the year ended December 31, 2024, there was a total of \$48,451 in forfeitures.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The only partial withdrawals or installments permitted are for required minimum distributions under Code Section 401(a)(9).

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Date of Management's Review

Subsequent events were evaluated through October 4, 2025, which is the date the financial statements were available to be issued.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and trust Companies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

At December 31, 2024, there was \$0 payable to participants for contributions in excess of amounts allowed by the IRS.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Reclassifications

Certain items from December 31, 2023 have been reclassified to conform to the December 31, 2024 presentation.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"> <li>• quoted prices for similar assets or liabilities in active markets;</li> <li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li> <li>• inputs other than quoted prices that are observable for the asset or liability;</li> <li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means</li> </ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment Companies mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### 4. TAX STATUS

The Plan has adopted a volume submitter plan which obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the form of the volume submitter plan was acceptable under section 401 of the Internal Revenue Code. The volume submitter plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

If the Plan has uncertain tax positions, they are evaluated by management and a loss contingency is recognized when it is probable that a liability has been incurred and the amount of the loss can be reasonably estimated. The amount recognized is subject to estimate and management judgment and the amount ultimately sustained for an uncertain tax position could differ from the amount recognized. As of October 8, 2024, management did not identify any uncertain tax positions. The tax years previous to 2020 are closed to examination by the Internal Revenue Service.

#### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

#### 6. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Matrix Trust Company at December 31, 2024 and 2023.

#### 7. EMPLOYER CONTRIBUTIONS

Cash contributions of \$418,356 were made by the employer for the year ended December 31, 2024. The employer was current on contributions as of December 31, 2024 and minimum funding requirements have been met.

#### 8. ADMINISTRATIVE COSTS

The Plan and the Companies pay administrative costs such as third-party administrator fees, audit fees, and pension consultant fees. Certain administrative functions are performed by employees of the Companies. Such employees receive no compensation from the Plan. Administrative costs paid by the Plan for the year ended December 31, 2024 were \$1,852. Administrative costs paid by the Companies for the year ended December 31, 2024 were \$9,772.

**9. RELATED-PARTY TRANSACTIONS**

JULY provides third-party administrator services to the Plan. Fees paid by the Plan for JULY's administrative services amounted to \$1,852 for the year ended December 31, 2024. Fees incurred by the plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

**10. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
