## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Trustees of  
LDI 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of LDI 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the "Financial Statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter – Supplemental Schedule Required by ERISA**

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the LDI 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more detailed and complete description of the Plan’s provisions, which are available from the Plan Administrator.

***GENERAL***

The Plan was established on January 1, 2000, and is a defined contribution plan covering all eligible employees of Leslie Digital Imaging, LLC (the “Company”) and its affiliates who meet eligibility requirements and choose to participate. The Company serves as the Plan Sponsor and Plan Administrator of the Plan.

The Plan was amended and restated, effective November 15, 2023, changing third party administrators from Principal Life Insurance Company (“PLIC”) to Fidelity Workplace Services, LLC (“Fidelity”). With this amendment, Fidelity Management Trust Company became the institutional trustee of the Plan as Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”) remained the institutional trustee of the guaranteed investment contract through August 2024.

Resource Investment Advisors (“RIA”) are the investment advisors of the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

***CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT***

On March 27, 2020, Congress passed the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”) which included several relief provisions to tax qualified plans and their participants that were put into operation by the Plan at that time. Formal adoption of such provisions of the CARES Act provisions are required to occur on or before December 31, 2025.

***SETTING UP EVERY COMMUNITY FOR RETIREMENT ENHANCEMENT ACT 2.0***

The Setting Every Community Up for Retirement Enhancement Act 2.0 (the “SECURE Act 2.0”) was enacted on December 29, 2022. The SECURE Act 2.0 includes a retirement-related provisions which directly impact the 401(k) Plan. The provisions of the SECURE Act 2.0 may be effective and operationalized immediately (i.e., prior to amending the Plan document). The Plan has adopted certain measures included in the SECURE Act 2.0 as follows:

- Increased the RMD age from 72 to 73 for participants reaching age 72 after December 31, 2022
- Expanded eligibility for long-term, part-time employees who have completed at least 500 hours of service in three consecutive years (two years beginning in 2025)
- Elimination of the pre-death RMDs for designated Roth accounts within the Plan
- Application of top heavy rules to defined contribution plans covering excludable employees
- Updating the dollar limit for mandatory distributions from \$5,000 to \$7,000

The timing and manner for formal plan amendments, as determined by the SECURE Act 2.0, is for the Plan year ending December 31, 2025.

***ELIGIBILITY***

Effective with the amendment on April 1, 2023, employees are eligible to enter the plan the subsequent month after completion of six months of service with the Company and attainment of age 21. Prior to the amendment on April 1, 2023, employees were eligible to participate in the Plan on either January 1 or July 1 of each year following the completion of six months of service with the Company and attainment of age 21. Employees which are covered by a collective bargaining agreement, non-resident aliens, leased employees, and interns are excluded from the Plan.

***CONTRIBUTIONS***

Eligible employees may contribute up to 100% of their pre-tax and after-tax annual compensation as determined by the participant, as defined by the Plan, and subject to Internal Revenue Code (“IRC”) limitations. Participants 50 years of age or older can contribute an additional maximum catch-up contribution. Effective April 22, 2024, the Plan was amended to allow for discretionary employer matching contributions. For the year ended December 31, 2024, the discretionary employer matching contribution was \$142,915. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have a deferral rate set at 6% of eligible compensation. The Plan also has an auto-escalation feature whereby the deferral rate will increase each year by 1% up to a maximum of 10%.

***INVESTMENT OPTIONS***

Participants direct the investment of their contributions to the Plan into various investments offered by the Plan.

The Pension Protection Act created the Qualified Default Investment Alternative (the “QDIA”), which provides employers a safe harbor from fiduciary risk when selecting an investment for a participant or beneficiary who fails to elect his or her own investment. The Plan’s QDIA through November 15, 2023, was the Vanguard Target Retirement Fund. Effective November 15, 2023, the Plan’s QDIA was the Fidelity Freedom Fund.

***PARTICIPANT ACCOUNTS***

Individual accounts are maintained for each participant. Each participant’s account is credited with the participant’s contributions, the Company matching and discretionary contributions, if applicable, and plan earnings. Each participant’s account is charged with withdrawals and plan losses and an allocation of administrative expenses, as defined. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***VESTING***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching discretionary contribution portion of their accounts, plus actual earnings thereon, is as follows:

***NOTES RECEIVABLE FROM PARTICIPANTS***

Participant may borrow from their accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest and are secured by the balance in the participant's account. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Principal and interest is paid ratably through payroll deductions. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant's loan balance is reduced, and a deemed distribution is recorded. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***FORFEITURES***

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,067 and \$5,226, respectively. These accounts will be used to reduce future employer contributions and related plan expenses. Also, in December 31, 2024, employer contributions were reduced by \$3,885 from forfeited nonvested accounts.

***PAYMENT OF BENEFITS***

Benefits are recorded when paid. On termination of service due to death, disability, retirement or other, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants are entitled to receive in-service withdrawals upon attainment of age 59½ or as a hardship distribution, as defined in the Plan agreement.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***BASIS OF ACCOUNTING***

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***USE OF ESTIMATES***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates and could cause the changes in net assets available for benefits to vary significantly from period to period.

***INVESTMENT VALUATION AND INCOME RECOGNITION***

The Plan's investments are stated at fair value except for its fully benefit-responsive investment contract, which is valued at contract value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***ADMINISTRATIVE EXPENSES***

In accordance with the Plan, certain administrative expenses may be paid out of the Plan unless otherwise paid by the Company.

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, "Fair Value Measurement", provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Mutual funds are classified as Level 1 investments.

**Money Market Fund**

The money market fund held by the Plan is actively traded on a national securities exchange, and its fair value is determined based on the daily quoted market price. The Money market fund is classified as a Level 1 investment.

**NOTE 5 – GUARANTEED INVESTMENT CONTRACT WITH PRINCIPAL LIFE INSURANCE COMPANY**

In March 2007, the Plan entered into a benefit-responsive guaranteed investment contract with PLIC. PLIC maintains the contributions in a general account. The contract is reported at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by PLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Guaranteed Investment Contract totaled \$- and \$2,407,783 at December 31, 2024 and 2023, respectively.

The crediting rate is based on a formula established by the contract issuer but may not be less than one percent or greater than three percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; or
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; or
4. A material amendment to the agreements without the consent of the issuer.

The Plan's contract with PLIC was terminated on July 31, 2024. Upon termination, all assets were transferred to a money market fund managed by Fidelity Management Trust Company. As a result, the PLIC fund balance was \$0 as of December 31, 2024.

**NOTE 6 – INCOME TAX STATUS**

The Plan had adopted a pre-approved prototype plan sponsored by PLIC which was restated in 2022. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the pre-approved prototype plan adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust was exempt from taxation.

With the change in third-party administrators, effective November 15, 2023, the Plan adopted a pre-approved prototype plan sponsored by Fidelity. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the pre-approved prototype plan adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust was exempt from taxation.

The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 – PLAN TERMINATION**

Although the Sponsor has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in the company's contributions.

**NOTE 8 – RELATED PARTY TRANSACTIONS**

Certain investments are managed by Principal and Fidelity. Principal and Fidelity are Plan Trustees and record keepers and, therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan to Principal and Fidelity were \$65,834 for the year ended December 31, 2024. Fees to RIA are paid from net investment earnings of the Plan.

Plan issues loans to participants that are secured by participants' account balances. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules under ERISA.

Certain officers and employees of the Company (who may also be participants in the Plan) perform administrative services related to the operation, recordkeeping and financial reporting of the Plan. The Company pays these individuals' salaries and other administrative expenses on behalf of the Plan. These transactions are not deemed prohibited party-in-interest transactions because they are covered by statutory and administrative exemptions from the IRC and ERISA rules on prohibited transactions.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE 10 – CORRECTION OF MISSED EMPLOYEE DEFERRALS**

During the year ended December 31, 2024, the Plan Sponsor identified an operational error related to missed employee elective deferrals resulting from the Plan's auto escalation provision not being properly implemented. The error is being corrected in accordance with IRS guidelines. The Plan is currently in the process of completing the correction procedures. Management has evaluated the estimated qualified nonelective contribution ("QNEC") and determined that the correction does not materially affect the financial statements.

**NOTE 11 – SUBSEQUENT EVENTS**

The Plan evaluated subsequent events through October 13, 2025, the date these financial statements were available to be issued.
