Independent Auditor's Report

To the Plan Administrator and Plan Participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Path Robotics, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

1. Description of the Plan

General

The following description of the Path Robotics, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

The Plan, originally established on January, 1, 2021, is a defined contribution plan available to all employees of Path Robotics, Inc. (the “Company”) who are age 21 or older. Eligible employees may begin participating in the Plan on the first day of the month coinciding with or next following the date of their employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Each year, participants may elect to contribute up to 100% of annual compensation, as defined in the Plan document. Both pre-tax and Roth deferrals are permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or tax-qualified plans (rollovers).

Company matching contributions are discretionary. For the years ended December 31, 2024 and 2023, the Company elected not to make a discretionary matching contribution.

The Company may also elect a discretionary profit sharing contribution to the Plan. The Company elected no discretionary profit sharing contribution for the years ended December 31, 2024 and 2023. Contributions are subject to certain Internal Revenue Code (the “Code”) limitations.

Participant Accounts

Each participants account is credited with the participants contributions and an allocation of the Company’s contribution, Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct their entire interest in the Plan into various investment options offered by the Plan. Participants may change their investment options on a daily basis.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service and is subject to the following vesting schedule:

To earn a year of service a participant must be credited with at least 1,000 hours of service during a Plan year.

Payment of Benefits

Upon termination of service due to separation of service, disability or retirement, a participant may elect to receive a lump-sum distribution equal to the value of the participants vested interest in his or her account. For termination of service due to death of a participant, the beneficiary will receive a lump-sum distribution that will be equal to the participants account. The participants account will become fully vested upon the death of the participant.

Participant Loans

Participants may borrow from their individual accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid within five years unless the loan is granted to allow the participant to purchase his or her principal residence. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions.

Withdrawals

Participants may withdraw up to 100% of their elective accounts in the event of undue financial hardship as provided for in the Plan document.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time. The Company has the right at any time, by action of its Board of Directors, to terminate the Plan subject to provisions of ERISA. Upon Plan termination or partial termination, participants will become fully vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Net Appreciation/Depreciation in Fair Value of Investments

Net realized and unrealized appreciation/depreciation are recorded in the accompanying statements of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

Contributions

Contributions from Plan participants and Company discretionary contributions are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 below for discussion of fair value measurements and Note 5 for valuation of the Plan's fixed annuity contract.

Purchases and sales of securities are recorded on a trade-date basis using fair value. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Brokerage fees, transfer taxes, and other expenses incurred in connection with the investment of the Plan's assets will be added to the cost of such investments or deducted from the proceeds thereof, as the case may be. Fees related to the administration of notes receivable from participants are allocated directly to the participant responsible for the expense. The Plan participates in an expense offset agreement whereby certain administrative expenses are paid with credits received by the Plan from certain investment managers. During the years ended December 31, 2024 and 2023 the Plan received investment manager credits of \$18,652 and \$13,326, respectively, which were offset against certain administrative expenses.

Benefit Payments

Benefits are recorded when paid.

3. Unaudited Information Certified by the Plan Trustee

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants as of December 31, 2024 and 2023, and net appreciation (depreciation), interest and dividend income, and interest on notes receivable from participants for the years ended December 31, 2024 and 2023, was prepared by or derived from information certified by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (the “Trustee”) and furnished to the plan administrator. The plan administrator has obtained certifications from the Trustee that such information is complete and accurate within the meaning of CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosures under ERISA.

4. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each general type of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds fair values are determined utilizing quoted market prices reported on the active market on which they are traded.

The collective investment trust is valued utilizing the respective net asset values as reported by such trust, which is reported at fair value. The net asset value is used as a practical expedient to

estimate fair value. The fair value has been determined by the trustee sponsoring the collective investment trust by dividing the trust's net assets at fair value by its units outstanding at the valuation dates. There are no restrictions as to the redemption of this investment, nor does the Plan have any contractual obligations to further invest in the collective investment trust.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investments at Contract Value

Investment in the Empower Annuity Insurance Company of America ("EAICA") fixed-annuity contract (the "Empower Contract") is fully benefit-responsive and is recorded at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The crediting rate is based on a formula established by the Empower Contract, but may not be less than 0.00% and is reviewed quarterly for resetting.

For the years ended December 31, 2024 and 2023, the Plan earned both an average and actual yield of 1.41% and 1.23%, respectively, in relation to the Empower Contract.

The Plan's ability to receive amounts due in accordance with this fully benefit-responsive investment contract is dependent on EAICA's ability to meet its financial obligations. EAICA's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with EAICA, the contract issuer. Examples of such events include 1) premature termination of the contract, 2) changes to the Plan's prohibition on competing investment options, and 3) bankruptcy of EAICA, the contract issuer.

The fully benefit-responsive investment contract is subject to early termination penalties that may be significant. There are no reserves against contract value for credit risk of EAICA or other matters.

6. Tax Status

The Plan sponsor adopted a non-standardized pre-approved plan document. The Internal Revenue Service ("IRS") has determined and informed the pre-approved plan sponsor, by an opinion letter dated on June 30, 2020, that the pre-approved plan is designed in accordance with applicable sections of the Code. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Parties-in-interest Transactions

The Company, which is a party-in-interest, provides certain administrative services to the Plan at no charge. Certain Plan investments are managed by the Trustee and its affiliates for which they receive fees. The Plan is also serviced by an outside investment advisor, which charges the Plan fees. These transactions qualify as exempt party-in-interest transactions.

8. Prohibited Transaction

During 2024 and 2023, the Company erroneously remitted the employees' deferral for several payroll periods to the Plan later than the period prescribed by the Department of Labor regulations.
