**To the Plan Administrator and Participants
Smiley Brothers, Inc. 401(k) Profit Sharing Plan**

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Smiley Brothers, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information), by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from an agent on behalf of a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America; and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. 1. Plan Description

The following description of the Smiley Brothers, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is administered by Smiley Brothers, Inc. (the "Employer"). Vanguard Fiduciary Trust Company is the Trustee of the Plan. Ascensus Trust Company is the recordkeeper of the Plan.

Eligibility

The Plan is a defined contribution profit sharing plan. Through December 31, 2023, employees of the Employer who had a minimum of one year and 1,000 hours of service and were age twenty-one or older were eligible to participate in the Plan. Effective January 1, 2024, employees of the Employer who have a minimum of one month and are age twenty-one or older are eligible to participate in the Plan. Additionally, effective January 1, 2024, international and leased employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year participants may contribute up to the amount allowed by the Internal Revenue Code of pretax compensation, as defined in the Plan agreement. For the year ended December 31, 2023, the Employer contributed to the Plan the lesser of 50% of the participant contributions or 50% of the first 6% of participant compensation, with a maximum employer match of 3%. Effective January 1, 2024, the Employer contributes 100% of participant contributions up to 3% of participant compensation and 50% of the next 2% of participant compensation, with a maximum employer match of 4%. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Employer's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately and fully vested in their pre-tax contributions plus actual earnings thereon. Prior to January 1, 2024, vesting in the Employer discretionary matching contributions was based on years of continuous service. A participant vested at a rate of 20% per year starting after year 2 and was 100% vested after six years of credited service. Employer discretionary matching contributions made subsequent to January 1, 2024, are 100% vested immediately.

1. Plan Description (*continued*)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years with the exception of loans for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime plus one percent per annum. Principal and interest are paid ratably through payroll deductions.

Interest rates on such loans ranged from 4.25% to 9.50% at December 31, 2024 and 2023.

Payment of Benefits

A participant's account will be distributed in a lump-sum payment upon termination, disability, retirement or death if the participant's account balance is less than \$1,000. If the participant's account balance is between \$1,000 to \$5,000, the balance will be rolled over into a Vanguard individual retirement account. However, any non-vested portion of the account balance is forfeited, except in the case of disability, retirement or death. In the event of such separation prior to age 59-1/2, the participant may elect to defer the distribution until the participant reaches age 59-1/2 or to an earlier date, provided that the participant's eligible distribution exceeds \$5,000. An inactive participant's account must be distributed no later than April 1, of the year following the participant's reaching 70-1/2 years of age. Active participants over the age of 70-1/2 can defer required minimum distributions until termination, retirement, disability or death. The Plan also provides for distributions under defined hardship distribution rules.

Forfeitures

Forfeitures are allocated to either reduce expenses incurred in the operations of the Plan or reduce future Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,012 and \$15,025, respectively. During 2024, \$16,238 was used to reduce Plan expenses and no employer contributions were reduced by forfeited non-vested accounts.

2. Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable inputs and are used to the extent that observable inputs do not exist.

At December 31, 2024 and 2023, all of the Plan's investments in mutual funds are valued based on Level 1 inputs.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Mutual funds held by the Plan are valued at fair value based on the daily closing price reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value ("NAV") and to transact at that price. The common/collective trusts are valued at the NAV, which is used as a practical expedient based on the fund's underlying investments. Investments in common/collective trusts are recorded at the value reported to the Plan by MetLife, Inc., ("Fund") which represents fair value of the underlying investments.

The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Pursuant to U.S. GAAP guidance common/collective trusts where fair value is measured using NAV per share as a practical expedient are not categorized within the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on an accrual basis and dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

All investment contracts held by the Fund are entered into directly between the Fund and the issuer of the contract and are nontransferable. Fund units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the Fund. The Fund has no unfunded commitments at December 31, 2024 and 2023.

Notes Receivable from Participants

Notes receivable from participants are valued at their outstanding principal amounts plus accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is made.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in a variety of investment options. There is no limit to how often a participant may change their investment options.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC as an agent of Ascensus Trust Company, a qualified institution.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

6. Tax Status

The Internal Revenue Service issued an opinion letter dated June 30, 2020 to the prototype plan document preparer which states that the form of the prototype plan qualifies under the applicable provisions of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC.

6. Tax Status (*continued*)

The Plan recognizes the effect of income tax positions only if those positions are more likely than not of being sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition or disclosure. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to December 31, 2021.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.

8. Party-in-Interest Transactions

Certain investments of the Plan are managed by the Trustee. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Certain employees of the Employer, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements on net assets available for benefits.

9. Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 10, 2025.
