**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Title 9 Sports, Inc. 401(k) Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**A. General**

The Plan was established on January 1, 1997 by Title 9 Sports, Inc. (the "Company") to provide retirement benefits to eligible employees. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**B. Administration**

Empower Trust Company, LLC and Empower Annuity Insurance Company of America ("Empower") are the trustees and custodian of the Plan. An Empower affiliate, Empower Retirement, is third-party administrator of the Plan and is responsible for maintaining participant records.

**C. Eligibility**

Substantially all employees are eligible to make elective deferrals upon employment commencement. Substantially all employees of the Company who have attained age 21 and completion of one year of service are eligible to receive an allocation of Company contributions. The Plan specifically excludes leased employees and collectively bargained employees.

**D. Participant Contributions**

Participants may elect to have the Company contribute up to 86% of their eligible pre-tax compensation to the Plan subject to applicable Code limits. Participants of age 50 or older may make additional catch-up contributions subject to Code limits.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with participant directions.

**E. Company Contributions**

The Company matches 100% of the first four percent of compensation deferred by participants. The Plan also permits the Company to make discretionary nonelective contributions. No nonelective contributions were made for the 2024 Plan year.

**F. Vesting**

Participant accounts are immediately 100% vested in their entire account balance.

**G. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, Company contributions and Plan earnings or losses and expenses. Plan assets are invested based solely on instructions received from participants.

The contributions of participants who decline to make an investment election are invested in the American Funds Retirement Fund that is appropriate for the individual's age and projected date of retirement.

**H. Payment of Benefits**

Participants are eligible for benefits upon attainment of age 59½, retirement, disability or termination of service. Normal retirement age under the Plan is age 65. A participant's benefit under the Plan is equal to his or her account balance. Benefits are payable in a lump sum or installments. Hardship distributions (\$500 minimum) are permitted under limited circumstances subject to the approval of the plan administrator. The accounts of terminated participants valued at \$5,000 or less who do not make an affirmative election concerning distribution of their accounts may be distributed by the plan administrator in accordance with applicable provisions of the Code.

**I. Expenses**

Investment fund operating expenses, brokerage, administrative and trust fees are charged directly to the investment funds and are thereby factored into each investment fund as a reduction of investment return. Participant loan administration and benefit payment processing costs are charged directly to participants. Other costs incurred for administering the Plan may be paid by the Plan or the Company at management's discretion.

**J. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. Such loans bear interest at available market financing rates. Principal and interest are paid ratably through payroll deductions. The plan administrator establishes the specific terms and conditions of participant loans. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 8.50% to 9.50% with various maturities through August 2029 and are reported at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments are stated at fair value except for fully benefit responsive investment contracts which are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under a contract plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**D. Risks and Uncertainties**

Plan investments include a variety of securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in value of investment securities will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

**NOTE 4 - TAX STATUS**

The Company adopted a prototype plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan meets requirements for tax-exempt status. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain investments maintained under the Plan are issued by the trustees. Purchases and sales of these funds and payment of administrative fees from Plan assets are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower, the trustees of the plan.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

Plan investments consist of mutual funds that are valued at the daily closing price reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded. The following table sets forth Plan investments measured at fair value based on the inputs used to value them at December 31:

**NOTE 8 - KEY GUARANTEED PORTFOLIO FUND**

The Key Guaranteed Portfolio Fund is maintained in an insurance company general account. Empower Annuity Insurance Company of America is contractually obligated to repay principal and a specified interest rate to the Plan. The methodology for calculating the interest crediting rate is based on the earnings of the underlying portfolio securities compared to the minimum interest crediting rate as stated in the contract and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the plan can be derived by averaging the quarterly gross interest rates for the fund over the year. The averages for 2024 and 2023 are 1.41% and 1.23%, respectively.

The fund meets fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan. There are no reserves against contract value for credit risk of the contract issuer.

A provision in the contract prohibits the immediate pay out of investments in the fund at contract value for certain Plan level events. The plan administrator does not believe that any events limiting the Plan’s ability to transact at contract value are probable of occurring.
