The undersigned (We) are providing this letter in connection with Forvis Mazars' audits of the financial statements of Ziehm-Orthoscan, Inc. 401(k) P/S Plan (Plan), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

7. The Plan is qualified under the appropriate section of the Internal Revenue Code, and we intend to continue them as a qualified plan and trust. We do not have any intention at present to terminate the Plan.
