Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bermo, Inc. Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bermo, Inc. Profit Sharing Plan and Trust financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Bermo, Inc. Profit Sharing Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of Bermo, Inc. Profit Sharing Plan and Trust (the Plan) is intended to provide only general information. Participants should refer to the Summary Plan Description or the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Bermo, Inc. (the Company, Plan Sponsor and Administrator). The Plan's Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Trustees. The participants are responsible for the direction of their account into the various investment options offered by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all requirements of Sections 401(a) and 401(k) of the Internal Revenue Code.

Plan Administration

The Company is the Plan Sponsor and Administrator. The Company has appointed Principal Trust Company (Principal) as trustee and asset custodian of the Plan. The custodian pays the distributions and retirement benefits at the direction of the Plan Administrator and provides custodial and investment management services with respect to the net assets of the Plan. The custodian also advises the Plan Administrator of compliance with ERISA and other matters related to the operation of the Plan.

The Company has appointed Tax Sheltered Compensation (TSC) to assist with certain plan administration responsibilities with respect to the Plan.

Eligibility

Employees of the Company are eligible to contribute to the Plan pursuant to an earnings reduction agreement with the Company upon the completion of three months of service and reaching the age of 18. Employees enter the Plan on the first day of the month after meeting eligibility requirements.

Employee Contributions

Participants may elect to contribute up to 100% or a specified dollar amount of their compensation to the Plan via wage deferrals subject to a calendar year dollar limit determined annually by the Internal Revenue Service (IRS). Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may make two types of contributions to the Plan, a pre-tax 401(k) deferral or a Roth 401(k) deferral.

Automatic Enrollment

Each employee meeting eligibility requirements will be automatically enrolled into the Plan with a deferral percentage of 4% of compensation and the deferrals to be invested in the Plan's default investment alternative, unless the employee makes a contrary election.

Rollover Contributions

The Plan allows participants to make rollover contributions from other qualifying plans.

Employer Matching Contributions

For participants that are not union employees, the Plan provides for a discretionary employer matching contribution. No discretionary employer matching contributions were made for nonunion employees for the Plan years ended December 31, 2024 and 2023.

For participants that are union employees, the employer matching contribution amount is specified in the applicable collective bargaining agreement. For the Plan years ended December 31, 2024 and 2023, the Plan matched 50% of the first 6% of compensation contributed by union employees.

Total employer matching contributions to union employees were \$88,316 and \$94,303 for the Plan years ended December 31, 2024 and 2023, respectively.

Employer Profit Sharing Contributions

Employer profit sharing contributions are discretionary and are determined by the Company's Board of Trustees. A participant is eligible to receive an allocated share of the contributions if requirements of eligibility are met and the participant has not been terminated for any reason other than death or disability at the end of the Plan year. Contributions to the Plan are funded within the time prescribed by law. There were no profit sharing contributions for the years ended December 31, 2024 or 2023.

Vesting

Participants are immediately 100% vested in their wage deferrals and earnings on these deferrals. The following schedule determines vesting in the employer matching and employer profit sharing contributions for nonunion employees:

Union employee participants are 100% vested at all times in their wage deferrals, employer contributions and earnings thereon.

Participant Accounts

Each participant's account is credited with the participant's wage deferral, rollover deposits, allocations of the employer's contributions, if any, and investment gains or losses. Participants' accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant's account balances, or participant transactions, as defined.

The allocation of the employer's matching contributions, if any, is based on each participant's compensation and elective contributions. The profit sharing contributions are allocated to the individual accounts of qualifying participants in the ratio that each qualifying participant's compensation bears to the total compensation of all qualifying participants for the Plan year. Allocation of plan earnings and losses is based on the share of each individual fund in a participant's account to the total of each fund in all participants' accounts.

Participant Accounts – Continued

Participants direct the investment of their wage deferrals and all employer contributions into various investment options offered by the Plan. The Plan currently offers its participants 21 diversified funds as investment options.

Notes Receivable from Participants

Participant loans are permitted in accordance with the Plan's written loan policy. Participants may borrow from their accounts up to the lesser of \$50,000 or 50% of participant's account balance. Loans bear interest at a fixed rate of 1% above the prime interest rate on the first day of the month in which the loan is requested by the participant. Participants are entitled to only two loans outstanding at any given time. Payments are made through payroll deductions over the loan term, not to exceed five years. Primary residence loans are an exception where terms are not to exceed 15 years.

Payment of Benefits

A participant whose termination of employment occurs for any reason is entitled to benefits equal to 100% of the participant's contribution, vested employer contributions, and rollover contribution accounts. Distribution of a participant's benefits is made to the participant or his or her beneficiaries in a lump sum or in installments based on the discretion of the Plan Administrator and the election made by the participant, within certain guidelines as defined in the Plan. The Plan allows in-service withdrawals after age 59½ for any reason and financial hardship withdrawals, as defined, before age 59½. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan Administrator will authorize the benefit payment without the participant's consent.

Forfeited Accounts

Forfeitures of nonvested amounts for terminated participants can be used to reduce plan administrative expenses or to reduce future employer contributions.

Forfeited non-vested account balances were \$0 and \$3 at December 31, 2024 and 2023, respectively. The Plan used forfeitures of \$0 and \$2,174 to pay administrative expenses during the Plan years ended December 31, 2024 and 2023, respectively. The Plan used \$0 and \$4,084 to fund employer contributions during the plan years ended December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements were prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

The financial statements and related notes are intended to conform with The Department of Labor's rules of Section 103(a)(3)(C) and regulations for reporting and disclosures under The Employee Retirement Income Security Act of 1974. All information required to comply with these laws has been included herein and is in conformity with those laws.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and trustee. See Note 5 for a description of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. The realized gain or loss on sales of investments is determined based upon the average cost of investments sold and is included in net appreciation in fair value of investments on the Statements of Changes in Net Assets Available for Benefits. Dividend income is recorded on the ex-dividend date. Interest is recorded as earned.

Notes Receivable from Participants

Notes receivable from participants are measured at amortized cost which includes their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. The Plan estimates expected credit losses on notes receivable from participants based on historical experience, current conditions, and reasonable and supportable forecasts. The Plan utilizes an aging analysis to determine the allowance for credit losses, considering the length of time the receivables have been outstanding and the likelihood of collection. The Plan's credit quality indicators include the participant's employment status and repayment history. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. The estimate of expected credit losses reflects the Plan's assessment of future economic conditions and their potential impact on participants' ability to repay their loans. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions

The Plan is required to return contributions received in excess of the amounts allowed by the IRS. At December 31, 2024 and 2023, amounts refundable by the Plan to participants for contributions made in excess of amounts allowed totaled \$17,819 and \$767, respectively. These amounts have been reflected as excess contributions payable and included as a reduction to participant deferrals in the accompanying financial statements for the year in which the contributions were made.

Administrative Expenses

Personnel within the Company's organization perform various administrative services for the Plan. The payroll and related overhead costs associated with these services are not included as plan expenses. The Plan incurred administrative expenses during the Plan years ended December 31, 2024 and 2023 consisting of fees for contract administration and other services of \$46,875 and \$43,884, respectively, paid to Principal Trust Company.

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in Net Appreciation in Fair Value of Investments.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events, for transactions and events that would require recognition in the financial statements or disclosures, through July 8, 2025, which is the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE PLAN CUSTODIAN (UNAUDITED)

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan has received certifications from the custodian that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investment balances
- Interest and dividend income from investments
- Net appreciation in fair value of investments
- Supplemental Schedule of Assets (Held at End of Year) – December 31, 2024
- Notes Receivable from participant balances and interest income

The Plan's Independent Auditors have not audited this information contained in the financial statements and supplemental schedule as it has been certified by the custodian for the applicable periods.

NOTE 4 ABILITY TO TERMINATE THE PLAN

Although it has no intention to do so, the Company has the right to discontinue its contributions or terminate the Plan at any time subject to the provisions of ERISA. In the event the Plan is completely terminated, all amounts credited to the affected participants' accounts shall become 100% vested and shall not be subject to forfeiture. All unallocated amounts shall be allocated to the accounts of all participants in accordance with the provisions of the Plan. Upon such termination, the Sponsor will direct the trustee and Plan Administrator either to completely distribute all assets in the trust fund to the participants or continue the trust and distribute benefits in such a manner as though the Plan had not been terminated.

NOTE 5 FAIR VALUE MEASUREMENTS

The Fair Value Measurements topics of the FASB Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 3	Inputs are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at net asset value (NAV) based on units of the pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan Administrator determines the fair value measurement policies and procedures. Those policies and procedures are reassessed at least annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted as necessary, based on current market conditions and other third-party information.

NOTE 6 GROUP ANNUITY CONTRACT

The Plan has entered into traditional fully benefit-responsive investment contracts with Principal that invest contributions in the Principal Fixed Income Guaranteed Option, which is general account product. Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the Statements of Net Assets Available for Benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer and is reviewed by Principal on a semiannual basis for resetting. The contract value for the Principal contract was \$2,232,299 and \$2,404,152 as of December 31, 2024 and 2023, respectively. The crediting rate for the Principal contract was 1.55% at December 31, 2024 and 2023, respectively.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 7 FEDERAL INCOME TAX STATUS

Ballard Spahr, LLC, the provider of the prototype Plan Document adopted by the Plan has received an opinion letter in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan is relying on an opinion letter that the prototype plan received from the Internal Revenue Service, that the Plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan Administrator believes the Plan meets the requirements of Section 401(a) of the IRC and is exempt from federal income tax under Section 401(a) of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Plan Trustee and Custodian

The investments are managed by the Plan's trustee and custodian, Principal Trust Company. The custodian maintains individual participant account records and provides investment advisory services. Certain participant investments are in Principal Trust Company investment vehicles and these transactions are considered as party-in-interest transactions. The trustee is not precluded under contract provisions or by ERISA, from executing investment transactions involving assets under the trustee's control.

Fees incurred by the Plan for investment services are included in net appreciation in fair value of investments, as they are paid through revenue sharing and are charged directly to each participant's account, rather than a direct payment.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. These funds hold various securities including U.S. Government securities, corporate debt securities, and equities. Investments in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments could occur in the near term and that such changes could materially affect the fair value of investments.
