Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- 1. Description of Plan** The following brief description of the Root 2 LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. Effective January 1, 2020, the Plan changed its name from the CHG 401(k) Plan to the Root 2 LLC 401(k) Plan.
- (a) *General*
- The Plan is a defined contribution retirement plan established on January 1, 2017, subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”), and to the provisions of the Internal Revenue Code of 1986, as amended (the “Code”), as it pertains to plans intended to qualify under Section 401(a) of the Code. Root 2 LLC (previously Craveable Hospitality Group, LLC) (the “Company” or “Employer”) is the sponsor of the Plan. Reliance Trust Company is the trustee of the Plan. ADP, LLC serves as the record keeper.
- (b) *Eligibility and Plan Entry Dates*
- Effective April 1, 2019, employees must have attained the age of 18 and have completed 3 months of service to be eligible to enter the plan. Employees enter the Plan on the first of the month following the completion of the eligibility requirements. Prior to April 1, 2019, employees were eligible to enter into the Plan on the first of the month following the date of hire.
- (c) *Contributions*
- Participants in the Plan may elect to contribute between 1% up to 90% of compensation, subject to the maximum allowed by the Code. Roth Contributions are also permitted. The Plan is not set up for automatic enrollment and does not require employees to opt out of the plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to suspend their contributions and to change their elective deferral at any date.

Discretionary matching contributions by the Company (“Employer Contributions”) to the Plan are discretionary and are authorized for each Plan year by the Company for the benefit of eligible employees. To be eligible for the Company contributions, employees must be credited with at least 1,000 hours of service during the Plan year, with certain other exceptions, as defined in the Plan. Qualified non-elective contributions may be made at the option of the Company. The Company elected to not make a discretionary matching contribution or non-elective contribution to the Plan for the 2024 and 2023 Plan years.

(d) *Participant Accounts*

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant’s account is credited with the pre-tax contributions made by the participant and employer discretionary matching contributions allocated to the participant, if any. Participants’ accounts are also credited with discretionary non-elective contributions as authorized each year. In addition, the Plan accepts rollover contributions from other employers’ qualified plans or from eligible Individual Retirement Accounts.

Each participant’s account is credited with its share of investment income (losses), which is interest, dividends, and appreciation or depreciation in the fair value of the underlying assets, net of administrative expenses, for the funds in which that account is invested. The benefit to which a participant is entitled is the participant’s vested account balance.

(e) *Forfeitures*

Forfeitures of terminated participants’ non-vested account balances may be used to pay Plan expenses, reduce employer contributions or can be allocated to participants. As of December 31, 2024 and 2023, unallocated forfeitures totaled \$7,906 and \$130, respectively. For the years ended December 31, 2024 and 2023, \$0 and \$4,800, respectively, of forfeitures were used to pay administrative expenses.

(f) Vesting

Employee and qualified non-elective contributions, plus actual earnings thereon, vest immediately.

Participants vest in any discretionary employer match according to the following schedule, or upon normal retirement age. A participant's vesting percentage increases to 100% in the Company's discretionary matching if, while employed with the Company, the employee dies or becomes disabled.

0% for less than 2 years,
33% for 2 years but less than 3 years,
66% for 3 years but less than 4 years,
100% for 4 years or more.

(g) Payment of Benefits

Upon termination of employment, retirement (age 65), disability, death or hardship, participants (their beneficiary or their estates) may elect to receive the vested portion of their account in the form of a direct rollover, a lump-sum payment or annual installment payments over a specified period of time.

(h) Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Fees related to notes receivable are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded. In general, participants who are active employees may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the vested balance in the participant's account and bear interest at the prime rate in effect on the day that the loan was initiated plus 2%.

The interest rates for outstanding loans at December 31, 2024 was between 5.25% and 10.50%. Principal and interest are generally repaid through payroll deductions. General-purpose loans must be repaid within five years and loans granted for principal residences must be repaid within thirty years.

(i) *Administrative Expenses*

The Plan pays certain administrative expenses associated with professional services provided to the Plan. Other expenses are paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4 – Fair Value Measurement).

Purchases and sales of investments are recorded on a trade date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

The Plan invests in the Invesco Stable Value Fund, a collective investment trust managed by Invesco Trust Company, which seeks to preserve principal and provide interest income consistent with maintaining required liquidity under prevailing market conditions. The Fund's returns are based on returns generated by an actively-managed, highly diversified portfolio of investment grade, fixed and floating rate securities. The Fund may invest in such securities directly or indirectly through commingled investment vehicle.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based upon the terms of the Plan.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- a) Quoted prices for similar assets and liabilities in active markets;
- b) Quoted prices for identical or similar assets and liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or by other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The valuation methodologies used may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements as of the reporting date.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: The fair values of the mutual funds are determined by obtaining quoted prices on nationally recognized securities exchanges in an active market and are classified within Level 1 of the valuation hierarchy.

Common collective trust fund: The common collective trust fund is valued at the NAV of units held by the Plan at year-end. The NAV is based on the fair value of its underlying investments held by the fund less its liabilities.

This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Unit values are determined by dividing the fund's net assets at fair value by the units outstanding at the valuation dates.

During the year ended December 31, 2024, there were no transfers between levels of the fair value hierarchy.

- 6. Tax Status** The Plan has adopted a prototype 401(k) plan document designed by the Plan's TPA, which received a favorable opinion dated October 6, 2020. The opinion indicates that the prototype plan has been reviewed by the Internal Revenue Service (IRS) and was found to be a qualified plan under Section 401(k) of the Code and thus exempt from federal income taxes under the provisions of Section 401(a) of the Code. The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes that the Plan is qualified and tax exempt as of the date of the financial statements.
- Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
- 7. Party-In-Interest Transactions** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Additionally, certain Plan expenses are paid directly by the Company.
- Additionally, participants who are active employees may borrow from their accounts (see Note 1(h)) and such loans qualify as party-in-interest transactions.
- 8. Plan Termination** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan or the complete discontinuance of contributions by the Company under the Plan, the participants' accounts will become fully vested and non-forfeitable in accordance with the terms of the Plan.

- 9. Excess Contributions Payable** Annual contributions for each participant are subject to the participation and discrimination standards of Internal Revenue Code Section 401(k). The statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 include reductions for corrective distributions of excess contributions and related earnings of \$42,731 and \$23,097, respectively, that were refunded to the participants for the 2024 and 2023 plan years, in order to meet the necessary compliance requirements under ERISA and IRS rules. Amounts payable to participants for corrective distributions are recorded as a liability. The Plan distributed the 2024 and 2023 excess contributions of \$42,731 and \$23,097, respectively, to the applicable participants in the subsequent year.
- 10. Risks and Uncertainties** The Plan provides for various investment options. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
- 11. Subsequent Events** The Company has evaluated subsequent events from January 1, 2025 through September 17, 2025, the date the financial statements were available to be issued, and has determined that there are no events to disclose.
