Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the VIP Family of Companies Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the **Auditor’s Responsibilities for the Audits of the Financial Statements** section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“U.S. GAAS”). Our responsibilities under those standards are further described in the **Auditor’s Responsibilities for the Audits of the Financial Statements** section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during our audits.

Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1 - Description of Plan

The following description of the VIP Family of Companies Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution profit-sharing plan under Section 401(a) of the Internal Revenue Code and has a Section 401(k) salary deferral arrangement. The Plan covers all employees of the VIP Family of Companies (the “Company”) after meeting certain eligibility requirements (see below). All assets acquired under the Plan are the result of employee and employer contributions thereto, and all income and other additions thereto are administered, distributed, forfeited, or otherwise governed by the provisions of the Plan and the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Name - For the year ended December 31, 2024, the Plan underwent a name change and is now the VIP Family of Companies Retirement Plan, previously known as VIP Structures, Inc. Retirement Savings Plan.

Eligibility - Employees aged eighteen and older are eligible to participate in the Plan after three months of service. Participants are automatically enrolled to begin making elective contributions of 6% of their annual compensation to the Plan on the first day of the calendar quarter coinciding with or following the date eligibility requirements are met, unless the participant elects a different percentage or expressly elects not to participate in the Plan. The deferral percentage is increased automatically by 1% on January 1st of each year, up to a maximum of 10%.

Contributions - Participants are allowed to make elective 401(k) salary deferrals and Roth elective deferrals up to the maximum amount allowed by the Internal Revenue Code. Participants are also allowed to make rollover contributions to the Plan.

Each year, the Company may contribute a discretionary matching contribution for each participant. Discretionary matching contributions were \$297,206 and \$254,021 for the years ended December 31, 2024 and 2023, respectively, of which the Company paid \$282,004 and \$203,664 for the years ended December 31, 2023 and 2024, respectively, and used available forfeitures for the remainder, as discussed below. The Company may also elect to make discretionary profit-sharing contributions. The amount and timing of such payments is at the discretion of the Board of Directors of the Company. There were no discretionary profit-sharing contributions for the years ended December 31, 2024 and 2023.

Participant accounts - Each participant’s account is credited with the participant’s elective salary deferral contribution, the Company’s discretionary matching and/or profit-sharing contributions and Plan earnings and expenses. Allocations are based on participant compensation or account balances, as defined by the Plan agreement. The benefit to which a

participant is entitled is the benefit that can be provided from the participant's vested account. Participants can access their account information via the trustee's website where they have the ability to change their elective deferrals and investment options, as well as apply for participant notes receivable and request distributions.

Vesting - Participants are immediately vested in their elective salary deferral contributions plus actual earnings thereon. Vesting in the remainder of their account balance is based on years of continuous service; a year of service is a plan year that a participant has at least 1,000 hours of service. A participant is 100% vested after six years of credited service.

Forfeitures - Forfeitures of terminated participants' non-vested account balances may be used to offset administrative costs of the Plan or reduce employer contributions. The Plan used \$15,202 and \$50,357 of forfeited non-vested accounts to reduce employer contributions for the years ended December 31, 2024 and 2023, respectively. Unused forfeitures were \$20,392 and \$1,906 as of December 31, 2024 and 2023, respectively.

Investment options - Participants may direct contributions to the Plan in any of the investment options offered by the Plan. Participants may change their investments daily through online media with the Plan's investment trustee, as discussed above.

Payment of benefits - Upon reaching age sixty-five or on termination of service due to retirement, disability, or death, the participant and/or beneficiary will be entitled to 100% of their account balance, which will be paid out as soon as practicable following termination of service. On termination of employment for reasons other than those listed above, the participant will be entitled to receive a lump-sum amount equal to the vested value of their account balance.

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes will bear a reasonable fixed rate of interest, to be determined by the plan administrator, similar to that which a bank or other professional lender would charge for making a similar loan. Interest rates range from 3.25% to 8.50% as of December 31, 2024. The notes will be repaid through weekly payroll deductions. Two notes per participant can be outstanding at a time. The notes are secured by the vested balance in the participant's account. According to requirements of the participant note program, the Plan Administrator will treat a note in default if any scheduled payment remains unpaid beyond ninety days.

Deemed distributions - Deemed distributions represent the amount of unpaid principal on notes receivable from participants for participants who are actively participating in the Plan and have not continued to make payments on their outstanding notes as required under the participant note program. There were no deemed distributions for the years ended December 31, 2024 and 2023.

Plan termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 2 - Summary of significant accounting policies

Method of accounting - The Plan maintains its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of Plan income and expense during the reporting period. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market risk. Market risks include domestic and global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Economic dependency and concentration of credit risk - Approximately 71% and 95% of the Plan's investments are invested with Vanguard as of December 31, 2024 and 2023, respectively. Accordingly, the Plan is dependent upon the financial condition of this company.

Investment valuation and income recognition - Investments are stated at fair value (see Note 6) with the exception of the common collective trust fund, which is valued at net asset value ("NAV") as a practical expedient as reported by the sponsor of the fund (see below). All fair values and net asset values have been determined and certified by Ascensus Trust Company, the Trustee of the Plan (see Note 3). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in investments includes the Plan's gains or losses on its investments bought and sold, as well as held during the year.

The common collective trust fund consists of various investment and security-backed contracts and is valued at NAV, which serves as a practical expedient to estimate fair value. The NAV of the common collective trust fund is not publicly quoted in the active markets and is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the trust will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no redemption restrictions or unfunded commitments as of December 31, 2024 or 2023. Therefore, investments

measured at net asset value per share used as a practical expedient are not required to be classified in the fair value hierarchy.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. At the end of each year, management reviews the individual notes receivable balances for any notes receivable outstanding at the end of the year from non-active payroll deductible notes receivable. Currently, there is no valuation allowance recorded; however, management will record an allowance, if and when potentially uncollectible participant notes receivable become material. If a participant defaults on a note receivable and distribution from the participant's account has been made during the Plan year because the participant has left the Plan, the defaulted note receivable will be reported as benefits paid to participants on the statements of changes in net assets available for benefits and deducted from the receivable balance.

Payment of benefits - Benefits are recorded when paid.

Corrective distributions - Corrective distributions represent excess employee salary deferral contributions received during the year but are returned to the participants in order to satisfy the relevant nondiscrimination provisions of the Plan. These corrective distributions are recorded as excess contributions payable on the statements of net assets available for benefits in the year that they are received. There were no corrective distributions or excess distributions payable to participants as of and for the year ended December 31, 2024. There were \$20,539 of corrective distributions for the year ended December 31, 2023.

Administrative costs - Administrative costs, including maintaining participant accounts and legal and accounting costs, are the obligation of the Plan; however, the Plan sponsor may pay or reimburse the Plan for such expenses. Costs of managing the investments are paid directly out of Plan assets (see Note 5).

Subsequent events - Management has evaluated subsequent events through September 24, 2025, the date that the financial statements were available for issue.

Note 3 - Information certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company, the Trustee of the Plan. Furthermore, the Plan's independent accountants did not perform auditing procedures with respect to the information except to compare such information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 4 - Tax status

The Company has adopted the Ascensus, LLC Defined Contribution Prototype Plan and Trust, Basic Plan Document No. 3 that the Internal Revenue Service has ruled as acceptable under Section 401(a) of the Internal Revenue Code. Accordingly, the Plan has been accounted for as a tax-exempt plan. The Plan has been amended since receiving the determination letter. The management of the Company and the Plan Administrator are not aware of any matters that would disqualify the Plan.

The Plan has reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan will include penalties and interest on income tax liabilities in administrative expenses if such amounts arise. The Plan did not incur any penalties and/or interest for the years ended December 31, 2024 and 2023. The Plan is no longer subject to regulatory examinations by tax authorities for the closed tax years before 2021.

Note 5 - Related party transactions

The Plan's investments are managed by Ascensus Trust Company, the Plan's Trustee Fees paid for these services qualify as party in interest transactions and are included in the net appreciation in investments on the accompanying statements of changes in net assets available for benefits.

The Plan contracts with The Vanguard Group to perform contract administrator services. Fees paid for these services were \$16,911 and \$16,190 for the years ended December 31, 2024 and 2023, respectively. The Plan has contracted with Dannible & McKee, LLP to provide plan auditing services. Fees paid by the Plan to Dannible & McKee, LLP were \$2,000 and \$19,549 for the years ended December 31, 2024 and 2023, respectively. The Plan contracts with LPL Financial RPCP to provide investment advisory services for the year ended December 31, 2024. Fees paid to LPL Financial RPCP were \$24,660 for the year ended December 31, 2024. The Plan contracted with Good Life Advisors, LLC, to provide investment advisory services for the year ended December 31, 2023. Fees paid to Good Life Advisors, LLC were \$16,005 for the year ended December 31, 2023. The fees paid for these services are included in administrative expenses in the accompanying statements of changes in net assets available for benefits.

Note 6 - Fair value measurements

The Financial Accounting Standards Board has published authoritative guidance on fair value measurements, which establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Registered Investment Companies (i.e., Mutual Funds) - Valued at the closing price reported on the active market on which the individual security is traded (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.
