## **Independent Auditors' Report**

To the Plan Administrator of  
Atlantic Geoconstruction Holdings, Inc. Retirement Savings Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Atlantic Geoconstruction Holdings, Inc. Retirement Savings Plan (formerly Terratest, Inc. Retirement Savings Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Atlantic Geoconstruction Holdings, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Atlantic Geoconstruction Holdings, Inc. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

## NOTE 1 - DESCRIPTION OF PLAN

The following description of the Atlantic Geoconstruction Holdings, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** - The Plan, which was originally adopted with an effective date of February 1, 2002, was most recently amended effective March 1, 2024. As part of the amendment, the Plan previously referred to as the Terratest, Inc. Retirement Savings Plan was renamed the Atlantic Geoconstruction Holdings, Inc. Retirement Savings Plan. The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code ("IRC"), covering all regular (not temporary) employees of Atlantic GeoConstruction Holdings, Inc. (the "Company"), formerly Terratest, Inc. The Plan excludes from participation those who are union employees, nonresident aliens, and leased employees. The anniversary date for the Plan is January 1 of each year, and a plan year is the 12-month period commencing January 1 and ending December 31 of each year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). As of December 31, 2024 and 2023, assets of the Plan are held by John Hancock Trust Company LLC, the Plan's trustee ("John Hancock" or the "Trustee").

**Eligibility** - Employees are eligible to participate in the Plan upon 30 days of service and attainment of age eighteen.

**Contributions** - The Plan is funded by the employees' contributions, which are equal to the total salary reduction elections of all participants. Participants may elect to defer up to 100 percent of their annual compensation subject to statutory limitations. Maximum contribution limits are adjusted annually by the Internal Revenue Service ("IRS"). Catch-up contributions, as defined in the Plan, are permitted for eligible participants age 50 or older. Participants may also contribute amounts representing distributions from other qualified plans and individual retirement accounts. The Plan also includes a Roth elective deferral option, whereby participants may elect to contribute after-tax dollars of their compensation, subject to statutory limitations. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferred rate set at 3 percent of eligible compensation, increased by 1 percent annually up to 6 percent, and their contributions invested in a designated investment until changed by the participant.

The Company makes safe-harbor matching contributions equal to 100 percent of the first 3 percent of compensation that a participant contributes to the Plan, plus 50 percent of the next 2 percent of compensation that a participant contributes to the Plan. The Company may also make discretionary matching, prevailing wage, and profit-sharing contributions to the Plan. For the year ended December 31, 2024, the Company did not make any discretionary matching or profit-sharing contributions. For the year ended December 31, 2024, prevailing wage contributions totaled \$64,470.

Participants direct the investment of all contributions into various investment options offered by the Plan.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and any matching contributions and allocations of (a) plan earnings and (b) administrative expenses. Allocations are based on participant compensation, participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Elections** - Participants may direct the investment of their contributions and any matching contributions into various investment options offered by the Plan. Participants may change their investment elections and their total contribution percentage via an automated system at any time.

## NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

**Vesting** - Participants are immediately vested in their contributions, safe-harbor matching, discretionary matching, prevailing wage, and profit-sharing contributions plus earnings thereon.

**Forfeitures** - The Company may maintain a separate forfeiture account with John Hancock. Under the terms of the Plan, forfeitures may be used in any manner permitted under the Plan, such as to reduce employer contributions or plan expenses. Employer contributions and plan expenses were not reduced by forfeitures during the year ended December 31, 2024 and the forfeiture account did not have a balance as of December 31, 2024 and 2023.

**Payment of Benefits** - On termination of service due to severance from employment, death, disability, attaining age 59.5 years, or retirement, a participant will be entitled to receive the participant's vested account balance. Terminated participants with account balances less than \$5,000 will automatically receive a lump-sum distribution of their account balances, unless otherwise directed. Participants or their beneficiaries who have balances greater than \$5,000 may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account, or partial withdrawals or installment payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account automatically as a lump-sum distribution. Hardship distributions are permitted, provided that the withdrawal is to satisfy a heavy financial need. In-service withdrawals are also allowed for participants who are at least 59 ½ years old.

**Notes Receivable from Participants** - Loans to plan participants are permitted. Participants may borrow funds from their participant accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loans must be repaid in terms of up to ten years. A participant is permitted to have one outstanding loan at a time.

The loans are collateralized by the balance in the participant's vested interest in the Plan and bear interest at 1 percent over the prime interest rate. Principal and interest payments are paid by the participant.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The Plan utilizes a modified cash basis of accounting for financial reporting purposes, whereby additions are recognized when received and deductions are recognized when paid, except that investments include adjustments to fair value at the end of the plan year and participant loans are reflected as notes receivable from participants. This method of accounting differs from accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires that additions are recognized when earned and deductions other than benefit payments are recognized when incurred.

**Use of Estimates** - The preparation of financial statements on the modified cash basis requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Risks and Uncertainties** - The Plan invests in various mutual funds and a common collective trust. Investments in general are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Investments Valuation and Income Recognition** - Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for discussion of fair value measurements.

## NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Net appreciation in fair value of investments included in the accompanying statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments, and certain fees. Net unrealized appreciation or depreciation in the fair value of investments represents the net change in the fair value of the investments held during the period. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value as of the beginning of the period or the cost of the investment if purchased during the year. Fees included in net appreciation of investments represent fees charged by the trustee for services provided in connection with recordkeeping and investment management.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Interest income earned on notes receivable from participants for the year ended December 31, 2024 was \$16,237.

**Plan Termination** - Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**Payment of Participant Benefits** - Benefits paid to participants are recorded when the cash is disbursed.

**Administrative Expenses** - All administrative expenses may be paid out of the Plan, unless paid by the Company.

## NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets.
- b. Quoted prices for identical or similar assets or liabilities in inactive markets.
- c. Inputs other than quoted prices that are observable for the asset or liability.
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

## NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED

The Plan's valuation methodology used to measure the fair values of mutual funds (which includes fixed income, U.S. equities, and international equities) were derived from quoted market prices as substantially all of these instruments have active markets and are classified within Level 1 of the valuation hierarchy.

The fair value of the collective investment trust has been measured using the Net Asset Value ("NAV") provided by the administrator of the fund under the practical expedient approach. The NAV is based on the assets of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The collective trust fund invests entirely in the Metlife Group Annuity Contract 25053. The objective of this fund is to provide safety and preservation of principal and accumulated interest for participant-initiated transactions. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments and no withdrawal restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no transfers between levels during the years ended December 31, 2024 and 2023.
