Independent Auditor's Report

To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of TD2 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of TD2 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Note 1 – Plan Description

The following description of the TD2 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan originally effective January 1, 2015. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective January 31, 2024. The Plan excludes non-resident aliens and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for the oversight of the Plan, the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Eligibility:

The Plan is a defined contribution plan covering all qualified employees of Translational Drug Development, LLC (the Plan Sponsor and Company). Employees are eligible to participate in the employee deferral, employer discretionary matching, and employer safe harbor matching components of the Plan upon turning 21 years of age and having one month of service. Plan entry dates are the first day of the month following satisfaction of eligibility requirements.

Effective January 31, 2024, the Plan was amended to recognize service from employees acquired from Flow Contract Site Laboratory, LLC (FCSL). Additionally, the Plan was amended to allow employees from FCSL to enter the Plan on their 1st day of employment with the Company.

Contributions:

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants may contribute up to 100% of their compensation as pre-tax 401(k) or Roth contributions to the Plan, up to the maximum allowed by the IRC. The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation, increasing automatically by 1% each year to a maximum of 12%. The automatic increase becomes effective in the second plan year following the year in which the automatic deferral election first becomes effective. Contributions are invested in the designated default fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may, at its discretion, elect to make a qualified matching contribution or employer contribution to the Plan. In addition, the Company contributes a safe harbor contribution equal to 100% of the first 5% of an employee's eligible compensation, regardless of plan participation. Employer safe harbor contributions are determined each payroll period. There were no Company discretionary contributions for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts:

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of Plan earnings or losses based on their investment allocation. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions and employer safe harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A year of service is defined as a plan year during which an employee works at least 1,000 hours. A participant is 25% vested after one year of credited service with an additional 25% vesting per year until the participant is 100% vested after four years of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear an interest rate equal to 2% above the prime rate as of the note request date. Notes must be repaid over a period not to exceed five years, but an extended repayment period is permitted if the note is for the purchase of the participant's principal residence (but in no case more than 15 years). Principal and interest are paid ratably through payroll deductions.

Payment of benefits:

Upon termination of service due to death, disability, termination of employment, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution. For termination due to death or required minimum distributions, the participant may also elect to receive installments. The Plan allows for in-service distributions if a participant reaches age 59 ½ or has been on active duty for at least 30 days, and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$7,000, the plan administrator may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeited accounts:

Forfeited non-vested accounts may be used to reduce employer discretionary contributions or to pay plan expenses. There were \$0 and \$32,877 of unallocated forfeitures as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, the Plan utilized \$32,877 to reduce 2023 employer contributions. This amount is included as a reduction to the 2023 employer contributions receivable on the statement of net assets available for benefits.

Note 2 – Summary of Significant Accounting Policies

A summary of the Plan's significant accounting policies follows:

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Note 2 – Summary of Significant Accounting Policies (Continued)

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The trustees determine the Plan's valuation policies utilizing information provided by the custodian and investment advisors. See *Note 4* for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions receivable:

Contributions from participants and related employer contributions, if any, are recorded in the year when the related compensation is earned, based on payroll period end date, regardless of the payroll check date.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Payment of benefits:

Benefits are recorded when paid.

Administrative expenses:

Administrative expenses of maintaining the Plan may be paid by the Company or from the assets of the Plan. The expenses that are paid from Plan assets are either shared by all participants or charged directly to the account of the participant on whose sole behalf the expense is incurred. Administrative expenses for the year ended December 31, 2024, consisted of recordkeeper, third-party administrator, investment advisor, and custodial fees. Investment expenses paid by the Plan are included in net appreciation of fair value of investments.

Subsequent events:

Plan management has evaluated subsequent events through September 22, 2025, which is the date the financial statements were available to be issued.

Note 3 – Information Certified and Provided by the Custodian

John Hancock Life Insurance Company (John Hancock), the custodian of the Plan, has supplied the plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Note 4 – Fair Value Measurement

Fair value measurements are based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (NAV) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. There are no unfunded commitments or redemption restrictions associated with these investments.

*In accordance with ASC 820-10, certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the fair value of the Plan's assets at the end of each respective year.

The Plan has investments in various pooled separate accounts which invest in equity, fixed income, and target date funds. The objective of these investment vehicles invested in equity instruments is to approximate the risk and return characterized by various indexes; to seek long term capital appreciation; provide diversified exposure representative of various segments of the U.S. or foreign equity market; and/or to seek income. The objectives of investment vehicles invested in fixed income is to provide investment results that approximate the overall performance of certain bond indices and/or to provide a predictable rate of return while preserving the safety of capital and minimizing market risk. The objective of the investment vehicles invested in target date funds is to provide various levels of asset allocations which become more conservative over time so participants can stay with the same fund before and after selected retirement dates.

Note 5 – Party-in-Interest and Related Party Transactions

Certain Plan investments are managed by John Hancock, the custodian as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan made direct payment to John Hancock of \$36,277. Additionally, indirect fees are paid to John Hancock based on investment account balances. These fees ranged from 0.05% to 0.65% of the investment account balance.

Edberg Perry, LLC is the third party administrator. For the year ended December 31, 2024, the Plan recognized \$6,670 in administrative fees to Edberg Perry, LLC.

Buckman and Corning Financial Strategies Group (Buckman) provide investment advisory services to the Plan. For the year ended December 31, 2024, the Plan recognized \$30,425 in administrative expenses to Buckman.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the plan administrator has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of complete or partial termination of the Plan, participants would become 100% vested in their accounts.

Note 7 – Tax Status

The Plan is placing reliance on an opinion letter dated June 30, 2020 from the IRS on the pre-approved plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The trustees concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to examination by the IRS; however, there are currently no audits for any tax periods in progress.

During 2023, the Plan sponsor inadvertently failed to deposit \$580 of participant deferrals within the required timeframe as stated by the United States Department of Labor (DOL) regulations. The Plan sponsor is in the process of depositing lost earnings and paying the applicable excise tax.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
