***Notes to Financial Statements***

***Note 1. Plan Description***

The following description of the American General Media Profit Sharing and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General:***

The Plan is a defined contribution 401(k) profit sharing plan covering all employees of AGM California, AGM-Nevada, Winton Road Broadcasting, and American General Media Foundation (the Company) who are 21 years of age or older and have completed 1,000 service hours within a consecutive twelve month period, excluding nonresident aliens and Puerto Rico residents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions:***

Participating employees are allowed to make contributions of their pretax or after-tax annual compensation as defined in the Plan, pursuant to Section 401(k) of the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified contribution plans. Effective January 1, 2022 the Plan was amended to add a safe harbor contribution feature. The safe harbor contribution is 100% of a participant's elective deferrals that did not exceed 3% of a participant's compensation, plus 50% of the participant's elective deferrals that exceeded 3% of the participant's compensation but did not exceed 6% of the participant's compensation. The Plan can make an employer matching contribution for a discretionary amount as determined by Plan management each Plan year and can also make a profit sharing contribution. For the year ended December 31, 2024, the safe harbor contribution was \$138,924. Contributions are funded each payroll period.

***Participant accounts:***

Separate accounts are kept for each participant. Each participant's account is credited with the participant's contributions, the Company's contributions, and allocation of Plan earnings or losses and expenses. All amounts are participant-directed; participants direct the investment of their contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## *Notes to Financial Statements*

### ***Vesting:***

Participants are immediately vested in their voluntary contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company's other contributions plus earnings thereon is based on continuous years of service based on a graded schedule. A participant is 100% vested in employer match contributions after five years of credited service or upon reaching normal retirement age. A participant is 100% vested in profit sharing contributions after six years of credited service or upon reaching normal retirement age. Participants are automatically 100% vested upon termination due to death or disability.

### ***Notes receivable, participants:***

A participant may obtain one loan for a minimum of \$1,000 which does not exceed 50% of their nonforfeitable account balance. The maximum dollar amount of the loan outstanding may not exceed \$50,000. The loan is secured by 50% of the participant's nonforfeitable account balance. The loans bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through each payroll period.

### ***Benefit payments and withdrawals:***

Upon termination of service, participants may elect to receive a lump-sum distribution equal to the vested value of their account or leave the value of the account on deposit until normal retirement (age 65). Distribution of vested value will also occur in the case of death or disability. If a participant's vested account balance is less than \$5,000, they will automatically receive payment in the form of a lump-sum. Participants with vested account balances greater than \$5,000 may elect payments in the form of lump-sum, installments or a combination of lump-sum and installment payments.

Participants may request for in-service withdrawals if a participant has reached age 59 ½ and may elected to withdraw all or a portion of the entire vested account while participant is still employed by the Company. The participant may also request for hardship withdrawals in which the participant may withdraw employee pretax and after-tax elective deferral contributions to satisfy specific and heavy financial needs in accordance with Internal Revenue Service regulations.

Amounts allocated to accounts of persons who at December 31, 2024, have elected to withdraw from the Plan but have not been paid are \$-0-.

### ***Forfeited accounts:***

Forfeitures of terminated employees' nonvested account balances are used to offset employer contributions or pay Plan expenses. Forfeitures used to offset Plan expenses for the year ended December 31, 2024 were \$-0-. Forfeiture balances at December 31, 2024 and 2023 were \$1,957 and \$1,876, respectively.

## *Notes to Financial Statements*

### *Note 2. Significant Accounting Policies*

#### ***Basis of accounting:***

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

#### ***Use of estimates:***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### ***Investment valuation and income recognition:***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### ***Notes receivable, participants:***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

#### ***Plan expenses:***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

## *Notes to Financial Statements*

### ***Benefits:***

Benefit payments are recorded when paid.

### ***Tax status:***

The non-standardized pre-approved Profit Sharing Plan with CODA Adoption Agreement has received its latest determination letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as designed, is in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### ***Note 3. Plan Termination***

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in any employer matching contributions that have been credited to their accounts. Payment of such amounts will be made to participants by the asset custodian as directed by the Plan Administrator.

### ***Note 4. Fair Value Disclosures***

The Financial Accounting Standards Board (FASB) provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB are described as follows: Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access; Level 2 - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means; Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

## *Notes to Financial Statements*

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Pooled separate accounts:* Separate accounts that invest exclusively in mutual funds are valued at the net asset value of the underlying mutual fund. Those separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

*Common/collective trusts:* The fair value of the common/collective trust are from broker quotations from market makers, original transaction price and recent transactions in recent or similar instruments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### ***Note 5. Investment Contract with Insurance Company***

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Ameritas Life Insurance Corp. (Ameritas Life) and Ameritas Life Insurance Corp. of New York (Ameritas Life of New York). Ameritas Life and Ameritas Life of New York maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The

guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract is a fully benefit-responsive investment, therefore it is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Ameritas Life and Ameritas Life of New York, represents contributions made under the contract, plus earnings less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a periodic basis for resetting. The contract value of the investment contract at December 31, 2024 and 2023 was \$296,596 and \$242,459, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (e) premature termination of the contact. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### **Note 6. Certified Financial Information**

The following information as of December 31, 2024 and 2023 and for the year ended December 31, 2024 was obtained and certified as complete and accurate by Ameritas Life Insurance Corp., the Plan custodian, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 7. Party-in-Interest Transactions**

For the year ended December 31, 2024, Plan's investments include a guaranteed investment contract managed by Ameritas Life Insurance Corp., the Plan's asset custodian. During the year ended December 31, 2024, the Plan paid \$10,546 to third party administrators and the asset custodian. These transactions qualify as a party-in-interest transactions which are exempt from the prohibited transactions rules.

**Note 9. Subsequent Events**
