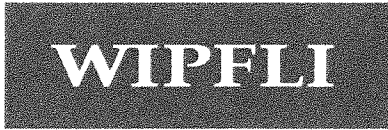

### Note 1: Description of Plan

The following description of the Terminal Supply Co. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all domestic, non-union employees of Terminal Supply Co. (the "Company" and "Plan Sponsor"). The Plan contains a 401(k) elective deferral arrangement which covers all employees of the Company meeting the eligibility requirements, as discussed below. The Plan is subject to the Department of Labor's ("DOL") Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Plan Sponsor is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

#### Eligibility

Except for nonresident aliens, leased employees and employees covered by a collective bargaining agreement, any employee who has completed one year of service and has reached the age of 21 is eligible to participate in the Plan. Upon meeting these requirements, and unless subject to additional requirements discussed below, an employee is eligible to make elective deferral contributions and participate in Plan Sponsor discretionary matching contributions, discretionary profit sharing contributions and safe harbor contributions. Eligible participants may enter the Plan immediately upon meeting the eligibility requirements.

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan document on a pre-tax or Roth basis. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designed fund based on their date of birth, until changed by the participant. Rollover contributions are not matched.

The Plan Sponsor provides a safe harbor contribution to the participants equal to 3% of eligible compensation. Total safe harbor contributions for the year ended December 31, 2024 were \$487,173.

In addition to the general eligibility requirements discussed above, a participant must have completed 500 hours of service in the Plan year and be employed on the last day of the Plan year to be eligible to participate in any discretionary profit sharing contributions. During the year ended December 31, 2024, the Plan Sponsor did not provide any such discretionary matching or discretionary profit sharing contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's safe harbor and discretionary matching contributions, allocations of (a) discretionary profit sharing contributions, (b) plan earnings (losses) and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately 100% vested in their voluntary contributions plus actual earnings thereon. A participant is 100% vested in Company discretionary matching contributions, safe harbor contributions, and discretionary profit sharing contributions and earnings after two years of credited service or upon other conditions as defined in the Plan document.

#### Forfeitures

Forfeitures may be used to pay administrative expenses or used to offset future Company contributions. In 2024, administrative expenses were reduced by \$12 from forfeited nonvested accounts. Forfeited nonvested accounts totaled \$12 and \$81 as of December 31, 2024 and 2023, respectively.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of the lesser of one-half of the total vested account balance reduced by the outstanding balance of all other loans from the Plan on the date of the new loan application, or \$50,000, reduced by the highest loan balance outstanding during the prior 12 months. The loans are secured by the balance in the participant's account. Loans bear interest at a rate set by the Plan administrator in accordance with local prevailing rates for similar types of loans. Interest rates ranged from 4.25% to 9.50% on loans outstanding as of December 31, 2024. Principal and interest payments are made through payroll deductions over a term not to exceed five years, except for home purchase loans, which can be for terms consistent with normal mortgages.

#### Payment of Benefits

Distributions are allowed upon retirement (age 65), attainment of age 59½, disability, death, or termination of employment. Participants or their beneficiaries may receive a lump-sum distribution equal to the value of their vested interest in the account or installment payments as requested by the participant, subject to minimum distribution requirements. A participant no longer employed by the Company may be subject to various force-out provisions depending on the participant's account balance upon the date of valuation after termination.

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States ("GAAP").

#### Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Administrative expenses also include trustee, record keeping and professional fees. Investment related expenses are included in the net appreciation in fair value of investments.

#### SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

#### Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

### Note 3: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus LLC, as Agent for Ascensus Trust Company, the Trustee of the Plan.

### Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.

- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued at the NAV of the shares held by the Plan at year end and is determined on the value of the underlying investments of the fund. The money market fund seeks to maintain a \$1.00 NAV.

*Self-directed brokerage securities:* The fair value is based on the underlying investments, which include common stocks and mutual funds. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds are valued at the daily closing price as reported by the mutual fund. Mutual funds included in the self-directed brokerage accounts are open-end mutual funds that are registered on the SEC. These mutual funds are required to publish their daily NAV and to transact at that price. The mutual funds and common stock held by the Plan are deemed to be actively traded.

### Note 5: Party-In-Interest Transactions

Certain Plan investments are managed by The Vanguard Group, Inc. ("Vanguard"). Vanguard is the recordkeeper, and therefore, these transactions qualify as party-in-interest transactions. Fees of \$9,478 were paid to Vanguard in 2024.

Certain fees incurred by the Plan for investment management services are netted against net appreciation in fair value of investments. These transactions are deemed to be party-in-interest transactions.

Vanguard provides certain administrative services to the Plan pursuant to a Fee Schedule agreement between the Company and Vanguard. Vanguard receives revenue from mutual fund service providers for services Vanguard provides to the funds. This revenue is used to offset certain amounts owed for Plan administrative services.

If the revenue received by Vanguard from such mutual fund service providers exceeds the amount owed under the Fee Schedule agreement, Vanguard remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Plan Sponsor may make a payment to Vanguard for administrative expenses not covered by revenue sharing. The Plan did not receive excess revenue sharing credits for the year ended December 31, 2024.

In addition, notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in Company contributions.

### Note 7: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, is in compliance with the application sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
