Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Park Nicollet Health Services 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Park Nicollet Health Services 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Park Nicollet Health Services 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following description of Park Nicollet Health Services 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan providing retirement benefits to eligible employees of the following subsidiaries of Park Nicollet Health Services (the Company): Park Nicollet Methodist Hospital, Park Nicollet Clinic, Park Nicollet Healthcare Products, and Park Nicollet Institute. The Plan was originally effective January 1, 1976, last restated effective November 29, 2021, and last amended effective January 1, 2025. Employees are immediately eligible to participate on their first day of employment. The Plan is subject to the provisions of ERISA.

The Company is the Plan Sponsor and administrator and has appointed Fidelity Management Trust Company (Fidelity) as trustee. The trustee executes investment transactions as directed by the participants. The trustee is also responsible for making distributions to participants. Fidelity performs some, but not all, of the recordkeeping services for the Plan. Fidelity performs these functions at the direction of the Company in accordance with the provisions of the Plan.

Contributions

All participants may contribute any percentage of their eligible compensation, either pretax or Roth, limited to \$23,000 and \$22,500 in total contributions (the limit is \$30,500 and \$30,000 for participants who qualify for a catch-up contribution) for 2024 and 2023, respectively. Participants age 50 or older qualify to make catch-up contributions. The Plan implemented an automatic enrollment feature for newly hired employees. Upon meeting eligibility requirements, newly hired employees have elective deferrals withheld in the amount of 4% of their eligible compensation and their contributions invested in a designated balanced target date fund until changed by the participant.

The Company may, at its discretion, make matching contributions on elective deferrals, up to a maximum of 4% of eligible compensation. The discretionary matching contribution is based on the operating income of the Company, as defined by the Plan. To be eligible for the Company's matching contribution, the participant must have completed one year of service, defined as the 12-month period following the date of hire. Once eligible, the participant must have 1,000 hours of service during the plan year and be employed as of December 31 in order to receive a contribution, except if terminated during the year due to death, disability, or retirement. In 2024 and 2023, the Company made matching contributions of \$13,508,098 and \$12,135,949, respectively.

Contributions (Continued)

Effective January 1, 2015, the Plan added a discretionary nonelective contribution provision. To be eligible for the discretionary nonelective contribution, a participant must complete 1,000 hours of service and be employed on the last day of the Plan year unless termination is due to death, disability, or retirement. Upon meeting the eligibility requirements, a participant is immediately eligible to enter the Plan for the discretionary nonelective contributions. For the years ended December 31, 2024 and 2023, the Company contributed an amount equal to the sum of 4.5% of each participant's compensation, plus 5.2% of that portion of the participant's annual compensation, which exceeds 100% of the social security taxable wage base in 2024 and 2023, as defined. Eligible compensation is limited to a maximum of \$345,000 and \$330,000 for 2024 and 2023, respectively. In 2024 and 2023, the Company made nonelective contributions of \$37,367,410 and \$33,600,492, respectively, before forfeitures were applied.

Rollover contributions are assets that were formerly held in a benefit plan of a participant's prior employer and were transferred into the Plan during the current year. Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts

Each participant's account is credited with his or her contributions, the Company's matching and nonelective contributions (if any), rollover contributions, and net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all matching and participant contributions plus actual earnings thereon. Vesting in the nonelective Company contribution is credited as follows:

Notwithstanding the above, participants are also 100% vested upon death or disability.

Forfeited Accounts

Forfeited nonvested accounts are used to pay administrative expenses and to reduce future Company nonelective contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$336,803 and \$253,717, respectively. There were no forfeitures used to pay administrative expenses for the years ended December 31, 2024 and 2023. There were \$496,636 and \$419,000 of forfeitures used in the subsequent Plan year to reduce Company nonelective contributions for the years ended December 31, 2024 and 2023, respectively.

Investments

Participants direct the investment of their contributions into various investment options offered by the Plan.

Notes Receivable from Participants

Under provisions of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. These loans bear interest at the prime rate plus 1%. Payments are due in biweekly or monthly installments of principal and interest over five years, unless the loan is for the purchase of a principal residence, in which case the repayments can be made over a period of 10 years.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded at December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Benefit Payments

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements as provided in the Plan document. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Fidelity Management Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants and related interest income reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Considerable judgment may be required in interpreting market data used to develop the estimates of fair value. The three levels of the fair value hierarchy under GAAP are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued daily based on unadjusted quoted market prices from national exchanges.

Money Market Fund: Valued daily based on subscription and redemption activity at a stable \$1 net asset value (NAV). Redemptions can occur daily at NAV and there are no restrictions to redemption or unfunded commitments.

Self-Directed Brokerage Accounts: Each common stock, preferred stock, mutual fund, and unit trust is valued daily based on unadjusted quoted market prices from national exchanges. Cash and cash equivalents including certificates of deposit and U.S. treasury and corporate bonds are recorded at book value, which approximates fair value.

Collective Trust Funds: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various mutual funds, collective trust funds, self-directed brokerage accounts and a money market fund, which may include investments in, but not limited to, U.S. government securities, corporate debt instruments, and corporate equity securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur over time and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across the participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments. Investment decisions are made, and the resulting risks are borne, exclusively by the Plan participant who made such decisions.

NOTE 6 PLAN TERMINATION

Although the Company has not expressed any intent to do so, it may terminate the Plan at any time, subject to the provisions of the Plan and ERISA. In the event the Plan is terminated, participants will become 100% vested in their accounts.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under present income tax law. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA, as amended, unless a specific exemption applies. Certain Plan investments are managed by Fidelity. Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees incurred by the Plan for investment management services are offset with revenue sharing credits and included as a reduction of the return earned on each investment.

NOTE 9 NONEXEMPT TRANSACTION

During 2024, the Company failed to remit employee 401(k) deferral contributions and loan payments for certain payroll periods within the timeframe prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the IRC. The \$16,500,237 of 401(k) deferral contributions and loan payments were remitted to the Trust during 2024 and 2025, however the lost earnings related to these late deferrals and loan payments are still being calculated and will be deposited during 2025.
