Notes to Financial Statements

1. Description of Plan

The following description of the Mountain River 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan available to eligible employees of Mountain River Trucking, Inc. (the “Company” or “Employer”). To be eligible to participate in the Plan, an employee must have completed one year of service and attained age 21. Employees may begin participation as of January 1 or July 1 coinciding with or following the date on which they meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Participants may elect to contribute a percentage of their pre-tax and/or after-tax (“Roth”) annual compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”).

The Company makes a safe harbor matching contribution equal to 100% of the first 3% of annual compensation plus 50% of the amount between 3% and 5% of annual compensation contributed to the Plan. As of December 31, 2024 and 2023, the Plan recorded a receivable of approximately \$2,900 and \$13,600 related to the annual true-up provision for the Company’s safe harbor matching contribution.

The Company may also make an additional discretionary contribution to be determined annually. However, there were no discretionary additional matching contributions for 2024.

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered through the Plan. Participants may change their investment options at any time and deferral percentages quarterly.

Participant Accounts

Each participant’s account is credited with the participant’s and the Company’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based on participant contributions, earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions and the Company’s safe harbor matching contributions, plus any income or loss thereon. Vesting on the Company’s discretionary contributions, plus any income or loss thereon, will be based on the following schedule:

1. Description of Plan (Concluded)

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive a lump-sum payment or installment payments over a period not to exceed the joint life expectancy of the participant and the designated beneficiary. In-service distributions may be made to participants who have reached age 59½. Withdrawals may also be made upon circumstances of financial hardship, as specified by the Plan.

Forfeitures

Forfeitures from non-vested participant accounts may be used to offset future Company contributions or administrative expenses. \$13,600 in forfeitures were utilized during 2024 to offset Company contributions. Available forfeited non-vested accounts totaled approximately \$4,200 and \$15,300 at December 31, 2024 and 2023.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Terms are generally up to five years and only one note may be outstanding at a time. The notes are secured by the vested account balance in the participant's account and bear interest at the prime rate plus 1% at the date of the application. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Other fees, including custodian and recordkeeping, may be paid by the Plan. Distribution and note fees are paid from the affected participant's account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Significant Accounting Policies (Concluded)

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through October 6, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (“John Hancock”), the custodian of the Plan.

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by CCH Incorporated, DBA ftwilliam.com (“CCH”). The IRS has determined and informed CCH by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants’ accounts will become fully vested and nonforfeitable.

7. Party-in-Interest Transactions

Certain plan investments are shares of funds managed by John Hancock. Fees paid to John Hancock by the Plan for certain administrative services were approximately \$13,500 for 2024. John Hancock serves as custodian and, therefore, these transactions qualify as party-in-interest transactions.

Fees paid to Aprio by the Plan for investment advisory services and administrative services were approximately \$7,300 in 2024.

8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurement

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered separate accounts: These investments are based on the market value of the underlying investments minus its liabilities, and then divided by the number of shares outstanding, which represents the net asset value ("NAV") provided by the administrator of the fund. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.


