

## Notes to Financial Statements

December 31, 2024 and 2023

**NOTE 1**      **DESCRIPTION OF PLAN**

The following brief description of **Twin Cities Spine Center 401(k) Profit Sharing Plan and Trust** (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**1.      General**

The Plan is a defined contribution plan adopted by Twin Cities Spine Center (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). It was restated effective January 1, 2021. The Company is the administrator and sponsor of the Plan and has appointed Acensus Trust Company as Trustee and recordkeeper of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's offerings, monitors investment performance and reports to the Plan's Administrator.

**2.      Eligibility**

Employees who have attained the age of 21 and have completed 30 days of service are eligible to participate in the elective deferrals portion of the Plan. Additionally, employees who have completed one year of service with a minimum of 1,000 hours worked and attained the age of 21 are also eligible to receive the safe harbor and the additional employer discretionary contributions. Employees covered by a collective bargaining agreement, designated as "Fellows" or non-resident alien employees are excluded from participation in the Plan.

**3.      Entry date**

Employees may enter the Plan on the first day of the month coinciding with or following the date they satisfy the Plan's eligibility requirements.

**4.      Contributions**

Each year, participants may contribute up to 90 percent of their pretax annual compensation (salary reduction contributions), as defined in the Plan document, up to the maximum limits of the Internal Revenue Code ("IRC"). Participants may designate all or a portion of their deferral contributions as after tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company contributes to the Plan a discretionary amount determined annually by the Company's Board of Directors. The Company also provides a safe harbor nonelective contribution of 3 percent of eligible compensation. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

**NOTE 1**      **DESCRIPTION OF PLAN (CONTINUED)****5.      Investment Options**

Upon enrollment into the Plan, a participant may direct employee and Company contributions in any of the funds offered by the Plan or through self-directed brokerage accounts. Participants may change their investment options daily.

**6.      Participant Accounts**

Each participant's account is credited with the participant's salary reduction contributions; catch-up contributions; Roth contributions; rollover contributions; and the Company's safe harbor and discretionary contributions, as well as an allocation of the Plan's earnings. Participants are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**7.      Vesting**

Participants are immediately vested 100 percent in their salary reduction (pre-tax and Roth), catch-up, rollover, safe harbor, and discretionary contributions.

**8.      Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested interest in the Plan or \$50,000. The loans are secured by the balance in the participant's account and bear interest at 1.00 percent over the Prime Rate. Principal and interest is paid ratably through payroll deductions over a period not to exceed 5 years, with longer term loans available for the purchase of a primary residence. A participant may have no more than one outstanding loan at any time.

**9.      Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments as defined in the Plan document. An active participant is allowed to receive a distribution from the Plan prior to termination of employment provided they have obtained age 59 1/2 or normal retirement age, as defined in the Plan document. A terminated employee with a balance of less than \$5,000 may be automatically paid out by the Plan upon termination. In the event of termination of employment (other than for death, disability, or retirement after age 59 1/2), participants are entitled to all of their account balances.

**NOTE 1      DESCRIPTION OF PLAN (CONTINUED)****10.   Forfeitures**

Participants who terminate before year-end are not eligible to receive any discretionary employer contributions for the Plan year, and may lead to forfeited contributions. These forfeitures can be used to reduce Plan expenses or future Company contributions. As of **December 31, 2024** and 2023, forfeited nonvested accounts totaled **\$9,363** and \$8,032, respectively. During the years ended **December 31, 2024** and 2023, forfeitures of **\$11,136** and \$8,410 were used to reduce Company contributions.

**11.   Other**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at anytime and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES  
AND USE OF ACCOUNTING ESTIMATES****Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Accounting Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("US GAAP") requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, Trustee and insurance companies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as those held during the periods ended **December 31, 2024** and 2023.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES  
AND USE OF ACCOUNTING ESTIMATES (CONTINUED)****Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of **December 31, 2024** and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution and not accrued upon termination of employment.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**NOTE 3      FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 3      FAIR VALUE MEASUREMENTS (CONTINUED)**

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no changes in the methodologies used at **December 31, 2024** and 2023.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds, common stocks, and money market funds that are valued on the basis of readily determinable market prices.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held are deemed to be actively traded.

Money market funds: Accounts consist of separately managed investment portfolios that are valued based on information reported by the investment provider.

**NOTE 4**      **INFORMATION CERTIFIED BY ACENSUS TRUST COMPANY**

The Plan sponsor has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for **2024** and 2023. Accordingly, as permitted under such election, no independent auditing procedures were performed with respect to the information certified by the asset custodian Acensus Trust Company, as of and for the year ended **December 31, 2024** and 2023.

The asset custodian has certified the completeness and accuracy of the Plan's statements of accounts, including beginning and ending balances of investments held, contributions received, and detail of all transactions occurring during the period, including investment income.

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to us complete and accurate by the asset custodian.

**NOTE 5**      **RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee organization, or a relative of such persons mentioned.

Certain Plan investment options are investments offered by the Trustee of the Plan. Additionally, fees incurred by the Plan for investment manager services are included in investment income for the audit periods. The Plan also issues loans to participants that are secured by the vested balance in the participants' accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**NOTE 6**      **TAX STATUS**

The Plan uses a Prototype Plan document established by the Trustee, who received an opinion letter from the Internal Revenue Service dated June 30, 2020, which stated the Prototype Plan document satisfies applicable regulations of the IRC. The Company believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

US GAAP requires the Company to evaluate tax positions taken by the Plan. The effects of an uncertain tax position are recognized in the financial statements when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan and has concluded that as of **December 31, 2024** and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions.

**NOTE 7**      **RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market conditions, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

The Plan had investments of **\$6,300,567** and \$4,744,554 that were concentrated in one fund at **December 31, 2024** and one fund at 2023, respectively.

**NOTE 8**      **RECONCILIATION OF FINANCIAL STATEMENTS**

The Form 5500 has been prepared recognizing all investment income, including dividends and interest; realized gains and losses; and unrealized gains and losses, reported as net investment gain (loss) from registered investment companies, rather than separated as shown on the statements of changes in net assets available for benefits for the years ended **December 31, 2024** and 2023, respectively. There were no other significant differences between the financial statements and the Form 5500 for the years presented.

**NOTE 9**      **SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through **October 8, 2025**, the date the financial statements were available to be issued.
