We have performed audits of the financial statements of Citadel Completions 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of the Citadel Completions 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering employees of Citadel Completions, LLC (the Company) upon reaching age 18. Employees not eligible to participate are members of a collective bargaining unit, nonresident aliens, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Participant Contributions

Each year, participants may contribute up to 90% of eligible compensation, as defined in the Plan Document, representing pre-tax and/or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company has a safe harbor match of 100% on elective deferral contributions up to 3% and 50% of elective deferral contributions greater than 3% up to 5% of eligible compensation. The Company may also elect to make discretionary non-elective contributions to the Plan. Participants are eligible for the discretionary non-elective contributions if the employee is employed by the Company on the last day of the Plan year, as defined in the Plan Document. There were no discretionary non-elective contributions made by the Company for the year ended December 31, 2024.

Contributions are subject to Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, and Plan earnings and charged with withdrawals and allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. Participants may direct the investment of their account balances into investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Notes To Financial Statements *(Continued)*

#### **Vesting**

Participants are immediately vested 100% on all elective deferrals, Company safe harbor matching contributions, and any earnings thereon.

Vesting of the Company's contributions received prior to January 1, 2019 and non-elective Company contributions were based on years of continuous service as listed below. Participants become fully vested upon death, disability or reaching normal retirement age.

#### **Forfeitures**

Participants who terminate their employment and are less than 100% vested will forfeit the non-vested portion of their account. Participant forfeitures may be used to pay the Plan's administrative expenses or reduce Company contributions. There were no forfeitures used to reduce Company matching contributions for the year ended December 31, 2024. At December 31, 2024 and 2023, there were \$2,145 and \$2,036, respectively, in forfeited non-vested accounts.

#### **Payment Of Benefits**

On termination of service, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan Administrator will authorize the benefit payment without the participant's consent. Participant account balances of \$1,000 or more will be distributed from the Plan to an individual retirement account if not otherwise directed by the participant.

#### **In-Service Withdrawals**

Participants age 59 ½ or older can take an in-service withdrawal. Participants can also take in-service withdrawals in the event of undue financial hardship, subject to Plan provisions.

#### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. No more than two loans are allowed outstanding to a participant at any one time. Loan terms may range from one to five years or longer if the loan is for the purchase of a primary residence. Loans bear a reasonable rate of interest determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

#### **Investments Options**

Participants direct the investment of their own contributions and the Company's contributions into various investment options offered by the Plan through Fidelity Management Trust Company (the Trustee).

#### **Administrative Expenses**

The Company pays significant administrative expenses incurred by the Plan.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

#### **Investment Valuation And Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses in securities that were bought and sold during the year.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Document.

#### **Payment Of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

### **3. Certified Investment Information**

#### 4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

#### **Registered Investment Companies**

Investments in registered investment companies are valued at the daily closing price as reported by the fund. The registered investment companies held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

#### **Collective Trust Fund**

The collective trust fund is valued at the NAV of units, or NAV equivalent, of the individual fund. The NAV, as provided by the trustee of the invested fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There were no unfunded commitments of the collective trust fund at December 31, 2024 or 2023. The collective trust fund held by the Plan is redeemable daily, and it files an annual report on Form 5500 as a direct filing entity.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### **6. Income Tax Status**

The Plan utilizes a non-standardized pre-approved profit sharing plan that received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the pre-approved plan, as then designed, was in accordance with applicable sections of the IRC. The Plan itself has not received a determination letter. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan and the related trust are tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **7. Party In Interest Transactions**

Certain Plan investments include shares of registered investment companies and a collective trust fund managed by an affiliate of the Trustee. In addition, certain participants have outstanding notes receivable as of December 31, 2024 and 2023. These transactions qualify as exempt party in interest transactions allowable under ERISA regulations.

## **8. Risk And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.
