**SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT**

We performed audits of the accompanying financial statements of the CJ Miller LLC 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1** DESCRIPTION OF PLAN

The following description of the CJ Miller LLC 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document or the Summary Plan Description for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering all employees of CJ Miller, LLC (Company), provided the employee attains certain minimum levels of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Participants may make before-tax contributions, not to exceed Internal Revenue Code (IRC) limitations. Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions. The Plan permits rollover contributions from other qualified retirement plans. For participants who are 21 years old and who have obtained one year of service, the Company provides a safe harbor matching contribution that matches 100% of up to 3% of the participant's compensation plus 50% of compensation that exceeds 3% up to 5%. The Company may also make discretionary profit-sharing contributions.

Effective May 28, 2024, the Company may make a discretionary wage rate contribution for any eligible employee who is working on a job to which a prevailing rate schedule is applied. An employee may join the Plan for the purpose of only receiving this contribution.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, an allocation of Plan earnings, and any discretionary Company contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

***Vesting***

Participants are immediately vested in their voluntary contributions, safe harbor employer contributions and the employer discretionary wage rate contribution. A participant generally becomes fully vested in the Company's discretionary profit sharing contributions upon three years of service, disability (as defined by the Plan), or death of the participant.

***Investment Options***

Upon enrollment in the Plan, a participant may direct employee contributions into various investment options offered by the Plan. Specific information regarding these options may be

obtained from the Plan Administrator. Participants may change their investment options at any time.

***Notes Receivable From Participants***

Participants may borrow against the balance in their account, up to a maximum of the lesser of 50% of their vested balance or \$50,000. Note terms require amortization of principal and interest over a period not to exceed five years. Notes used to acquire a principal residence may extend beyond a five-year term. The notes receivable are collateralized by the balance in the participant's account and bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Notes receivable are repaid through payroll deductions and may be repaid in full at any time.

***Payment of Benefits***

Upon termination of employment or service due to death, disability, or retirement or upon reaching age 59½, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in the participant's account in either a lump-sum amount or partial withdrawals to meet required minimum distributions under IRC Section 401(a)(9). Withdrawals for financial hardship (as defined by the Plan) are permitted under the Plan.

***Forfeited Accounts***

Forfeited balances of non-vested accounts are used to reduce administrative expenses and Company contributions in accordance with the Plan Document. There were no forfeited non-vested accounts at December 31, 2024 and 2023.

***Plan Termination***

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all interests of the participants not previously vested would become vested and non-forfeitable, and the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

***Plan Expenses***

Certain administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

**NOTE 2** SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

***Accounting Standards Codification***

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

***Basis of Presentation***

The accompanying financial statements were prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Valuation of Investments***

Investments are stated at fair value except for fully benefit responsive investment contracts which are reported at contract value. See Note 4 for a discussion of fair value measurements.

***Risk and Uncertainties***

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

***Notes Receivable From Participants***

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefits are recorded when paid.

***Subsequent Events***

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 9, 2025, the date the financial statements were available to be issued.

The Plan's investments were held by the Custodian, Principal Trust Company, at December 31, 2024 and 2023. **NOTE 4 VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions under the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

*(See Independent Auditors' Report)*

The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds:** Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

**Pooled Separate Accounts:** Valued at the closing NAV of the sub accounts. NAV is quoted on a private market that is not active; however, the unit price is based on underlying investments that are traded on an active market.

**Collective Trusts:** Valued using NAV. NAV is quoted on a private market that is not active; however, the unit price is based on underlying investments that are traded on an active market.

*(See Independent Auditors' Report)*

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 GUARANTEED INVESTMENT CONTRACT**

The Plan has an investment in the Principal Fixed Income Guaranteed Option Account, which is a fully benefit responsive investment contract and, therefore, is reported at contract value. Contract value, as reported to the Plan by the Custodian, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer. Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the Plan Document (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to

qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the Custodian to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, wherein the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan was amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded there were no uncertain tax positions taken as of December 31, 2024.

**NOTE 7 RELATED-PARTY TRANSACTIONS**

The Plan pays investment management, administrative, and custodial fees to parties in interest. The Plan paid approximately \$55,000 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
