Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of RXR Realty 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of RXR Realty 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Other Matter—2023 Financial Statement

The 2023 financial statements of the Plan were audited by Marcum LLP. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 11, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or was derived from the certified investment information, was presented, in all material respects, in conformity with the DOL Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

1. Description of the Plan

The following description of the RXR Realty 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on February 1, 2007, and amended July 25, 2023, for the purpose of providing eligible employees of RXR Realty LLC, its predecessors (the “Employer”) and its related companies that participate in the Plan (collectively, the “Participating Employers”) with an opportunity to increase their savings on a tax-favored basis. The Plan’s investment committee is responsible for Plan oversight and governance.

The Plan is a defined contribution plan sponsored by the Employer covering all eligible employees of the Participating Employers who have completed one month of service, as defined in the Plan agreement, and are age twenty-one or older.

1. Description of the Plan (continued)

Contributions

Participants may elect to contribute up to 50% of their annual cash compensation as defined in the Plan agreement. Unless an employee requests in writing to not participate in the Plan, all eligible employees are automatically enrolled in the Plan with 3% of their annual cash compensation being contributed to a mutual fund designated by the Employer based on expected retirement age. Participant contributions under the Plan may be made from after-tax earnings and/or from before-tax earnings, the latter form of contribution having the effect of reducing the participant's current taxable earnings for federal, state and local income tax purposes. Participants may also rollover amounts representing distributions from other qualified benefit or defined contribution plans. During the years ended December 31, 2024 and 2023, rollovers from other qualifying plans were \$509,469 and \$434,754, respectively, and are included on the accompanying Statements of Changes in Net Assets Available for Benefits. In addition, the Plan permits participants who are at least age 50 before the end of the calendar year to make a catch-up contribution, as provided for under the Employee Retirement Income Security Act of 1974 ("ERISA").

Discretionary matching contributions may be contributed at the option of the Participating Employers. Contributions are subject to certain limitations, as prescribed by ERISA.

The aggregate of a participant's contributions are subject to the limitations of the Internal Revenue Code of 1986, as amended (the "Code").

The Employer makes matching contributions on participant's salary deferrals of up to 3% of the participant's compensation with a maximum amount of \$1,500 on an annual basis. Such matching contributions were \$391,595 and \$431,395 for the years ended December 31, 2024 and 2023, respectively. Pursuant to the terms of the Plan, Participating Employer contributions are forfeited by a participant if a participant fails to meet the Plan's vesting requirements ("Forfeitures"). At December 31, 2024 and 2023, accumulated forfeited non-vested amounts totaled approximately \$27,000 and \$32,000, respectively. Forfeitures may be used by the Participating Employers to offset future Plan expenses and Participating Employers' contributions. For the years ended December 31, 2024 and 2023, the entire available forfeiture balance was utilized as a partial offset against subsequent Participating Employer contributions for each year.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Participating Employer's matching contributions, if any, Plan earnings, and charged with Plan losses, distributions and certain of the Plan's administrative expenses, if not paid by the Participating Employers or with Forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Vesting

Participants are immediately 100% vested in their contributions and earnings thereon. Additionally, a participant is eligible for employer matching contributions, if any, after one year of credited service, which then vests ratably based on five years of credited service.

In July 2023 and in connection with an employee outsourcing, the Plan was amended to provide for such impacted employees to be fully vested in the Plan as of June 21, 2023 and for such employees to be eligible to receive employer matching contributions in advance of their expected payment subsequent to December 31, 2023.

Notes Receivable from Participants

Participants may generally borrow from their accounts up to 50% of their vested account balance, subject to a minimum of \$1,000 and a maximum of \$50,000. The loans are secured by the balance in the participant's account and bear interest at the U.S. prime lending rate plus 1% determined at time of origination. Participant loan terms, when originated, can range up to five years or thirty years for the purchase of a primary residence. Additionally, participant loans are serviced through payroll deductions or direct payment from the participant.

Payment of Benefits

On termination of service, a participant may elect to (i) receive a lump-sum amount equal to the value of their vested interest or (ii) leave their vested interest in the Plan. Notwithstanding, if at the time of termination, the value of the terminated employee's vested account balance is below certain thresholds, as defined in the Plan, the Employer may force a distribution. Benefits are recorded when paid.

Hardship Withdrawals

The Plan provides for hardship withdrawals, as set forth in accordance with applicable sections of the Code, not to exceed a participant's actual contributions to the Plan and must result from an immediate and heavy financial need of the participant that cannot be satisfied from other financial resources, as determined on a non-discriminatory basis by the plan administrator.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

utilizing information provided by the investment advisor, PNC Bank, National Association and custodial entities, Newport Trust Company, (“Newport Trust”) and Ascensus, LLC, (“Ascensus”). See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation/(depreciation) in fair value of investments on the accompanying Statements of Changes in Net Assets Available for Benefits includes realized and unrealized gains and losses net of dividends declared and reinvested on investments bought and sold as well as those investments held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities as of the date of these financial statements. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation (or compensation is earned).

Administrative Expenses

Certain expenses of maintaining the Plan may be paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net realized and unrealized appreciation in fair value of investments.

Benefit Payments

Benefits are recorded when paid.

Notes to Financial Statements (continued)

3. Fair Value Measurements

Accounting Standards Codification (“ASC”) 820, “Fair Value Measurements”, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels of inputs as described below. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Level 1 (highest priority)

Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets
- Quoted prices for identical or similar assets in inactive markets
- Inputs other than quoted prices that are observable for the asset
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 (lowest priority)

Inputs to the valuation methodology are unobservable but are significant to the fair value measurement.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions are the Employer’s valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Notes to Financial Statements (continued)

3. Fair Value Measurements (continued)

Investments measured at net asset value: Consisting of common/collective trusts, valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Interest-bearing Cash: These investments are stated at cost, which approximates fair value.

4. Information Certified by the Plan's Custodians

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Prior to April 2022, PNC Financial Services Group, Inc. served as custodian of the plan. Such services were assumed by Newport Trust in April 2022. Additionally, in April 2022, Newport Trust merged with Ascensus. In June 2023, the Newport Trust custodial platform used for the plan was transitioned to the Ascensus platform. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, interest and dividends on investments and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus or Newport Trust, as applicable, for the year ended December 31, 2024 and 2023, respectively. This information has not been audited by the Plan's independent auditors.

5. Party-In-Interest Transactions

Transactions through the following Plan investments qualify as parties-in-interest:

At both December 31, 2024 and 2023, the Plan's assets included notes receivable from participants, who are considered parties-in-interest. Additionally, certain administrative functions of the Plan are performed by officers and employees of the Employer. No officer or employee receives compensation from the Plan.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Two investments represent approximately 30% of net assets available for benefits (see Schedule H).

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Employer contributions.

8. Income Tax Status

The underlying non-standardized prototype plan, from which the Plan is based, has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the Code. As such, the Plan's sponsor has determined that it is eligible to, and has chosen to rely on, the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan's administrator believes the Plan is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
