The following description of the Coast Professional, Inc. Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of Coast Professional, Inc., (the "Company") as determined by the provisions of the Plan adoption agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### **Administration**

The Company is the sponsor and administrator of the Plan. The President and Chief Financial Officer of the Company is the trustee of the Plan. Transamerica Trust Company (TTC) is the custodian of the Plan. Transamerica Financial Life Insurance Company (Transamerica) is the recordkeeper, and Ascensus Trust Company (Ascensus) is the third-party administrator of the Plan.

#### **Eligibility**

Individuals become eligible to participate in the Plan on the first day of the Plan quarter following the period in which they obtain two months of service and reach age 18, as defined in the Plan document. Employees must have one year of service in order to be eligible for employer contributions.

#### **Contributions**

The Plan allows participants to contribute an amount up to 100% of their annual compensation subject to certain contribution limitations under Section 401(k) and Section 415 of the Internal Revenue Code (IRC). Participants who have reached the age of 50 may elect to defer additional amounts to the Plan.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Employees enrolled as a result of this provision must defer at least 3% of their compensation to the Plan. Participants can change their contribution amount at any time.

The Company makes discretionary matching contributions on behalf of the Plan's participants. The Company match is based on the participant's eligible compensation, not to exceed 3% of the participant's compensation. The Company may, at its sole discretion, also make annual discretionary profit-sharing contributions to the Plan. There were no profit-sharing contributions made in 2024 or 2023.

#### **Participant Accounts**

Participants direct the investment of all contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of investment earnings or losses, and is reduced by benefit payments and an allocation of administrative expenses.

## 1. DESCRIPTION OF PLAN (Continued)

### **Participant Accounts (Continued)**

Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are fully vested in their elective deferrals, rollover contributions, and any earnings thereon. Contributions made through the employer match and discretionary profit-sharing contributions vest 20% each year and become 100% vested after five years of service.

### **Administrative Expenses**

Administrative expenses include investment management fees, operating expenses, and transaction fees.

### **Payment of Benefits**

Upon termination of service, a participant may only elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Vested account balances of \$5,000 or less are paid as lump sum distributions immediately in cash from the Plan. No early retirement provisions are provided or permitted by the Plan. Hardship distributions are permitted under Plan provisions and in-service distributions are also available for participants who have reached 59 ½ years of age from all contribution accounts that are fully vested.

### **Forfeitures**

Forfeitures of non-vested account balances are used to reduce future employer contributions or offset administrative expenses. Unused amounts are held and invested in a segregated account within the Plan. In 2024 and 2023, there were forfeitures of non-vested account balances and earnings on unused amounts totaling \$96,704 and \$72,426, respectively. At December 31, 2024 and 2023, there was \$314,621 and \$240,797, respectively, available to reduce future employer contributions or pay administrative expenses. In 2024 and 2023, forfeitures of \$22,880 and \$17,515, respectively, were used to offset administrative expenses.

### **Plan Termination**

Although they have not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America.

### **Investments and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Fair Value Measurements**

The Plan uses various valuation techniques in determining fair value. *Financial Accounting Standards Board Accounting Standards Codification 820 (ASC 820)* establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available.

The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to participant contributions.

### **Benefit Payments**

Benefit payments are recorded when paid.

### **Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying financial statements.

### **Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

(a) In accordance with Subtopic 820-10, certain investments that were measured at net asset value ("NAV") per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* valued based on quoted market prices in active markets.

*Common collective trust:* valued using the net asset value, based on the value of the underlying investments held at year end, divided by the number of units outstanding. The unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments which are primarily based on quoted market prices.

#### **4. FAIR VALUE MEASUREMENTS (Continued)**

The overall investment objective of these investments varies from stability of current income to growth. These investments do not have any unfunded commitments. The Plan can redeem these investments daily. There are currently no redemption restrictions on these investments.

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

#### **5. PARTY-IN-INTEREST TRANSACTIONS**

TTC is the custodian of the Plan; Transamerica is the recordkeeper of the Plan; and Ascensus is the third-party administrator of the Plan. Administrative fees were paid to these entities involved with the Plan for the investment management, recordkeeping services, and administrative services, and these expenses qualify as exempt party-in-interest transactions.

#### **6. TAX STATUS**

The Plan adopted a pre-approved plan offered by Ascensus LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **7. RECONCILIATION TO FORM 5500**

While net assets available for benefits and change in net assets available for benefits agree between the financial statements and Form 5500 in total as of and for the years ended December 31, 2024 and 2023, certain classifications differ between the financial statements and Form 5500.

#### **8. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.
