**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Benchmark Digital Partners, LLC (the “Company”) 401(k) and Profit Sharing Plan (the “Plan”) provides only general information. For a more complete description of the Plan’s provisions, refer to the agreement governing the Plan (the “Plan Agreement”).

General

The Plan is a defined contribution plan covering all employees (except excluded classes) of the Company who have completed thirty days of service. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974, as amended. Enrollment in the plan is allowed on the first day of the month coinciding with or next following the date the employee becomes eligible to participate.

Contributions

Participants may elect to contribute a specific percentage or dollar amount of compensation on a pre-tax or after-tax Roth deferral basis, as defined in the Plan Agreement, up to the total annual deferral limit set by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. The Company made a safe harbor matching contribution of 100% up to the first 3% of salary deferral plus 50% up to an additional 2% of salary deferral. Effective May 24, 2020, the Plan was amended and suspended employer safe harbor contributions to the Plan. Employer safe harbor contributions were reinstated effective January 1, 2021. Additional matching contributions may also be made at the discretion of the Company’s management. Participants direct the investment of all contributions among various investment options offered by the Plan.

Participant Accounts

Participant accounts are valued on a daily basis based on quoted market prices. Each account is credited with the participant’s contributions, the Company’s matching contributions, and allocations of net investment earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Employee Investment Options

Upon enrollment in the Plan, participants may direct contributions among investment choices offered by the Plan. Participants may change their investment options on any business day. There are no non-participant-directed investments in the Plan. All investments are allocated based upon the participants’ elections.

Vesting

Participants are immediately vested in their contributions, including rollovers, plus actual earnings thereon. Participants are also immediately vested in the Company’s safe harbor matching contributions plus actual earnings thereon. Discretionary Company contributions vest on a 3-year cliff schedule based on years of continuous service, with 100% vested after three years of service. Prior to the third year of service, the vesting percentage is zero.

Notes Receivable from Participants

The Plan permits participants to borrow from their fund accounts up to the maximum established by IRS regulations, generally \$50,000 or 50% of their vested account balance, whichever is less. Loans are secured by the balance in the participant's account and bear interest at the prime interest rate. Principal and interest is paid ratably through payroll deductions over a period not exceeding five years, unless the loan is for purchase of a principal residence, in which case repayment may be extended to a period commensurate with commercial lenders.

Payment of Benefits

Distribution benefits are generally payable in the form of either a lump sum amount equal to the value of the participant's vested account balance, or as partial withdrawals according to current laws concerning required distributions. Distributions are allowable in the event of retirement, disability, death, qualified reservist leave, or other employment severance. Hardship distributions and in-service distributions are allowed as defined by the Plan Agreement

Forfeited Accounts

Upon termination of employment, participants forfeit their non-vested balances. Forfeited funds may be used by the plan sponsor to pay Plan administrative expenses or reduce future Company contributions. Unallocated forfeiture balances were \$0 as of December 31, 2024 and 2023.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Presentation

The accompanying financial statements have been prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 11 for a discussion of fair value measurements.

The net appreciation or depreciation in the fair value of investments is reflected in the Statements of Changes in Net Assets Available for Benefits and includes realized gains and losses on investments bought and sold and the change in appreciation from one period to the next. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Acquisition costs are included in the cost of investments purchased and sales are recorded net of selling expenses.

Fully Benefit Responsive Investment Contract

The John Hancock Stable Value Fund is a stable value fund that is a non-tradable obligation of John Hancock Life Insurance Company (U.S.A.) ("John Hancock USA"). Thus, the fund cannot or will not assign or sell the contract or its proceeds to another party without the consent of John Hancock USA. This investment seeks to protect against any loss of principal while providing returns in excess of money market funds and one-year U.S. Treasury bills. All deposits are credited with the same interest rate on a daily basis and with no set maturity. For deposit liabilities with no defined maturities, the fair value to be disclosed is the amount payable on demand at the reporting date.

The repayment of principle and interest credited to participants in the fund is a financial obligation of John Hancock USA. However, if an event should ever occur such that realization of full contract value for a particular investment contract is no longer probable (for example, a significant decline in creditworthiness of John Hancock USA), the stable value fund may no longer be considered fully benefit-responsive.

Terms of the contract require all permitted participant-initiated transactions with the fund to occur at contract value with no conditions, limits, or restrictions. Permitted participant-initiated transactions are those allowed by the Plan, such as withdrawals for benefits, loans, or transfers to other funds within the Plan. Fair value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and those changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Market conditions may result in an unusually high degree of volatility and increase the risks and short-term liquidity associated with certain investments held by the Plan, which could impact the value of investments after the date of these financial statements.

Administration Costs

The Company absorbs significant costs of Plan administration related to legal, accounting, recordkeeping, and general administration. Investment advisory fees and other expenses related to the administration of the Plan are paid either by the Plan, the Company, or the participants.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Participant loans are classified as loans receivable for GAAP purposes and measured at the unpaid principal plus accrued but unpaid interest, when such interest is material.

New Act

On December 23, 2022 Congress pass the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, which varying effective dates through 2027. The most significant changes impacting existing plan provisions included updates to required minimum distributions (RMDs) and hardship distribution rules, expanded eligibility of part-time employees, modifications to catch-up contribution rules and options for the plan sponsor to make matching contributions to an employee's retirement account based on employee's student loan payment. SECURE Act 2.0 amendments must be adopted by December 31, 2025, for calendar year plans. Plan documents are to be updated in accordance with the provisions of SECURE Act 2.0.

**NOTE 3 – INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has a group annuity investment contract with John Hancock USA. The John Hancock Stable Value Fund is an investment option of the investment contract. John Hancock USA maintains the investments in a pooled separate account with options stated at fair value as reported to the Plan by John Hancock USA, based on the quoted market prices of the underlying mutual funds. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

**NOTE 4 – INVESTMENTS**

The Plan's investments (including interest, dividends, and gains and losses on investments bought and sold, as well as held during the year) increased in value by \$2,428,027 and \$2,009,819 during the years ended December 31, 2024 and 2023, respectively.

**NOTE 5 – RECORDKEEPING AND CUSTODIAN AGREEMENTS**

Record keeping services are performed by Trinity Pension Consultants, Inc. and trustee services are performed by John Hancock Life Insurance Company.

**NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS**

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Certain Plan investments are shares of various mutual funds which are managed by John Hancock Life Insurance Company, who has been designated as the trustee. Fees and commissions paid from Plan assets totaled \$103,624 and \$83,461 during the years ended December 31, 2024 and 2023, respectively. In addition, the Company provides certain accounting and administrative services to the Plan for which no fees are charged.

**NOTE 7 – TAX STATUS**

The Plan has adopted a standardized form of a prototype plan offered by John Hancock Retirement Plan Services, who has represented that the prototype plan qualifies under Section 401(a) of the Internal Revenue Code. The Plan has not received a determination letter specific to the Plan itself. However, the Plan administrator believes the Plan was designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 8 – PLAN AMENDMENTS**

The Plan may be amended and restated as necessary to comply with recent legislative actions or allowable sponsor elections. The plan was amended effective May 24, 2020, and was no longer a safe harbor plan offering an employer match. The plan was amended effective January 1, 2021, and the safe harbor plan was reinstated along with the employer match.

The plan was amended effective January 1, 2021, to change the Plan name to Benchmark Digital Partners, LLC 401(k) and Profit Sharing Plan.

**NOTE 9 – UNAUDITED INFORMATION CERTIFIED BY TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company, the trustee of the Plan, has certified as to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, Note 4, and the supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023. Accordingly, as permitted under this election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this information, except for comparing such information to the information included in the Plan's financial statements and supplemental schedule.

**NOTE 10 – FAIR VALUE MEASUREMENTS**

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1    Inputs to the valuation methodology are based on quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2    Inputs to the valuation methodology are based on quoted prices in markets that are not active or for which significant inputs are observable either directly or indirectly.
- Level 3    Inputs to the valuation methodology are based on inputs that are unobservable and significant to the overall fair value measurement.

When available, quoted market prices are used to determine the fair value of investments held in the Plan, and such items are classified within Level 1 of the fair value hierarchy. The level to which an asset or liability is classified is based upon the lowest level of input that is significant to the fair value measurements.

The following is a description of the valuation methodologies used for instruments measured at fair value, as well as general classifications of such instruments pursuant to the valuation hierarchy. There has been no changes in methodologies at December 31, 2024 and 2023.

*Mutual funds:* These investments are valued at the daily closing price as reported by the fund. They are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. These investments are classified as Level 1.

*Stable value funds:* Investments in a pooled separate account with options stated at fair value based on quoted market prices of the underlying mutual funds. The underlying funds are required to publish their daily net asset value and to transact at that price. These investments are classified as Level 1.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
