Independent Auditors' Report

Opinion

We have audited the financial statements of The Associates Health Trust Employee Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE 1. DESCRIPTION OF PLAN

The following description of The Associates Health Trust Employee Benefit Plan (the "Plan") provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

- A. Benefits – The Plan provides health benefits (medical and dental) to all eligible employees and their dependents, if elected, of Swagelok Company and certain related companies (the "Company"). Medical and dental benefits are provided based on the participants' annual election through a self-funded arrangement. Self-funded claims are paid through a third party administrator.
- B. Contributions – The Company makes periodic contributions to the Plan to provide for benefits and expenses payable thereunder. Participants contribute according to rates established by management which relate to benefit coverages elected by the participants for themselves and their dependents.
- C. Plan Termination – Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. No amendment of the Plan shall adversely affect benefits payable to a participant or dependent thereon. Further, no amendment of the Plan may be made which permits any part of the trust fund to be used for or diverted to purposes other than for the exclusive benefit of the participants and their dependents.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting:

The accompanying financial statements have been prepared on the accrual basis and in accordance with accounting principles generally accepted in the United States of America.

Subsequent events:

The Company has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

Money market funds:

The Plan considers all highly liquid debt instruments purchased with an initial maturity of three months or less to be cash equivalents. The Plan maintains cash and equivalents at a financial institution which exceed federally insured amounts at times and which may, at times, significantly exceed balance sheet amounts due to outstanding checks.

Investment valuation and income recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Money market funds consist of a short-term investment fund that maintains daily liquidity and has a constant unit value of \$1.00.

NOTE 2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Investment valuation and income recognition (Continued):

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative expenses:

All expenses of the Plan are paid by the Plan, or the Company, at the Company's discretion.

Benefits to participants:

All benefits of the Plan are recorded when paid.

Estimated health claims:

Estimated health claims incurred but not reported ("IBNR") are determined by the Company with the assistance of the Plan's actuary and are based on the Company's historical claims payments and actual claims incurred prior to the end of the Plan year but not paid until after the year in which the claim was incurred.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, estimated IBNR claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Commitments and contingencies:

During 2020, a legal claim was filed against the Plan, Company and plan administrator and it is being vigorously defended. The ultimate disposition is unknown at this time, but Plan management does not believe any impact will be material to the Plan.

NOTE 3. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board established a framework for measuring fair value that prioritizes the inputs and defines valuation techniques used to measure fair value. A summary of financial assets that were measured at fair value at December 31, 2024 and 2023 is as follows:

NOTE 4. FEDERAL INCOME TAX STATUS

The Plan's underlying trust is intended to be exempt from federal income taxes under Section 501(c)(9) of the Internal Revenue Code (the "IRC"). Internal Revenue Service regulations under IRC Section 512(a)(3)(E)(i) specify that net investment income earned by a voluntary employees' beneficiary association is taxable as unrelated business income. Accordingly, net investment income earned by the trust is generally subject to federal income taxes. Unrelated business income tax for the years ended December 31, 2024 and 2023 is included in administrative fees on the statements of changes in net assets available for benefits and was not material to these financial statements. The Company believes that the trust, as amended, continues to qualify and operate in accordance with applicable provisions of the IRC.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that the Plan does not have any significant unrecognized tax benefits as of December 31, 2024.

NOTE 5. PLAN BENEFIT OBLIGATIONS

Plan benefit obligations at December 31, 2024 and 2023, for the health claims incurred by active participants but not reported at that date, are estimated by the Plan's actuary in accordance with accepted actuarial principles, under which historical claim data is recorded by period incurred and period paid, and a development pattern is used to estimate the future existing claims as of the valuation date. Such estimated amounts are reported in the Plan's benefit obligations. Health claims incurred by participants but not reported at year end are included in the amounts currently payable.

NOTE 8. SUBSEQUENT EVENT

In August 2025, the Company approved the termination of the VEBA trust currently used to fund the Plan. The remaining assets in the trust will be used for the exclusive benefit of the participants and their dependents. Subsequent to the termination of the trust, which is expected to happen in 2025, benefits under the Plan will be funded directly by the Swagelok Company.
