Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of New York City Mission Society 403(b) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

December 31, 2023 and 2022

Note 1: Description of the Plan

General

The following description of New York City Mission Society 403(b) Plan (the Plan) set forth herein is provided for general information purposes only. Participants should refer to the plan document for more complete information.

The Plan is a defined contribution plan sponsored by New York City Mission Society (the Employer or Sponsor) for the benefit of its employees. Employees become eligible to participate in the Plan, with respect to making elective deferrals, beginning on the date of hire. To be eligible for employer contributions under the Plan, employees must be 21 years of age and have three months of service with no fewer than 20 hours per week.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. Effective November 2022, the Plan was amended to implement provisions of *Coronavirus Aid, Relief, and Economic Security Act* (CARES Act). Ascensus, LLC serves as Plan Trustee.

Contributions

Employees are able to contribute to the Plan up 100% of eligible compensation through a salary deferral election. Once an employee reaches the age of 50 before the end of any calendar year, they may defer extra catch-up contributions into the Plan as a pre-tax and/or Roth contribution once they meet certain plan limits. The Plan allows for special code Section 403(b) catch-up contributions for those participants with 15 years of service.

Employer may make discretionary contributions to the Plan based on a percentage of the employee's eligible compensation. Effective January 1, 2023, the Plan was amended to a safe harbor plan with a 5% contribution by the Employer.

Contributions are subject to certain limitations. Employee rollover contributions are also permitted.

Participant Investment Account Options

Investment account options available consist of mutual funds. Each participant has the option of directing contributions into any of the investment account options selected by the Employer and may change the allocation to the extent permitted by the individual agreements.

Participant Accounts

Each participant's account is credited with participant contributions and the employer contributions, if any, and an allocation of net plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Employees are vested in Employer's contribution portion of their accounts plus earnings after a year of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum amount which is equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum amount of a loan shall be \$1,000. The loans are secured by the balance in the participant's account. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on prime rate of interest as specified in the Wall Street Journal.

Payment of Benefits

Under the terms of the Plan, participants are eligible for normal retirement upon reaching age 65. Payments of benefits shall be in the form of a lump-sum distribution or annuity contract. The distribution method is selected by the participant upon reaching normal retirement age. The amount of benefits is based upon the employee's vested amount included in his/her participant account.

Forfeited Accounts

If a participant's employment terminates for reasons other than retirement, disability, or death, the unvested portion of his/her account is forfeited either when the vested portion of his/her account is distributed or in other limited circumstances. Forfeitures shall be placed in suspense account and will be applied to reduce employer contributions or pay for expenses. There were \$3,751 and \$2,218 of forfeitures including investment earnings for the years ended December 31, 2023 and 2022, respectively. Forfeiture balances were \$3,751 and \$0 as of December 31, 2023 and 2022, respectively.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan does not have any investments which are considered fully benefit-responsive investment contracts.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. As applicable, interest income is recorded on the accrual basis, and dividend income is accrued on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Employer or the Plan, at the Sponsor's discretion.

Note 3: Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC as an agent for Ascensus Trust Company and Newport Trust Company, LLC, qualified institutions, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4: Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Administrative expenses consist mainly of contract administrator fees paid to Ascensus LLC were \$8,637 and \$7,718 for the years ended December 31, 2023 and 2022, respectively.

The Sponsor provides certain administrative services at no cost to the Plan.

Note 5: Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Such securities are classified in Level 2 of the valuation hierarchy. The Plan held no investments classified in Level 2 or Level 3 at December 31, 2023 and 2022.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
