## INDEPENDENT AUDITOR'S REPORT

To the Trustees and Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Dakota Eye 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Dakota Eye 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**NOTE 1 PLAN DESCRIPTION**

The following description of the Dakota Eye 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established January 1, 1990 and was most recently restated as of December 5, 2022.

The Plan is administered by the employer – Dakota Eye Institute, PC (the Company) and covers the employees of Dakota Eye Institute, P.C. as well as Dakota Surgery & Laser Center, LLC and DEI Optical Company. Empower Annuity Insurance Company of America and Empower Trust Company, LLC serve as the provider and trustee of the Plan holding the Plan assets, while Empower Retirement serves as the recordkeeper of the Plan and maintains the records of the participant data.

Morgan Stanley Smith Barney, LLC serves as the Plan's ERISA section 3(38) investment manager.

**Eligibility**

Substantially all employees who have attained age 21 are eligible to participate in the Plan. To receive employer contributions, an employee must complete one year of service and have 1,000 hours of service during the eligibility computation period. Employees may enroll in the Plan the first day of the month coinciding with or next following the date on which the eligibility requirements are met.

**Contributions**

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals.

The Plan allows for discretionary employer contributions. These contributions are allocated to each employee based on a percentage of that participant's total eligible compensation for each pay period. Employer contributions for the years ended December 31, 2024 and 2023 were a 2% matching contribution and a 6% profit sharing contribution based on eligible compensation.

Participants may make rollover contributions for amounts representing distributions from other qualified defined benefit plans, defined contribution plans, or individual retirement accounts.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Company's matching and profit-sharing contributions, if any. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions, Company discretionary matching and profit-sharing contributions, if any, to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options throughout the year by contacting Empower Retirement.

**Vesting**

Participants are always 100% vested in their elective deferral contributions and earnings thereon. Participants are fully vested in employer contributions after six years of credited service.

**Payment of Benefits**

Upon termination of employment, death, disability or retirement, a participant with a vested account balance of more than \$7,000 can receive a lump sum payment or installment payments equal to the value of the participant's vested interest. Distribution of benefits upon termination become automatic if the participant's account balance is less than \$7,000. Hardship distributions and in-service distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 1/2 or become disabled to qualify for in-service distributions. Distributions are also allowed from rollover accounts at any time. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest rates of Wall Street Journal prime plus 1%. The term of the loan cannot exceed five years, unless it is for the purchase of a principal residence, which must be repaid within ten years. Principal and interest are paid ratably through payroll deductions. A participant may only have two loans outstanding at any time.

**Forfeitures**

Forfeitures may be used to either reduce future employer contributions or pay plan expenses. Current year forfeitures must be applied by the end of the following Plan year or they will be reallocated as additional contributions to all eligible participants based on the eligible participants' year-end vested balances.

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$23,859 and \$713, respectively. During the year ended December 31, 2024 and 2023, \$144,364 and \$40,781 of forfeitures were used to reduce employer contributions, respectively. During the years ended December 31, 2024 and 2023, \$0 and \$3,826 of forfeitures were used to pay plan expenses, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully-benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the providers of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held and transferred during the year and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefit distributions are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**NOTE 4 FAIR VALUE MEASUREMENT**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Great-West Trust Company. The non-standardized pre-approved plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service as to the Plan's qualified status. The opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 6 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

In 2018, the plan entered into a group fixed deferred annuity contract (Group Annuity Contract) with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in one or more separate accounts. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The group annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value, (which represents contributions made under the contract, plus earnings, less withdrawals and administrative expense), because it is fully

benefit responsive. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Empower Annuity Insurance Company of America owns the underlying assets of the group annuity contract in its general account. The Plan owns the group annuity contract for the benefit of its participants. The group annuity contract is backed by the full faith and creditworthiness of the issuer. Guarantees are based on the claims-paying ability of Empower and not the value of the securities within the issuer's general account. The long-term credit rating of the issuer at both December 31, 2024 and 2023 was "aa" as reported by A.M. Best.

The general fixed account held at Empower had a contract value of \$340,208 and \$667,003 at December 31, 2024 and 2023, respectively. Interest earned on the general account during the years ended December 31, 2024 and 2023 was \$5,538 and \$14,824, respectively.

Certain events might limit the ability of the Plan to transact at the contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

The contract permits the insurance company to terminate the agreement with 60 days advanced written notice.

**NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Empower Retirement, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, are the recordkeeper, provider, and trustee, respectively, as defined by the Plan. The group annuity contract held during this period is an investment contract between the Plan and Empower Annuity Insurance Company of America. Therefore, these transactions qualify as party-in-interest transactions. During the years ended December 31, 2024 and 2023, \$30,264 and \$28,533 of fees were paid for these services, respectively.

Morgan Stanley Smith Barney (Morgan Stanley) provides 3(38) investment management services for the Plan. During the years ended December 31, 2024 and 2023, the Plan paid investment management fees to Morgan Stanley of \$42,851 and \$27,386 respectively.

Empower Retirement also collects 12b-1 fees, commissions, and certain other fees payable by the Plan's investment options. When Empower collects these fees, commissions, and certain other fees, they are remitted to the trust in order to offset plan expenses as allocated to participant's accounts who were invested in those revenue receiving funds. Any funds received in excess of the respective Plan expenses related to those revenue sharing accounts are allocated back to participants as income. The paying agent is typically able to remit these fees to the Trust monthly. The amount of 12b-1 fees collected during the years ended December 31, 2024 and 2023 totaled \$65,233 and \$32,909, respectively.

**NOTE 8 AMENDMENT AND TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

**NOTE 9 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through September 26, 2025, which is the date these financial statements were available to be issued.
