### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We have performed audits of the financial statements of the Blue Bell Creameries, Inc. 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## NOTES TO FINANCIAL STATEMENTS

### 1. Description of Plan

The following brief description of Blue Bell Creameries, Inc. (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for more complete information.

#### General

The Plan is a defined contribution plan covering substantially all employees of the Company. Only those employees who are twenty-one years of age and have completed six months of service may participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### Administration

The Plan is administered by the Company and accordingly, certain administrative functions are performed by officers or employees of the Company. No officers or employees receive compensation from the Plan. Fidelity Management Trust Company (the "Trustee") serves as the Plan's Trustee and recordkeeper.

#### Employee Contributions

Each year, participants may contribute from 1% to 60% of their pretax annual compensation not to exceed the limitation (\$23,000 in 2024 and \$22,500 in 2023) set forth in Section 402(g) of the Internal Revenue Code ("IRC"). Effective July 1, 2019, participants may designate a portion or all of such contribution as a Roth contribution. Participants may make catch-up contributions, pre-tax contributions that exceed the annual elective deferral limit, during any calendar year ending on or after the participant's 50<sup>th</sup> birthday. Participants' total catch-up contributions are limited to a maximum of \$7,500 in 2024 and 2023. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### Employer Contributions

The Company may make discretionary matching contributions equal to a percentage of the participant's contribution, not to exceed 50% of the first 4% of each participant's compensation contributed as elective deferrals for the Plan year. Such discretionary matching contribution amounts are determined each year by the Company. During the years ended December 31, 2024 and 2023, the Company matched 50% of the first 4% of each participant's compensation contributed totaling \$3,079,219 and \$2,588,423, respectively.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' accounts in that fund. Upon the occurrence of a distribution event, the benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after 3 years of service. A participant qualifies for a vested year by completing 1,000 hours of service during the Plan year.

### 1. Description of Plan (continued)

#### Notes Receivable from Participants

Active participants in the Plan may obtain loans from the Plan. The loans must be at least \$1,000 and may range up to a maximum amount of the lesser of (a) \$50,000 minus the participant's highest outstanding loan amount during the prior 12 months, or (b) 50% of the participant's vested account balance. Loans bear interest at a fixed rate, as determined by the Plan administrator. Interest rates are based on the Prime Rate published in the Wall Street Journal. Loan terms range from one to five years unless used for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account. Repayments on the loan must be made quarterly, on an after-tax basis, in level payments of principal and interest. Participant loans outstanding as of December 31, 2024 and 2023 bore interest at rates ranging from 3.25% to 8.50%.

#### Payment of Benefits

Benefit payments are typically made in a lump-sum distribution to the participant upon termination of employment (or to the beneficiary in the event of death). In addition, participants are permitted in-service distributions from the vested portion of their Plan account at any time after having attained age 59 ½. Also, subject to guidelines set forth in the IRC, an employee may request a hardship withdrawal of all or any portion of his or her contribution account. Employer matching and profit-sharing account balances can be withdrawn only if the participant is age 55, has 5 years of participation in the plan and is 100% vested.

#### Forfeited Accounts

All employer contributions credited to a participant's account, but not vested, are forfeited by the participant (or his or her beneficiary in the event of death) upon distribution of the full vested value of his or her account.

Forfeitures may be used to pay administrative expenses under the Plan and/or reduce employer contributions. During 2024 and 2023, forfeited non-vested amounts of \$207,274 and \$0, respectively, were used to reduce employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,918 and \$43,868, respectively.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Use of Estimates

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from these estimates.

### 2. Summary of Significant Accounting Policies (continued)

#### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market risks, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value investments.

The Plan presents in the Statements of Changes in Net Assets Available for Benefits the net appreciation in the fair value of its investments, which consists of realized gains and losses on investments sold during the year and unrealized appreciation of investments held at the end of the year. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make note repayments and the Plan administrator deems a participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

#### Benefit Payments

Benefits are recorded when paid.

### 3. Fair Value Measurements

The Financial Accounting Standards Board Accounting Standards Codification Topic 820 ("ASC 820") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and not corroborated by market data and significant to the fair value measurement.

### 3. Fair Value Measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

In determining fair value, the Plan uses the market approach, which uses prices and other relevant data based on market transactions involving identical or comparable assets and liabilities.

Following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan administrator believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024 and 2023, the Plan's investments consist entirely of mutual funds. These investments are valued at quoted prices in active markets and are therefore classified as Level 1 fair value measurements.

### 4. Information Certified by the Trustee (Unaudited)

The Plan administrator has elected the method of annual reporting and compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income for notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 5. Federal Income Tax Status

The Plan adopted by the Company is a non-standardized pre-approved profit sharing plan that is designed to comply with provisions of the IRC's Economic Growth and Tax Reconciliation Act of 2001 ("EGTRRA"). Such non-standardized plans are pre-approved by the IRS by reference to the Cumulative List of Changes in Plan Qualification Requirements (the "Cumulative List") provided under EGTRRA. Because the Plan is a non-standardized pre-approved plan, the Company is not authorized to amend the Plan except to comply with changes in the Cumulative List. The non-standardized pre-approved plan received a favorable determination letter from the IRS on June 30, 2020. Although the Plan has been amended since the date of the determination letter, management of the Company and the Plan administrator believe the Plan complies with and is being operated in accordance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their total account balance.

**7. Party-in-Interest Transactions**

Certain Plan investments are in accounts managed by the Trustee and the Plan issues notes receivable from participants. These transactions qualify as party-in-interest transactions, as defined by ERISA. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

**8. Subsequent Events**

Plan management has evaluated all subsequent events through October 8, 2025, which is the date the financial statements were issued, and has concluded that there are no significant events to be reported.
