Basis for Opinion

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

A. Description of Plan

The following description of Paradowski Creative 401(k) Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan is a defined contribution plan covering all full-time employees of Woodruff Communications St. Louis, LLC dba Paradowski Creative and Nemo Pictures, LLC dba Bazillion Pictures (the Company) who have one month of service and are aged twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan.

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter. Accordingly, there is no material impact on the Plan's financial statements.

2. Contributions to the Plan

Each year, the Company will contribute to the Plan the following amounts:

- (a) Elective Deferral Contributions – The total amount of the salary reduction elected to defer by employees. The maximum contribution per employee is \$23,000 and the maximum catch-up additional deferral is \$7,500 for calendar year 2024. Total deferrals for the Plan years ending December 31, 2024 and 2023, was \$538,970 and \$707,450, respectively.
- (b) Discretionary Matching Contributions – The employer will determine at its sole discretion how much, if any, it will make as a matching contribution. The amount will be allocated as a uniform percentage of eligible contributions. All salary deferrals, including any Roth deferrals and catch-up contributions, are eligible for the matching contributions. Total matches for the Plan years ending December 31, 2024 and 2023, were \$213,972 and \$270,286, respectively.

In order to be eligible for discretionary matching contributions, you must have attained 21 years of age and completed one month of service. There are no allocation conditions that apply in order for participants to receive an allocation of the discretionary matching contribution.

- (c) Discretionary Employer Contributions – A separate discretionary employer contribution may be made to each participant. There were no discretionary employer contributions for the Plan years ending December 31, 2024 and 2023.

In order to be eligible for discretionary employer contributions, you must have attained 21 years of age and completed one month of service. There are no allocation conditions that apply in order for participants to receive an allocation of the discretionary employer contribution.

3. Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. During the years ended December 31, 2024 and 2023, forfeited nonvested accounts totaled \$61,560 and \$47,248, respectively.

3. Forfeitures (Concluded)

Forfeitures can be used to reduce employer contributions to the Plan, Plan expenses, or "allocated" or divided among participants eligible to share for a Plan year. Employer contributions were reduced by \$7,383 and \$5,590 for the years ended December 31, 2024 and 2023, respectively. Additionally, Plan fees were reduced by \$33,387 and \$33,144 during the years ended December 31, 2024 and 2023, respectively.

4. Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Employees vest 20 percent per year after completing two years of service until becoming 100 percent vested after six years of credited service in accordance with the Plan document, or immediately if employment is terminated due to death, disability, or retirement upon attainment of the age of 65.

5. Payment of Benefits

On termination of service due to death, disability, or retirement, a participant can elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various forms of annuities, as provided in the Plan document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

6. Year of Service and Hours of Service

Employees will have completed one year of service for vesting purposes if they are credited with 1,000 hours of service during a Plan year, even if they were not employed on the first or last day of the Plan year.

7. Notes Receivable from Participants

The Plan permits participants to borrow a minimum of \$1,000 up to 50 percent of their vested account balance not to exceed \$50,000. The notes are secured by the balance in the participants' accounts and bear interest at 1% above the prime interest rate. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within five years. Participant notes receivable are valued at their outstanding principal balance plus accrued and unpaid interest. As of December 31, 2024 and 2023, the Plan had outstanding notes to participants with principal balances totaling \$82,541 and \$51,005, respectively.

8. Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, Plan earnings, and charged with an allocation of investment gains or losses, withdrawals, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

B. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions

Contributions from employees are recorded as they are withheld from participants' wages.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed any excess contributions to the applicable participants.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Plan Expenses

The Plan sponsor absorbs significant costs of the Plan administration. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

C. Certified Investment Information

The Plan's investment options were managed by Charles Schwab Trust Bank, the custodian and managing agent of the Plan, for the years ended December 31, 2024 and 2023. The following information included in the accompanying financial statements and ERISA-required supplemental schedule was obtained from data that has been prepared and certified as to complete and accurate by the custodians as of and for years ended December 31, 2024 and 2023.

Investments, including notes receivable from participants, at fair value as of December 31, 2024 and 2023, were \$7,250,398 and \$6,941,276, respectively.

The Plan's investments (including investments bought, sold, and held during the year) appreciated (depreciated) in value by \$826,152 and \$1,017,979 during the Plan years ending December 31, 2024 and 2023, respectively.

Dividend income reported by the managing agent totaled \$160,010 and \$103,124 for the years ending December 31, 2024 and 2023, respectively.

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2:

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability,
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Collective trust funds: Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits. The portfolio's investment objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. The portfolio invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements) and enters into "wrap contracts" issued by third parties and invests in cash equivalents represented by shares in money market funds. There are no unfunded commitments at December 31, 2024. The fund has a daily redemption frequency and redemption notice period.

E. Rollovers

Rollover contributions are permitted from any employee even if not otherwise eligible to be a Participant. In-kind rollovers are not permitted. There were rollovers into the Plan of \$29,567 and \$30,678 during the years ended December 31, 2024 and 2023, respectively.

F. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the investment custodian. Therefore, these transactions qualify as party-in-interest transactions. Investment fees paid to the investment custodian are netted against investment returns.

G. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants will become 100 percent vested in their accounts.

H. Tax Status

The Company has adopted a non-standardized plan pre-approved by the Internal Revenue Service (IRS). The IRS issued an opinion letter dated June 30, 2020, that the Plan is acceptable with the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

J. Subsequent Events

The Plan administrator has evaluated events and transactions subsequent to the statements of net assets available for benefits date through the date of the independent auditors' report (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements. The Plan administrator has not identified any items requiring recognition or disclosure in the financial statements.
