### 1 Description of Plan

The following description of Robin Industries, Inc. Employees' 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### ***General:***

The Plan, which began November 1, 2001, is a defined contribution Plan covering all employees of Robin Industries, Inc., except for union employees and non-resident aliens, who meet the hour and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was last restated and amended February 17, 2022.

#### ***Eligibility:***

All employees, except for union employees and non-resident aliens of the Company age eighteen and older and who are employed for six months are eligible to participate in the Plan.

#### ***Contributions:***

Cash or Deferred Option [401(k)] - Participants may elect a portion of their compensation, up to the maximum allowed by law, to be contributed to the Plan by the Company. Catch up contributions are permitted. The Plan allows for auto-enrollment for all newly eligible participants at 3%. Participants have the option to opt out of participation in the Plan.

Employer Discretionary Matching Contributions - The Company may make a discretionary matching contribution to each eligible participant's account by matching a percentage of the participant's elective deferral, not to exceed 6% of the participant's compensation for the Plan year. The discretionary matching contributions were \$306,589 and \$308,553 as of December 31, 2024 and 2023.

Qualified Non-Elective Contributions - The Company may also make a qualified non-elective contribution on a discretionary basis. This additional contribution, if any, will be allocated to only non-highly compensated participants in proportion to each eligible employee's compensation as a ratio of all eligible employees' compensation.

The Company may also make additional contributions. Such additional contributions, if any, shall be allocated to each participant in proportion to his or her compensation for the calendar year.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

**1 Description of Plan, Continued**

***Participants' Accounts:***

401(k) Accounts - Each participant's account is credited with the participant's elective contributions, employer matching contributions, earnings, and losses thereon.

***Vesting:***

Vesting in the participant's account balance is based on years of service. The vesting schedule does not apply to participant's elective deferrals. Instead, participants are 100% vested in their elective deferrals at all times. A participant is vested as follows:

***Forfeitures:***

Employer contributions are reduced by forfeitures in the year the forfeiture occurred. The balance in the forfeiture account was \$3,682 and \$5,086 at the end of December 31, 2024 and 2023, respectively.

***Notes Receivable from Participants:***

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans shall not be made for less than \$500 and are repaid over a period not to exceed five years with exceptions for the purchase of a primary residence. Loans are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear interest at prime, as reported in The Wall Street Journal. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits:***

Upon termination of service by reason of retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account, or annual installment payments. Benefit payments to participants are recorded upon distribution.

***Other Plan Provisions:***

Normal retirement age is 65. The Plan also provides for early payment of benefits after reaching age 59-1/2.

### 1 Description of Plan, Continued

#### *Hardship Withdrawals:*

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

#### *Investment Options:*

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

### 2 Summary of Significant Accounting Policies

#### *Basis of Accounting:*

The Plan's transactions are reported on the accrual basis of accounting.

#### *Valuation of Investments:*

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The fair value of the common collective trusts and pooled separate accounts are based on the net asset values as the practical expedient as determined by the asset custodian on a daily basis. The fair value of the guaranteed investment contract is calculated based on the discounted cash flow.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

#### *Use of Estimates:*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

#### *Administrative Fees:*

Substantially all administrative fees are paid by Robin Industries, Inc.

### 2 Summary of Significant Accounting Policies, Continued

#### *Risks and Uncertainties:*

The Plan's investments include investments in common collective trusts, mutual funds, pooled separate accounts, and a guaranteed investment contract with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### *Subsequent Events:*

Management evaluates subsequent events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

### 3 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets
- \* Quoted prices for identical or similar assets or liabilities in inactive markets
- \* Inputs other than quoted prices that are observable for the asset or liability
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

### 3 Fair Value Measurements, Continued

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds:***

The fair value of the mutual funds is based on quoted market prices and are classified as Level 1.

#### ***Pooled Separate Accounts:***

The fair value of the pooled separate accounts is based on the net asset value as a practical expedient (NAV) of shares held by the plan at year-end. The underlying investments are valued at fair value based on commercial quotation services. The fair value is allocated among the contract holders based on a unit value.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the account, the investment adviser reserves the right to temporarily delay distributions from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The Fund invests in domestic stocks and mutual funds.

#### ***Guaranteed Investment Contract:***

The fair value of the guaranteed investment contract is based on the underlying assets of the contract. The fair value is expressed in units. The guaranteed investment contract is classified in the Level 3 category of the valuation hierarchy.

#### ***Common Collective Trusts:***

The fair value of the common collective trusts is based on the net asset value as a practical expedient of shares held by the plan at year-end. The underlying investments are valued at fair value based on commercial quotation services. The fair value is allocated among the contract holders based on a unit value.

Unit purchases and redemptions are transacted at the net asset value per unit of the Portfolio determined as of the close of each business day. The Portfolio issues new units and repurchases outstanding units on a daily basis at the net asset value per unit. Each participating Plan may withdrawal, in whole or in part, amounts from its accounts, upon notice to the Trustee.

Depending on the nature of underlying assets of each fund in the common collective trusts, these investments could be illiquid and not readily convertible into cash.

### 4 Tax Status

On June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions.

### 6 Party-in-Interest Transactions

Certain Plan investments are invested in collective investment trust, guaranteed investment contract and pooled separate accounts managed by the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest. Usual and customary fees were paid by the Plan fund for the investment management services. In addition, the Plan has arrangements with various service providers and these arrangements qualify as party-in-interest transactions.

### 7 Prohibited Transactions

For the 2023 and 2022 Plan years, employee withholdings and loan repayments in the amount of \$160,624, and \$43,639 respectively, were not remitted by the Company to the Plan within the time period as defined by ERISA. These transactions constitute prohibited transactions and will be corrected under the appropriate IRS guidelines.

All delinquent contributions for the 2023 plan year were corrected in March 2025 outside of the Voluntary Correction Program (VFCP). Additionally, \$20,718 of 2022 delinquent contributions were corrected in March 2025, and \$22,921 were corrected in October 2023 outside of VFCP.
