We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Randolph Macon Academy Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1, the governing body of Randolph Macon Academy Profit Sharing Plan approved a plan of liquidation in March 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the financial statements for the year ended December 31, 2023 to the liquidation basis used in presenting the financial statements for the year ended December 31, 2024. Our opinion is not modified with respect to that matter.


Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Randolph Macon Academy Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.


Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 – Plan Description

The following description of the Randolph Macon Academy Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Randolph Macon Academy (the “Academy”) who have attained the age of 18. Eligible employees may enter the Plan on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was frozen and contributions ceased as of December 1, 2023. In March 2024, Randolph Macon Academy amended the Plan document effective December 1, 2023, to terminate the Plan. See Note 7 for additional information regarding Plan termination.

Contributions

Prior to December 1, 2023, participants could contribute a portion of their compensation, as defined by the Plan, up to the maximum amount allowed by law. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Contributions were subject to certain limitations.

The Plan provided for a match of 100% up to 4% of eligible compensation that a participant contributed to the Plan. The Academy could also make discretionary employer contributions to eligible participants working greater than 1,000 hours who had completed one year of service, as defined.

Effective December 1, 2023, the Plan was terminated and no additional contributions were made with respect to compensation earned after that date.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Academy’s contributions, and an allocation of Plan earnings and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Academy’s matching contributions plus earnings thereon is based on years of continuous service. A participant is 100% vested in Academy contributions after three years of credited service. Due to Plan termination, all participants are 100% vested.

Notes from Participants

Prior to December 1, 2023 (the Plan freeze date), participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms ranged from one to five years

unless the note was for purchase of a primary residence, in which case the term could exceed five years. Notes were secured by the balance in the participant's account and bore interest at a rate commensurate with market rates. The interest rate ranged from 3.25% to 4.50% at December 31, 2024. Principal and interest payments were the responsibility of the participant and were not paid through payroll deductions.

Payment of Benefits

Prior to December 1, 2023 (the Plan freeze date), on termination of service with a vested account balance in excess of \$5,000, a participant or a participant's beneficiary could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, enter into a qualified joint and survivor annuity, begin installment payments where the participants vested benefit would be paid out in equal annual installments over a set number of years, or roll over the funds to another qualified Plan or an individual retirement account.

For termination of service with a vested account balance less than \$5,000, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution or rollover the funds to another qualified plan or an individual retirement account. In-service distributions were permitted for participants at least age 59½. Hardship withdrawals were permitted, as defined.

Plan termination distributions are made as single lump-sum payments.

Administrative Costs

Plan fees and administrative expenses are paid by the Academy or the Plan on a discretionary basis.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,005 and \$4,873, respectively. Forfeited balances of terminated participants' nonvested accounts may be used to reduce employer contributions or pay administrative expenses. During the years ended December 31, 2024 and 2023, forfeited non-vested amounts of \$-0- and \$11,796 were used to reduce employer contributions, respectively.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting used to determine the amounts at which investments are stated from ongoing Plan basis to the liquidation basis for years after December 31, 2023.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through October 6, 2025, the date the financial statements were available to be issued. See Note 7 for Plan Termination information.

Note 4 – Fair Value Measurements

The Plan’s mutual funds are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

Note 5 – Investment Contract with Insurance Companies

The Plan holds investment contracts with The Variable Annuity Life Insurance Company (VALIC). These contracts, VALIC Fixed Account Plus and VALIC Short-Term Fixed Account, meet the fully benefit-responsive traditional investment contract criteria and, therefore, are reported at contract value. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

For the Fixed Account Plus, VALIC employs a new money interest crediting policy where VALIC declares a “current” interest rate at the beginning of each month applicable to contributions received during that month. It is the intent of VALIC, though not guaranteed, to continue to credit interest at the same rate for such contributions for an additional calendar year. At the beginning of the third calendar year, such contributions will earn interest at a newly declared pool rate. This rate is established January 1 of each calendar year and guaranteed for that entire calendar year. The contractually guaranteed minimum interest rate is applicable for the lifetime of the contract. The minimum guaranteed interest rate ranged from 1.00% to 4.50% for the years ended December 31, 2024 and 2023.

The VALIC Short-Term Fixed Account crediting rates are established on a portfolio basis, whereby all deposits in the option receive the same crediting rate, regardless of the initial date of deposit. The minimum guaranteed interest rate ranged from 1.00% to 3.00% for the years ended December 31, 2024 and 2023. Once a transfer has been made into the Short-Term Fixed Account, no transfers from this account will be permitted for 90 days.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan’s failure to qualify under Section 401(a) of the *Internal Revenue Code (IRC)* or the failure of the trust to be tax-exempt under Section 501(a) of the *IRC*
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan’s prohibition on competing investment options
- Other Plan Sponsor events that significantly affect the Plan’s normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan’s investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

Note 6 – Related Party and Party-in-Interest Transactions

Certain administrative functions are performed by officers or employees of the Academy. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Plan investments are managed by VALIC and therefore, these transactions qualify as a party-in-interest transactions. Fees paid to VALIC for administrative services were \$6,052 for the year ended December 31, 2024.

Note 7 – Plan Termination

Effective December 1, 2023 (Plan freeze date), the Academy determined that no new participants should enter the Plan and there would be no further contributions. In March 2024, the Academy elected to terminate the Plan effective December 1, 2023. As of July 29, 2025, the Plan's Custodian distributed all assets of the Plan to participants and beneficiaries, with any remaining unclaimed amounts escheated to the appropriate state in accordance with applicable unclaimed property laws.

Note 8 – Tax Status

The Plan has adopted a non-standardized profit sharing/401(k) plan sponsored by VALIC Retirement Services Company. The Plan is designed in accordance with applicable sections of the IRC. The Academy has obtained the most recent favorable opinion letter from the IRS dated June 30, 2020. The Academy believes the Plan is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
