**INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator and Participants of

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### **NOTES TO FINANCIAL STATEMENTS**

#### **NOTE 1 - DESCRIPTION OF PLAN**

The following brief description of Jerry's Enterprises, Inc. Union Employee's 401(k) Plan (the "Plan") is provided for general information only. Participants should refer to the plan agreement for more complete information.

##### **General**

The Plan is a defined contribution plan covering certain union employees of Jerry's Enterprises, Inc. (the "Company") who have completed one year of service, as defined, and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Contributions**

Each year participants may make contributions of eligible compensation, as defined in the Plan, up to the maximum amount permitted by law. Participants may also make rollover contributions from qualified benefit plans from previous employers. The Company makes defined contributions per the terms of the collective bargaining agreements with Minnesota Meat Masters and the United Food & Commercial Workers Union Local 663 ("663").

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of plan earnings and is charged with an allocation of administrative expenses. Allocations are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in all employee contributions plus actual earnings thereon. Minnesota Meat Masters participants are immediately vested in all employer defined contributions. Vesting of employer defined contributions for 663 participants, plus earnings thereon, is based on the number of years of continuous service which is subject to certain break in service rules as defined in the 663 collective bargaining agreement. The portion of the participant's accounts attributable to the Company's contribution becomes 20 percent vested after two years of credited service, as defined, and continues to vest at the rate of 20 percent for each successive year of service until 100 percent vested after six years.

##### **Payment of Benefits**

Upon termination of service due to retirement, a participant may elect to receive payment in a lump sum or in installments. For termination of service due to other reasons, a participant will receive the value of the account in a lump-sum distribution.

If the account balance is less than \$5,000, the participant will automatically receive a lump sum distribution. If the balance is greater than \$5,000, the participant can elect to receive a lump sum, or an installment arrangement.

**NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

**Forfeited Accounts**

Forfeitures from terminated participants' accounts are used to reduce the Company's contribution obligation and/or reduce fees from plan expenses. Forfeited nonvested accounts at December 31, 2024 and 2023 were \$19,205 and \$20,703, respectively. Contributions were reduced by \$12,034 during 2024. Fees were reduced by \$7,950 during 2024.

**Notes Receivable from Participants**

In accordance with the plan agreement, participants may borrow from their accounts. The aggregate of all loans to a participant under the Plan may not exceed the lesser of \$50,000 or 50 percent of such participant's total account balance and have terms ranging from one to five years or up to 30 years for the purchase of a primary residence. At December 31, 2024, the loan interest rate ranged from 4.25% to 9.50%, with maturity dates through February 2040. The rate of interest on new loans is the prime rate as published for the last business day of the calendar month preceding the calendar month in which the loan is granted or renewed. The loans are secured by the balance in the participant's account. Principal and interest payments are paid ratably through payroll deduction or are received directly from participants.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as accounts payable. There were no excess contributions for the years ended December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain administrative expenses are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration expenses not paid directly by the Company may be paid from the Plan in accordance with Plan provisions. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's accounts. Fees paid by the plan were \$67,666 for the year ended December 31, 2024.

**Date of Management's Review**

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

*Level 2 Fair Value Measurements*

The fair value of corporate bonds, U.S. government securities and pooled separate accounts are valued using a market approach on yields currently available on comparable securities of issuers with similar credit ratings.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers into or out of Level 3.

**NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The plan has a traditional fully benefit-responsive guaranteed investment contract with an insurance company. The insurance company maintains contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal of transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$1,498,740 and \$2,175,830, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis.

**NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY(CONTINUED)**

The average yield earned by the Fund for the years ended December 31, 2024 and 2023 was 2.59% and 2.35%, respectively. The actual interest rate credited to participants in the Fund for the years ended December 31, 2024 and 2023 was 2.60% and 2.36%, respectively.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (a) amendments to the plan documents, (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan Participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

**NOTE 7 - TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan paid Minnesota Life Insurance Company, the trustee of the Plan, for professional services for the year ended December 31, 2024.

The Plan paid StanCorp Financial Group for professional services for the year ended December 31, 2024.

The Plan paid Prime Capital Investment Advisors, Inc. for eligible compensation fees.

The Plan paid Miller, Welle, Heiser & Co., Ltd. for audit services for the year ended December 31, 2024.

Other than loans to participants in the form of promissory notes, the Plan has had no agreements or transactions with any parties-in-interest other than those noted above.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 10 - CERTIFIED INVESTMENTS**

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments, and notes receivable from participants held at December 31, 2024, and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from the participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate of The Standard Insurance Company (the trustee of the Plan).


