INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of
the Magna Legal Services 401(k) / Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Magna Legal Services 401(k) / Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Magna Legal Services 401(k) / Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information as described in Note 6 to the financial statements is complete and accurate.

Opinion

Note 1 - Description of Plan

The following description of the Magna Legal Services 401(k) / Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Magna Legal Services, LLC (“the Company”) who have attained the age of 21 and are not covered by a collective bargaining agreement, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Each employee who satisfies the eligibility requirements will be automatically enrolled in the Plan on the first day of the month, following their hire if, after given a reasonable opportunity to respond, they do not indicate either the amount or percentage of compensation to be deferred or that they opt not to make elective deferrals. Upon automatic enrollment, 3% of the participant’s compensation will be withheld, contributed and treated as a pre-tax elective deferral. If the participant is automatically enrolled and does not indicate their investment elections, the default investments are the My Retirement Path Index Funds based on the participants expected retirement date.

The Plan also entitles participants to make elective deferrals to Roth 401(k) accounts. These deferrals are included in the participant’s taxable income and, once deferred, are irrevocably designated as Roth elective deferrals.

Plan Merger

Effective January 1, 2024 the Barkley Court Reports Inc. 401(K) Profit Sharing Plan and Trust and Resonant Legal Media, LLC 401(k) Profit Sharing Plan and Trust were fully merged into the Plan as a result of acquisitions of the 2 plan sponsors, by the Company. As a result of the plan mergers, assets totaling \$13,556,148 were transferred into the Plan in February 2024.

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan, not to exceed annual dollar limitations imposed by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

Annually, the Company may make safe harbor contributions to the Plan for eligible participants equal to 3% of their compensation, as limited by the Internal Revenue Code (“IRC”). The Company may also contribute a discretionary profit sharing contribution at such amounts allocated to eligible participants, pro rata, by class, based on compensation. In addition, the Company may make a matching contribution on behalf of eligible participants in an amount equal to either a percentage of compensation or a dollar amount as it directly relates to elective deferrals made during the year by

eligible participants. Participants direct the investment of their contributions and those provided to them by the Company into various investment fund options offered by the Plan.

Total employer discretionary profit sharing contributions for the year ended December 31, 2024 was \$1,426,621, which was funded by the Company subsequently. There were no safe harbor or employer matching contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and any Company contributions on their behalf, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral, safe harbor and rollover contributions, plus actual earnings thereon. With respect to the Company's matching and discretionary portions, a participant is 20% vested after 2 years of continuous service increasing to 100% after six years.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the participant's highest outstanding note balance to the plan during the one-year period ending on the day before the date on which the note is made, whichever is less. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% through 9.50%, maturing through September 2036. Principal and interest are paid ratably through payroll deductions over a reasonable period of time. Any outstanding loans are due and payable upon termination of employment.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive benefits in a lump sum or in installment payments (over a period not to exceed the life expectancy of the participant, or the participant and his/her designated beneficiary). If a participant is terminated, the participant must consent to any distribution when his/her vested account balance exceeds \$7,000. The value of the participants vested account balance shall exclude rollover contributions that the participant may have made to the Plan.

Payment of Benefits (continued)

Upon termination, if the participant does not make a timely election with respect to a cash-out distribution of an amount greater than \$1,000 but less than or equal to \$7,000, a direct rollover will be made on their behalf of their vested account balance into an individual retirement account or annuity (“IRA”). If the amount is under \$1,000, unless instructed in writing to rollover such amount to either an IRA or another qualified retirement plan, the participant will receive a check representing their vested account balance less the applicable 20% federal income tax withholding.

Participants may request a distribution while still employed for financial hardships or after you reach 59 ½ years of age.

Forfeited Accounts

As of December 31, 2024, and 2023, forfeited non-vested accounts totaled \$52,821 and \$15,295, respectively. Forfeitures of non-vested account balances of terminated employees are used to offset Plan expenses or reduce the Company’s contributions. There were no forfeitures utilized to reduce employer contributions during the year ended December 31, 2024.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 - Fair Value Measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other fees are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Note 3 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts that were funded by matching and discretionary contributions.

Note 4 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 5 - Tax Status

The Internal Revenue Service has determined and informed the Trustee by a letter dated June 30, 2020 that its profit sharing/money purchase/CODA plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC") and is exempt from income taxes. The Plan's administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress for any tax periods.

Note 6 - Information Prepared and Certified by the Trustee (unaudited)

Certain information related to investments in the accompanying financial statements and supplemental schedule, including investments at fair value and notes receivable from participants held as of December 31, 2024 and 2023, net appreciation in fair value of the investments, dividend income and interest income on notes receivable from participants for the year ended December 31,

Note 7 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

- Level 1*** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2*** - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3*** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust – Common collective trust (“CCT”) is valued at NAV of units held by the Plan and is not publicly quoted. The NAV, as provided by the Custodian of the CCT, is used as a per share practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Fixed annuities – Values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

For the year ended December 31, 2024, there were no transfers between level 1 and 2 and no transfers into or out of level 3.

The investment strategy for the My Retirement Path Index Funds is to provide long-term investors with an asset allocation strategy designed to maximize their retirement savings consistent with the risk that investors may be willing to accept given their investment time horizon.
