Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Turning Technologies, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Turning Technologies, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible full-time employees of Turning Technologies, LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Company acquired Inkling Systems Inc. in April 2024. Effective September 1, 2024, the Inkling Systems, Inc. 401(k) Plan (the "Inkling Plan") merged into the Plan. All net assets of the Inkling Plan were transferred, which totaled \$5,783,705. Approximately 100 participants were added to the Plan.

Eligibility: The Plan covers all eligible employees of the Company who are age 18. Employees covered by a collective bargaining agreement, are leased employees, nonresident aliens or temporary employees, as defined in the Plan, are excluded from eligibility to the Plan.

Contributions to the Plan: Eligible employees are automatically enrolled into the Plan contributing 6% of eligible compensation, as defined in the Plan, unless participation is declined. Participants may elect to change or discontinue deferrals of eligible compensation to the Plan at any time. Individual participants may contribute up to 90% of their eligible compensation not to exceed the Internal Revenue Service (IRS)'s maximum allowed into pre-tax and/or after-tax Roth investments. Participants may also rollover pre-tax amounts representing distributions from other qualified plans. Participants that have attained 50 years of age may also contribute "catch up" contributions.

The Company may make discretionary matching contributions which are determined annually and are a percentage of participant deferrals or a uniform dollar amount. For the period January 1, 2024 through August 31, 2024, the Company matched 35% of the first 6% contributed by the participants. For the period September 1, 2024 through December 31, 2024, the Company matched 50% of the first 6% contributed by the participants.

In addition, the Company may contribute discretionary employer profit sharing contributions which are allocated as a percentage of participant compensation to all eligible participants, as defined in the Plan agreement. In order to be eligible for profit sharing contributions, a participant must have provided 1,000 hours of service to the Company during the Plan year and be employed as of the last day of the Plan year. No discretionary employer profit sharing contributions were contributed by the Company in 2024.

Plan participants may direct all their contributions among one or more funds offered by the Plan. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted, pursuant to the Plan's provisions.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, and an allocation of the Company's discretionary profit-sharing contribution, if applicable, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Vesting: Participants are immediately vested in their elective deferral and rollover contributions plus actual earnings thereon. Vesting in the remainder of their accounts, plus earnings thereon, is based on years of continuous service. A participant is 100% vested in discretionary matching contributions after three years of credited service.

Payment of Benefits: Upon termination of service due to retirement, disability or death, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account. Benefit amounts between \$1,000 and \$5,000 will be distributed to participants in the form of an automatic rollover, while benefits under \$1,000 will be automatically distributed in a lump sum. Participants (or their beneficiaries upon the death of the participant) may elect to receive their vested account balances as a single lump sum or in partial payments.

In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Participants may have only one outstanding loan at any given time. The loans are secured by the balance in the participant's account and bear interest at prime rate. Interest rates on loans outstanding range from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions over a term not exceeding five years or for loans used for the purchase of a primary residence, a longer term may be granted.

Forfeitures: Forfeitures of non-vested Company contributions will generally be used to pay administrative expenses or reduce future Company contributions. For the year ended December 31, 2024, \$57,023 was used to reduce Company contributions. There were \$0 and \$24,176 of unused forfeitures at December 31, 2024 and 2023, respectively.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan. Any expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

(Continued)

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 4 for discussion of fair value measurements.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: Plan management has evaluated all events or transactions that occurred from December 31, 2024, to October 9, 2025, the date the financial statements were available to be issued.

In the subsequent Plan year, the Company completed an acquisition. As a result, the net assets and participants of the acquired entity's retirement plan were merged into the Plan.

NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by the Plan administrator and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC (the trustee of the Plan).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Plan investments are in funds and accounts that are managed by Vanguard Group, Inc. (Vanguard), the contractor of Ascensus Trust Company. Investment management fees are also paid by the Plan to parties-in-interest and are reflected as a reduction of investment returned earned by the Plan on its investments. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
