INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants
Distribution Technology, Inc. 401(k) Retirement Plan
Charlotte, North Carolina

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of **Distribution Technology, Inc. 401(k) Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the **Distribution Technology, Inc. 401(k) Retirement Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from Ascensus Trust Company as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN:

The following description of the Distribution Technology, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is sponsored solely by Distribution Technology, Inc. (the Employer).

General - The Plan is a defined contribution retirement savings plan under Section 401(k) of the Internal Revenue Code and covers all employees who have at least three months of service at the plan entry date. It is subject to the provisions of the Employee Retirement Income Security Act of 1974. The Plan is not covered by the Pension Benefit Guarantee Corporation. Additionally, the Plan assets have no other form of insurance. The Plan provides several investment options, all of which are participant directed. The employer allows eligible employees to enter the Plan on January 1, April 1, July 1, and October 1.

Contributions - Salary deferral contributions may be made by all eligible employees. Salary deferral contributions shall not exceed the amounts prescribed by the Secretary of the Treasury. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they have affirmatively elected not to participate in the Plan. Automatically enrolled participants have their rate set at 4% of eligible compensation unless changes by the participant. Employer matching contributions equal a percentage as determined annually by the Employer. In 2024 and 2023, this was 25 percent of the employees' contributions that did not exceed 6 percent of the employees' compensation. All Employer contributions are subject to the vesting percentage. Voluntary contributions by plan participants in excess of salary deferral contributions are not permitted.

Participant accounts - Each participant's account is credited with the participant's contributions, the Employer's matching contributions and the net earnings or losses of the participant's investment account. Allocated earnings are based on participant account balances as defined in the Plan. The benefits to which a participant is entitled are the benefits that can be provided from the participant's account. Changes in the underlying value of investments selected by participants will affect the benefits to which a participant is entitled.

Vesting - A participant is 100 percent vested in Employer contributions and related earnings upon the occurrence of any of the following:

- Attaining normal retirement age.
- Employment terminates as a result of death or disability.

If a participant's employment terminates prior to retirement for any reason other than death or disability, then vesting is based on a six-year schedule, with increments of 20 percent vesting beginning in the second year and continuing until the participant is 100 percent vested after the sixth year. Each participant is immediately 100 percent vested in his or her salary deferred contribution and related earnings. Forfeitures are used to pay reasonable Plan expenses.

Payment of benefits - Participants are eligible for the payment of benefits in the event of separation of service, death or disability, retirement, and severe financial hardship, as well as for in-service disbursements once the participant has achieved the age of 59 and 1/2 and is fully vested. Upon termination of employment with the Employer, any participant account with a vested account balance that is less than \$5,000 will automatically be paid to the participant as a lump sum distribution unless otherwise directed by the terminated employee/participant.

Notes receivable from participants - The Plan allows for loans to participants. The minimum amount for each loan is \$1,000, and the maximum is the lesser of 50 percent of the participant's vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at market rates. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or fifty percent of their account balance. The loans are repaid ratably through monthly payroll deductions over the terms of the loan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates - The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments - The Plan's investment securities are stated at fair value, based on quoted market prices. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded as earned.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits - Benefits are recorded when paid.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES:

The plan administrator has elected the alternative method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. 4. FAIR VALUE MEASUREMENTS:

The Fair Value Measurements Topic of the Financial Accounting Standards Board (“FASB”) Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in active markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liabilities have a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability’s fair value measurement level within the hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common and collective trust: Valued at NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INCOME TAX STATUS:

The Plan administrator has chosen to rely on an opinion letter from the third-party administrator that the Plan is qualified under Internal Revenue Code Section 401. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more than likely would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations prior to 2021.

6. PLAN TERMINATION:

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

7. FORFEITURES:

During 2024 and 2023, the Employer did not use any forfeitures to reduce its matching contribution.

8. PARTIES-IN-INTEREST:

Party-in-interest transactions occurred with the Plan's auditors and investment advisors. The Employer pays the auditor's fees and the plan pays the investment advisor fees.

9. RISKS AND UNCERTAINTIES:

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. SUBSEQUENT EVENTS:

Events and transactions occurring after December 31, 2024 have been evaluated to determine proper recognition and disclosure in the financial statements. Subsequent events and transactions were evaluated through October 10, 2025, which represents the date the financial statements were available to be issued.
