## INDEPENDENT AUDITOR'S REPORT

To the Participants

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the accompanying financial statements of Blakeman Steel Inc. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**Note 1**            **DESCRIPTION OF PLAN**

The following description of the Blakeman Steel Inc. Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan is a defined contribution plan established by Blakeman Steel, Inc. (the Company). The Plan qualifies as a profit-sharing plan under Internal Revenue Code (Code) Section 401(a).

The Plan, as amended and restated as of January 1, 2022, is a defined contribution plan that covers all employees of the Company who are age 20 ½ or older and have six months' service with the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan entry dates are January 1, April 1, July 1, and October 1 of each year.

**Employee contributions**

Employee contributions are not allowed.

**Employer contributions**

The Company may make discretionary contributions, which are allocated among three employee groups: (A) Owner Employees, (B) Managers and Office Staff, and (C) Others. Within these groups, contributions are allocated based on eligible compensation.

This allocation is limited by the requirement that the rate contributed on behalf of all eligible employees must be at least one-third of the rate Owner Employees receive. (That limitation may not exceed 5% of compensation.)

Participants must have at least 1,000 hours service during the year and be employed the last day of the year to receive a share of employer contributions. These requirements do not apply to participants who retired, became disabled, or died during the year.

**Participant accounts**

Each participant's account is credited with allocations of the Company's contribution, plan earnings, losses, and expenses. Earnings, losses, and expenses are allocated proportionately among all participants based on the amount of their investments. If a participant receives a distribution before the annual valuation, no earnings or losses are allocated to that account.

**Investments**

All investments are non-participant directed.

**Forfeitures**

Forfeitures are allocated in the same manner as employer discretionary contributions. At December 31, 2024 and 2023, forfeited nonvested participant account balances totaled \$0 and \$0, respectively. These accounts may be used to reduce future employer contributions.

**Vesting**

Participants become 20% vested in their accounts after two years of service with the Company. That increases 20% per year, until they are fully vested after six years of service.

Employees' balances become fully vested upon death or disability. In addition, an employee who has been a participant in the plan for at least five years becomes fully vested at age 65.

**Administrative expenses**

The Plan pays investment management fees, broker fees, and audit fees. The Company absorbs the cost of substantially all other administrative expenses.

**Payment of benefits**

Participants (or their beneficiaries) are eligible to receive benefits upon termination of service. Benefits are paid as soon as feasible after the end of the plan year following termination. Vested balances under \$5,000 may be paid without the participant's consent. Balances over that amount are made at the Participant's election. Benefits are paid as lump-sum distributions or in installments for required minimum distributions.

**Other plan provisions**

Other plan provisions are described in the Plan Document.

**Note 2            SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of accounting**

The financial statements of the Plan are prepared using the modified cash basis of accounting. This method differs from accounting principles generally accepted in the United States of America since revenues are recorded when received rather than when earned, and expenses are recorded when paid rather than when incurred.

**Payment of benefits**

Benefits are recorded when paid.

**Investments and investment income**

Investments are stated at fair value. See Note 6. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Subsequent events**

The Plan has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued.

**Note 3            TAX STATUS**

On January 1, 2022, the Plan adopted the CCH Incorporated, d/b/a ftwilliam.com Basic Plan Document #01. The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC).

**Note 3**            **TAX STATUS – (continued)**

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 4**            **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan's sponsor has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a full or partial termination, affected participants would become fully vested in all accounts.

**Note 5**            **INVESTMENTS CERTIFIED**

The December 31, 2024 and 2023 statements of net assets available for benefits, the investment activities included on the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Charles Schwab Trust Bank (CSTB) (the Trustee) in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

The information certified includes total investments of \$3,200,253 and \$3,060,541 at December 31, 2024 and 2023, respectively, and related investment income of \$415,608 for the year ended December 31, 2024.

These accounts were maintained by CSTB, a party-in-interest.

**Note 6**            **FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels.

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets or liabilities and have the highest priority. Level 2 inputs consist of observable inputs other than quoted market prices for identical assets or liabilities. Level 3 inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

**Level 1**

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. Cash and cash equivalents are carried at amortized cost, which approximates fair value.

The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.
