NOTE A DESCRIPTION OF PLAN

The following brief description of the International Union of Operating Engineers Local 835 Health and Welfare Fund is provided for general purposes only; participants should refer to the Plan Agreement for more complete information.

General

The Plan provides for dental, vision care, prescription, death and disability benefits for eligible members as detailed in the plan.

NOTE B SIGNIFICANT ACCOUNTING POLICIES

General

The International Union of Operating Engineers Local 835 Health and Welfare Fund was formed under a declaration of trust between the Union and the contributing employers covered by the collective bargaining agreement.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investments

Investments are presented at market value. Any changes in market value are recognized during the period. Income from securities is recognized using the accrual basis of accounting. At December 31, 2024 and 2023 the estimated cost of the securities was \$8,600,000 and \$7,444,000 respectively.

Contributions

Employer contributions are based on the amounts required to be funded under the Collective Bargaining Agreement. Additional amounts are received from qualified beneficiaries who elect to continue coverage under COBRA in amounts established by the Plan's Board of Trustees. Contributions receivable includes only those amounts actually received by the administrator in the subsequent period for hours worked during the current Plan year. Consequently, no provision has been made for amounts deemed uncollectible.

NOTE B SIGNIFICANT ACCOUNTING POLICIES (continued)

Benefit Obligations

Health costs incurred by participants and their dependents are covered by insurance contracts maintained by the Plan. It is the present intention of the sponsor of the Plan to continue obtaining insurance coverage for benefits.

Since postretirement benefits are not provided under the Plan, there is no provision for postretirement benefit obligations.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires Management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Income Taxes

The Fund has been advised of its exemption from federal income taxes under Section 501(c)(9) of the Internal Revenue Code.

Termination

It is the intent of the Trustees to continue the plan in full force and effect. However, in the event the obligation of the employer to make contributions to the Fund shall terminate, the Trustees shall continue to apply the Fund to the purpose for which it was formed. Upon disbursement of the entire Fund, the Trust shall terminate. Discontinuance or termination shall not permit any part of the Fund to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification*(ASC) 820, *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value in generally accepted accounting principles, and expands disclosure about fair value measurements. The statement requires that assets and liabilities carried at fair value be classified and disclosed in one of the following three categories:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Fair Value Measurements(continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different instruments could result in a different fair value measurement at the reporting date.

The following is a description of the valuation methodologies used for assets measured at fair value:.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
