**INDEPENDENT AUDITOR'S REPORT**

To the Administrator of the

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Big M Transportation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Big M Transportation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note A - Description of Plan**

The following description of the Big M Transportation 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

2020 was the initial year of the Plan. The effective date for the Plan operations was January 1, 2020.

*General:* The Plan is a defined contribution plan covering employees that have four months of service or forty-five hours per week of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee oversees governance of the Plan.

*Contributions:* Each year, participants may make contributions to the Plan in the form of salary reductions equal to the lesser of \$23,000 in 2024 and \$22,500 in 2023 (plus an additional \$7,500 for 2024 and \$7,500 for 2023, if over 50) or 100% of defined compensation. The Company contributes a match of 20% of the first 6% of base compensation that a participant contributes to the Plan. The Company match is capped at 1.2%. Participants may elect to make voluntary contributions under the Plan in amounts determined by the Plan administrator with the consent of the Custodian. Participants may direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and an insurance investment contract as the investment options for participants. The Plan offers pre-tax and after-tax(Roth) options to the participants.

*Participant Accounts:* Each participant's account is credited with the participant's contribution and allocations of (a) the employer's matching contribution and (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. At December 31, 2024 and 2023, The Plan holds \$553,969 and \$337,741 in vested accounts of former participants that have separated from service with account balances.

*Vesting:* Participants are immediately vested in their salary reduction contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 20% vested after two years, with a 20% increase each succeeding year until becoming fully vested after the sixth year of service.

*Forfeitures:* At December 31, 2024 and 2023, accumulated forfeited non-vested accounts totaled \$114,945 and \$65,658. Forfeited amounts are applied against future employer contributions and fees. For December 31, 2024 and 2023, plan fees offset by forfeitures totaled \$2,532 and \$2,216, respectively.

*Notes Receivable from Participants:* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their account balance. The notes are secured by the balance of the participant's account and bear interest at rates ranging from 3.25% to 8.5%, based on national prime rates plus a 1% adjustment. Principal and interest are paid ratably through payroll deductions. Participants are limited to one active loan at any one time.

*Payment of Benefits:* On termination of service due to death, disability, or retirement, a participant may elect to receive either an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or take annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Note B - Summary of Significant Accounting Policies**

*Basis of Accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

*Use of Estimates:* The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

*Payment of Benefits:* Benefits are recorded when paid.

*Operating Expenses:* All custodial fees are paid by the Plan. Other expenses of maintaining the Plan are paid by the Plan sponsor and are not included in these financial statements. Fees from the administration of notes receivable are included in administrative expenses and charged directly to the participant's account.

*Investment Valuation and Income Recognition:* Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Expenses:* Certain expenses of maintaining the Plan are paid by the sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses of the plan are allocated to participant accounts.

*Date of Management's Review:* Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

**Note D - Investment Contract with Insurance Company**

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Standard Insurance Company. Standard maintains contributions in its general funds in unallocated contracts. The account is credited with earnings on the underlying investments and is charged with participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value.

Certain events could limit the Plan's ability to transact at contract value with Standard Insurance Company. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletions of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (d) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events could allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuers consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with the Plan, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Contract value, as certified to the Plan by The Standard Insurance Company, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$484,536 and \$353,264, respectively. The crediting interest rate was 1.34% in 2024 and .83% in 2023. The minimum crediting interest rate is re-determined annually.

**Note E - Financial Instruments**

*Off-Balance-Sheet Risk*

The Plan is not a party to any financial instruments which have off-balance-sheet risk of accounting loss.

*Significant Group Concentrations of Credit Risk*

The Plan's exposure to credit risk arises from its investments in unallocated contracts held by Standard Insurance Company located in Portland, OR, investments held in pooled separate accounts of Standard Insurance Company, receivables from the sponsor, and participant loans.

There is no collateral assigned to the investments or receivables. Participant loans are collateralized by the participant's individual account balance. The maximum amount of credit loss from these financial instruments is their carrying value.

**Note F- Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits, except for fully benefit-responsive investment contracts, which are reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. The Administrative Committee determines the Plan's valuation policies. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at yearend. The fair values of common stocks, and US government securities are based on the closing price reported in the active market where the individual securities are traded, when available.

*Level 2 Fair Value Measurements*

The fair value of investments in pooled separate accounts and master separate accounts is based on quoted net asset values of the shares held by the Plan at year-end. The fair values of these shares are based on quoted market prices for similar assets or liabilities in active markets where the individual securities are traded.

*Level 3 Fair Value Measurements*

The guaranteed investment contract with the insurance company is not actively traded and significant other observable inputs are not available. Thus, the fair value of the guaranteed investment contract is determined using an income approach based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer.

For those assets with fair value measured using Level 3 inputs, the Plan administrator determines the fair value measurement policies and procedures in consultation with the Plan custodian. These policies and procedures are reassessed annually to determine if the current valuation techniques are still appropriate. At that time, the unobservable inputs used in the fair value measurements are evaluated and adjusted, as necessary, based on current market conditions and other third-party information.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023 are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers into and out of Level 3 at the end of the reporting period. For the years ended December 31, 2024 and 2023, transfers are netted in the following tables.

**Note G - Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

**Note H -Tax Status**

The Internal Revenue Service has determined and informed the Plan sponsor by letter with an effective Plan adoption date of January 1, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore believes that that Plan is qualified and the related trust is tax-exempt.

**Note H - Tax Status (Continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain tax positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022, as this is the first year of the Plan's existence.

**Note I - Concentrations and Contingencies**

The ability of the Plan sponsor to continue making contributions to the Plan is largely contingent on the demand of the sponsor's trucking services. Any substantial economic downturn would affect the sponsor's ability to fund the Plan.

**Note K - Risks and Uncertainties**

The Plan invests in various investment securities through the pooled separate accounts. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.

**Note L - Related Party Transactions and Parties in Interest**

The Plan investments are in pooled separate accounts and unallocated contracts of Standard Insurance Company. Stancorp Financial Group provides administrative and investment services for the Plan. Stancorp Financial Group is the parent company of Standard Insurance Company. The Plan paid Stancorp Financial Group \$74,719 and \$71,503 in fees for years ended December 31, 2024 and 2023.

As part of the insurance contract with Standard Insurance Company, the insurance agent, Charles Barber, was paid \$9,187 and \$6,378 in commissions by the insurance company for the year ended December 31, 2024 and 2023.

For 2024 and 2023, the Plan paid Kestra Advisory Services, LLC \$8,433 and \$5,785.

The Plan sponsor pays the professional fees related to the Plan.

Each of these transactions are exempt from the prohibited transaction rules of ERISA.

**Note M - Delinquent Contributions Transmittals**

During the 2024 and 2023 Plan years, the Company failed to remit all employee deferrals, company matches, and loan repayments to the Plan timely. The totals of these delinquent remittances were \$177,437 for 2024 and \$431,413 for 2023. Standard Insurance Company calculates lost earnings and the Company has or will remit that to the Plan. The Company feels the lost earnings are immaterial and have not accrued those amounts to the Plan.
