Basis for opinion

These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Doylestown Hospital 403(b) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, including definitions of key terms.

General

The Plan is a defined contribution plan covering substantially all employees of Doylestown Hospital (the "Hospital", "Employer" and "Plan Sponsor"). All employees are eligible and commence participation immediately upon hire. The Pension and Personnel Committee of the Hospital controls and manages the operation and administration of the Plan. The Plan utilizes Lincoln Financial Group Trust Company, Inc. As the custodian. The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Participants may make pre-tax or Roth contributions of 1% to 100% of eligible compensation, as defined in the Plan document, subject to certain Internal Revenue Code ("IRC") limitations. The Plan provides for automatic deferral elections (subject to opt out) in the amount of two percent of eligible compensation for all eligible employees.

The Plan offers a discretionary employer matching contribution as determined by the Hospital for each Plan year. To be eligible for the discretionary employer matching contribution, a participant must be an employee of the Hospital and must have attained age 21. Participants who work less than 20 hours per week, must be credited with 1,000 hours of service to be eligible for the discretionary employer matching contribution. The Hospital's discretionary matching contributions were 100% of the first 2% of eligible compensation deferred by a participant, and 50% of the next 3% of eligible compensation deferred by a participant till April 2024, subsequently there was an amendment on April 28, 2024, the Hospital's discretionary matching contributions were 100% of the first 2% of eligible compensation deferred by a participant, and 50% of the next 4% of eligible compensation deferred by a participant.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Hospital's contributions, and Plan investment earnings, and is charged with withdrawals and an allocation of Plan administrative expenses and Plan investment losses. Allocations are based on participant earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their account balances into various investment options offered by the Plan, including participant-directed brokerage accounts invested in registered investment company funds, and may change their investment options at any time, subject to the terms of the funding vehicles. Plan earnings/(losses) are allocated to participants' accounts on a daily basis according to the type of funding vehicle in which balances are invested.

Fund managers' fees are charged to participants' accounts as a reduction of the return earned on each investment option.

Vesting and Forfeitures

Participants' deferral and rollover contributions and earnings thereon are fully and immediately vested. The Hospital's discretionary matching contribution is cliff vested after completion of three years of service. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,412 and \$589, respectively. Forfeitures used to reduce Hospital contributions totaled \$284,193 during the year ended December 31, 2024.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance reduced by the difference between the highest outstanding loan balance during the prior 12-month period and the current outstanding loan balance. Loan terms range from six months to five years and up to 10 years for the purchase of a primary residence. The maximum number of loans a participant may have outstanding at any one time is two. The loans are secured by the balance in the participant's account and bear interest at 1% above the prime rate at the date the loans are issued; interest rates are determined quarterly by the recordkeeper. Interest rates range from 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest are billed directly to participants by the custodian. Loan repayments are made by participants directly to the custodian quarterly, monthly or biweekly.

Payment of Benefits

Upon termination of service, retirement, death, or total permanent disability, a participant may elect to receive a distribution of his or her entire accumulated account balance, subject to the terms and certain limitations of the funding vehicles. Distribution options include lump-sum payments, partial payments or installments. In addition, participants may elect in-service withdrawals of their elective deferral account balances after reaching age 59½. Participants are also permitted to make hardship withdrawals in certain cases of immediate and heavy financial need. Rollover account balances may be withdrawn at any time. Per IRS regulations, participants are required to take a required minimum distribution by April 1 of the year following the year they reach age 73.

Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their hospital contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Plan's investment in fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Benefits Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid from the ERISA account. Loan processing fees and distribution fees are paid by the participants.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

ERISA Account

ERISA accounts at Lincoln Financial Group Trust Company, Inc. hold any investment earnings under the Plan that have not been allocated, and can be used by the Hospital to pay administrative expenses of the Plan, as determined by the Hospital, at its sole discretion. The ERISA account balance was \$172,816 and \$172,577 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, funds from this account in the amount of \$534,704 were used for administrative expenses.

NOTE C - INVESTMENTS AND INFORMATION CERTIFIED BY CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group Trust Company, Inc., the custodian, has certified that the following investment information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation method used for assets measured at fair value. There have been no changes in the method used at December 31, 2024 and 2023.

Registered Investment Company Funds and Participant-directed Brokerage Accounts: Valued at the net asset value ("NAV") of shares held by the Plan at year end based on quoted market prices on nationally recognized securities exchanges.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methods or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Gains and losses (realized and unrealized) included in changes in net assets for the period above are reported in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

NOTE E - INVESTMENT IN STABLE VALUE ACCOUNT

The Plan entered into a fully benefit-responsive contract, the Stable Value Account, with The Lincoln National Life Insurance Company ("Lincoln"). The Stable Value Account's investment objective is to seek the preservation of capital and to provide a competitive level of income over time and is held within the general assets of Lincoln. Participants' ownership of the Stable Value Account is represented as units. Units are issued and redeemed daily at the Stable Value Account's constant NAV of \$1 per unit.

Investments in the accompanying statements of net assets available for benefits include fully benefit-responsive investment contracts recognized at contract value. Contract value represents net contributions plus crediting interest less funds used to pay terminated participants. The Stable Value Account contract does not specify any events which would limit the ability of the Plan to transact at contract value with the issuer or any events that would allow the issuer to terminate the contract and settle for an amount different from contract value. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 1.75%. The formula is guaranteed for five contract years. The crediting interest rate was 1.75% for both December 31, 2024 and 2023.

NOTE F - RELATED-PARTY TRANSACTIONS

The Plan invests in a Stable Value Account and participant-directed brokerage accounts managed by Lincoln, the recordkeeper of the Plan. The Plan permits notes receivable from participants. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

NOTE G - TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code ("IRC"). The terms of the Plan have been prepared to conform to the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b). The Plan administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the IRC and, therefore, believes that the Plan is qualified, and the related accounts are tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

During the year ended December 31, 2024, the Plan Sponsor identified operational errors resulting in excess matching contributions totaling \$188,018. These errors were subsequently corrected and remediated during the year 2025.

NOTE H - PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, the Company failed to segregate and remit in a timely manner certain participant contributions (salary reduction amounts) from its assets within the required time period as specified by the United States Department of Labor Reg. 2510.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Company remitted these contributions to the Plan shortly after the required time frame. The Company is in the process of remitting lost earnings associated with \$49 of untimely participant contributions as of December 31, 2024.

NOTE I - RISKS AND UNCERTAINTIES

Participants invest in various investment securities offered by the Plan. The Plan Sponsor selects the investment vehicles offered within the Plan to provide appropriate investment options to participants. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J - SUBSEQUENT EVENTS

The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 8, 2025, the date the financial statements were available to be issued. On April 1, 2025, Doylestown Hospital and the Doylestown Hospital entities became constituents of and wholly owned by University of Pennsylvania Health System and Penn Medicine. As part of the integration process, Doylestown Hospital's 403(b) plan is expected to merge into the University of Pennsylvania Health System 403(b) Plan (the "UPHS Plan") on January 1, 2026. Final contributions to the Doylestown Hospital 403(b) Plan will be made on or before December 31, 2025. Participants will not be fully vested at the time of the merger; however, their existing vesting service will be carried forward and applied under the vesting provisions of the UPHS Plan.

The Plan is not aware of any subsequent events, except for the above, which would require recognition or disclosure in the financial statements.
