The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Human Technologies Corporation Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Human Technologies Corporation (Organization). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Plan Administration

The Organization is the sponsor and administrator of the Plan. American Trust Company serves as the trustee and recordkeeper of the Plan.

Eligibility

Employees are eligible for elective deferrals upon date of hire and become eligible for the safe harbor matching and non-elective profit-sharing contributions after attaining age twenty (21) and completing one year of service (1,000 hours) with the Organization. Prevailing wage contribution eligibility is based on work performed with the Organization subject to the prevailing wage law.

Contributions

Each year, participants may contribute up to 100% of their compensation subject to certain limits established by the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants have the option to elect to have roth contributions made to the Plan. Roth contributions are included in a participant's taxable gross income for the year in which the contribution is made. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Organization's safe harbor matching contribution is equal to 100% of the employee's first 3% of deferrals plus 50% of employee deferrals between 3% and 5% (4% maximum). Additional profit-sharing amounts may be contributed at the discretion of the Organization. For the years ended December 31, 2024 and 2023 matching contributions were approximately \$215,000, respectively. There were no profit-sharing contributions for the years presented.

The Organization, based on Federal and State law, is required to provide supplemental benefits for those employees working on Federal and State contracts based on job classification and location. These benefits are applied towards medical insurance premiums. Any unused or excess supplemental benefits are contributed to the plan as a Qualified Non-Elective Contribution (QNEC). These contributions will offset any safe harbor contributions to be made by the Organization on the participants behalf. For the years ended December 31, 2024 and 2023 contributions were approximately \$977,000 and \$905,000, respectively.

1. DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Participants direct the investment of their contributions and the Organization's contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, their share of the Organization's contributions, and an allocation of both the Plan's actual earnings (losses) and the Plan's administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately 100% vested in their contributions, employer safe harbor and prevailing wage contributions and earnings (losses) thereon. Participants will become 100% vested in employer nonelective profit sharing contributions and earnings (losses) thereon upon completing three years of service (cliff vesting). A participant is also 100% vested upon reaching normal retirement age, or in the event of death or disability while employed by the Organization.

Payment of Benefits

Payment of benefits will begin as soon as administratively feasible after a request has been made. Participant or their beneficiary may choose to receive account distributions either in a form of a lump-sum distribution or an annuity.

Participants with a balance less than \$5,000 will be rolled into an individual retirement plan designated by the Plan administrator, while participants with a balance of \$1,000 or less will receive a lump sum payment, unless the participant directs otherwise.

The Plan allows for hardship withdrawals for uninsured medical expenses, tuition payments, purchase of a primary residence or prevention of eviction or foreclosure on a primary residence. The Plan also allows for in-service withdrawals to participants attaining age 59 1/2.

Investment Options

Investments are held and maintained by American Trust Company. Contributions are invested at the discretion of the participant, in one or a combination of available investment options.

Forfeited Accounts

Forfeited balances, if any, of terminated participants' non-vested accounts are used to reduce future Organization's contributions or to reduce plan administration fees. There were no forfeited non-vested accounts at December 31, 2024 or 2023. No forfeitures were used for the years ended December 31, 2024 and 2023.

Participant Loans

Loans are not permitted by the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institutions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well held during the year.

Payments of Benefits

Benefits paid to participants are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Administrative Expenses

Administrative expenses are paid by the Plan, as provided in the plan document. Expenses that are paid by the Organization, such as audit fees are excluded from these financial statements. Fees related to the administration of distributions to participants are charged directly to the participant's account. Investment related expenses paid by the Plan are charged against the investment funds whose assets are involved in such transactions.

Fair Value Measurement - Definition and Hierarchy

Financial Accounting Standards Board (FASB) *Accounting Standard Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value and disclosing fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- *Level 1*: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- *Level 2*: Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3*: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

A description of where the Plan's investments fall within the ASC 820 hierarchy is provided in Note 3. There were no transfers between levels of the fair value hierarchy during 2024 or 2023.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make certain estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates and such differences may be significant.

3. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following is a description of the valuation methodologies used for assets and liabilities for which fair values are estimated using the net asset value (NAV) practical expedient:

- *Common collective trust*: valued at the NAV of units of the collective trust. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust, the custodian reserves the right to temporarily delay withdrawal from the trust in order to ensure that the liquidations of the securities will be carried out in an orderly business manner.

The common collective trusts objective is to provide capital preservation and predictable, steady returns. The Fund seeks to achieve this objective by investing primarily in stable value products, such as Guaranteed Investment Certificates ("GICs"), also known as traditional GICs, separate account GICs and synthetic GICs. The fair value of this investment is not readily determinable and has been estimated using the net asset value per share of the underlying investments. There are no unfunded commitments related to the collective trust.

3. FAIR VALUE MEASUREMENTS (Continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

The Plan investments include shares of investment funds managed by affiliates of American Trust Company. America Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan sponsor uses Royal Alliance Associates, Inc. as investments advisors for the Plan and fees paid to these parties qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. INCOME TAX STATUS

The Internal Revenue Service (IRS) has determined and informed by letter for the prototype plan adopted by the Plan, dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

7. PLAN TERMINATION

Although the Organization has not expressed any intent to do so, it has the right to terminate the Plan at any time, subject to the provisions set forth in ERISA. In the event of Plan termination participants will become 100% vested in their accounts.
