### Opinion

I have audited the accompanying financial statements of International Alliance of Theatrical Stage Employees Local 8 Vacation Fund, which comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements. In my opinion, the financial statements referred to above present fairly, in all material respects, the financial position of International Alliance of Theatrical Stage Employees Local 8 Vacation Fund as of December 31, 2024 and 2023, and the results of its operations for the year ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

I conducted my audit in accordance with auditing standards generally accepted in the United States of America. My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I am required to be independent of International Alliance of Theatrical Stage Employees Local 8 Vacation Fund and to meet my other ethical responsibilities in accordance with the relevant ethical requirements relating to my audit. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about International Alliance of Theatrical Stage Employees Local 8 Vacation Fund's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

## INDEPENDENT AUDITORS' REPORT

### Opinion

I have audited the accompanying financial statements of International Alliance of Theatrical Stage Employees Local 8 Vacation Fund, which comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements. **NOTE A      DESCRIPTION OF PLAN**

The following brief description of the International Alliance of Theatrical Stage Employees Local 8 Vacation Fund (Plan) is provided for general purposes only; participants should refer to the Plan Agreement for more complete information.

**General**

The Plan was formed under an agreement between various contributing employers and IATSE Local 8 (Union). The Plan covers all members of the Union employed under the terms of the collective bargaining agreement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions and Benefits**

Employers contribute to the Plan amounts deducted from participating members at a rate of 3% or 5% of gross pay earned by Plan participants. The amount accumulated in each participant's vacation account as of December 31 of each year is paid on or after March 1 to the participant.

**Investment Income**

Investment income in the Plan is used primarily to pay the Plan's administrative expenses. Excess of investment income over administrative expenses may be carried forward to later years or distributed to participants on a pro rata basis at the discretion of the trustees.

**Other**

The Plan may be terminated only by joint agreement between industry and union.

**NOTE B      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Contributions**

Contributions receivable are based upon amounts received by the administrator subsequent to year end for hours worked in 2025 and 2024. Consequently, no provision has been made for delinquent accounts.

**NOTE C      TAX STATUS**

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to the appropriate section of the Internal Revenue Code as a tax exempt organization. The trust has obtained a favorable tax determination letter from the Internal Revenue Service and the Plan sponsor believes that the trust continues to qualify and to operate as designed.

**NOTE D      PLAN AMENDMENT**

Effective June 1, 2007 the plan was amended to provide for supplemental life and long term disability insurance benefits to eligible participants. Premiums are deducted from the participant's vacation benefits. Due to the Covid-19 pandemic the benefit has been suspended for the year ended December 31, 2023.

**NOTE E      SUBSEQUENT EVENTS**

The Plan Administrator has evaluated subsequent events through August 4, 2025, the date the financial statements were available to be issued.



