Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Weldall Mfg., Inc. Profit Sharing 401(k) Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Weldall Mfg., Inc. Profit Sharing 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A -- Description of the plan and significant accounting policies

The following description of the Weldall Mfg., Inc. Profit Sharing 401(k) Savings Plan ("the plan") provides only general information. Participants should refer to the plan document for a more complete description of the plan's provisions. The employer, as described below, has adopted the FMR, LLC Non-Standardized Pre-Approved Profit Sharing Plan effective November 15, 2023. Prior to that date, the employer had adopted the AT Retirement Services LLC Non-Standardized Defined Contribution Pre-Approved Plan, originally effective March 1, 1984, with the most recent restatement dated January 1, 2022.

Effective November 15, 2023, the plan changed its asset custodian and trustee from Johnson Bank to Fidelity Management Trust Company ("Fidelity").

General

The plan is a defined contribution profit sharing plan covering all eligible employees of Weldall Mfg., Inc. ("Weldall"), Orbis Machinery, LLC ("Orbis") and Central State Diesel Generators, LLC ("CSDG") ("the employers") who are age 18 or older and have completed six-months of service. In order to receive an allocation of the company discretionary contribution, employees must be employed on the last day of the plan year. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(k) Committee is responsible for the oversight of the plan, determining the appropriateness of the plan's investment offerings and monitoring investment performance.

The plan's federal identification number is 39-1199680, and the plan's number is 001.

Contributions

Each year, participants may contribute up to 100% of pre-tax (regular) or post tax (roth) annual compensation, as defined in the plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan. The plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the plan unless they affirmatively elect not to participate in the plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The plan has an automatic escalation feature in which the auto enrollment percentage increases by 1% on January 1 of each year to a maximum of 10%.

The employers have a right to make nonelective contributions. For 2024, Weldall made a discretionary contribution of 2.50% of eligible compensation. CSDG made a safe harbor nonelective contribution of 3% of participants compensation in 2024. No discretionary contributions were made by Orbis in 2024. During the year ended December 31, 2024, the employer made a \$438,419 discretionary profit sharing contributions to the plan. During the year ended December 31, 2024, the employer made a \$20,464 safe harbor nonelective contributions to the plan. Annual contributions are subject to certain limitations defined by the Internal Revenue Service (IRS).

Contributions receivable

Contributions receivable are written off when they are determined to be uncollectible. The allowance for credit losses is estimated based on expected credit losses considering the Plan's historical losses, existing economic conditions, and the financial stability of the company.

Participant accounts and "rollovers"

Each participant's account is credited with the participant's contributions and allocations of a) the employer's matching and discretionary contribution, b) plan earnings and c) charged with an allocation of plan administrative expenses. Allocations of plan earnings are based on participant account balances, as defined, and an allocation of company discretionary contributions is based on participant compensation, as provided in the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

Vesting

Participants are vested immediately in their contributions and safe harbor non-elective contributions plus actual earnings thereon. Vesting in the employer's discretionary contribution portion of their accounts is based on years of continuous service. Participants vest over a five year period a rate of 25% per year starting in year two. Participants who leave the plan because of death or disability, as defined in the plan, are considered 100% vested in all amounts.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate that is determined as 1% over the Prime Rate (7.50% at December 31, 2024) set by the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest is paid ratably through payroll deductions.

Benefits

On termination of service due to death, disability, retirement (age 65), or termination of service due to other reasons, a participant with an accounting valued at less than \$5,000 shall receive the value of the vested interest in their account as a lump-sum distribution. For accounts exceeding \$5,000, the participant may elect a lump-sum distribution, installment payments for requirement minimum distribution purposes only, defer such distribution to any valuations date subjected to his or her retirement date, or elect to rollover the distribution to another qualified plan. The plan permits in-service distributions at age 59 ½. The plan also permits hardship distributions if certain criteria are met.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$49,348 and \$14,469, respectively. Forfeited account balances can be used to pay plan expenses or reduce employer discretionary contributions. Forfeitures were used to reduce plan expenses by \$3,187 in 2024.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments valuation and income recognition

The plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's 401(k) Committee determines the plan's valuation policies utilizing information provided by the investment advisors, and asset custodian. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the plan are paid directly by the employer and are excluded from these financial statements. The major administrative expenses are record keeping, investment and professional fees.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions and adjustment to net appreciation in the fair value of investments. The plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Subsequent event

These financial statements have not been updated for subsequent events occurring after October 10, 2025, which is the date these financial statements were available to be issued. The plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

NOTE B -- Information certified by the asset custodian and trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation, other income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity, the asset custodian and trustee of the plan.

NOTE C -- Fair value measurements

The plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Money market fund. Valued based on quoted net asset values of the shares held by the plan at year end.
- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

NOTE D -- Party-in-interest transactions

Certain Plan investments are managed by Fidelity (“the provider”). The provider is the trustee, asset custodian and recordkeeper of the plan, and therefore, these transactions qualify as party-in-interest transactions.

The provider provides certain administrative services to the plan pursuant to a Master Plan Services Agreement (“MSA”) between the company and the provider. The provider receives revenue from mutual fund service providers for services the provider provides to the funds. This revenue is used to offset certain amounts owed to the provider for its administrative services to the plan.

If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts will be allocated to the accounts of the participants. During 2024, excess amounts totaled \$617 and are recorded as other income on the Statement of Changes in Net Assets Available for Benefits. The Plan or Plan Sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

NOTE E -- Concentration of market risk

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE F -- Tax status

The company adopted the FMR, LLC Non-Standardized Pre-Approved Profit Sharing Plan, effective November 15, 2023, received a favorable opinion letter from the IRS on June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The plan has been restated since the date of the opinion letter. However, the plan administrator and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the plan was qualified and related trust was tax-exempt as of the financial statement date.

NOTE G -- Plan termination

Although it has not expressed any intent to do so, the employer has the right under the plan to discontinue their contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will be 100% vested in their allocated employer discretionary profit-sharing contributions.

NOTE H -- Excess contributions payable

The plan failed the discrimination testing for the year ended December 31, 2023. Excess contributions amounting to \$13,732 are recorded as a liability in the accompanying Statements of Net Assets Available for Benefits and as a reduction to participant-directed contributions for the year and adjustment to net appreciation in fair value of investments. The plan has reimbursed these excess contributions to its participants prior to March 15, 2024. For purposes of the Form 5500, these excess contributions are not recorded until the year paid.
