INDEPENDENT AUDITORS' REPORT

To the Trustees
The Reliable of Milwaukee 401(k) Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of The Reliable of Milwaukee 401(k) Retirement Savings Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from Transamerica Life Insurance Company as of December 31, 2024 and 2023 and for the year ended December 31, 2024 and for the period from December 5, 2023 to December 31, 2023, from Reliance Trust Company as of December 31, 2023 and for the period from December 5, 2023 to December 31, 2023 and for the period from January 1, 2024 to June 30, 2024, from Transamerica Trust Company as of December 31, 2024 and for the period from July 1, 2024 to December 31, 2024 and from Minnesota Life Insurance Company for the period from January 1, 2023 to December 4, 2023 stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits do not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the plan's ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

ERISA-Required Supplementary Information

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - The Reliable of Milwaukee 401(k) Retirement Savings Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through October 8, 2025, which is the date the financial statements were available to be issued.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Key parties of the plan - Reliable of Milwaukee is the plan sponsor, employer and the plan administrator. Prior to December 5, 2023, Minnesota Life Insurance Company ("Minnesota Life") was the investment agent and custodian of plan assets and Securian Financial Group, the parent of Minnesota Life, was the third-party administrator that maintained participant records and tax counsel that performed various compliance tests. Effective December 5, 2023, Reliance Trust Company ("Reliance") became the custodian of the plan's mutual fund and common/collective trust investments and Transamerica Life Insurance Company ("Transamerica Life") became the custodian of the plan's stable value fund investment. Transamerica Retirement Solutions, LLC ("Transamerica Retirement") became the investment agent that maintains investment and participant records and tax counsel that performs various compliance tests. Effective July 1, 2024, Transamerica Trust Company ("Transamerica Trust") assumed the role of the custodian that holds the plan's mutual fund and common/collective trust investments. Transamerica Life, Transamerica Retirement, Reliance and Transamerica Trust are collectively referred to as "Transamerica". Minnesota Life and Transamerica are collectively referred to as the "custodians". The plan was also amended in December 2023 to remove NitroGolf LLC as a participating employer. Equitable Advisors is the plan's investment advisor. Two officers of the plan sponsor are the plan trustees.

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings, including the net appreciation (depreciation) in the fair values of investments bought, sold or held during the years, are reflected in the accompanying statements of changes in net assets available for benefits. Participants should refer to the investment account summaries and prospectuses for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds - The mutual funds are valued at the daily quoted market prices as reported by the funds. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Common/collective trust - The common/collective trust is valued at the NAV based on units of the common/collective trust, which is included within a combined direct filing entity. The NAV, as provided by Transamerica Trust, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the common/collective trust less its liabilities. The practical expedient would not be used if it is determined to be probable that the fund would sell the investment for an amount different from the reported NAV.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

Investment at contract value - The plan has a fully benefit-responsive investment contract through a group annuity contract issued by Transamerica Life. This is an investment based on the general unallocated account of Transamerica Life. Transamerica Life pays interest and guarantees the plan's capital deposit regardless of the activity in the general account. The investment is not considered a Guaranteed Investment Contract or Common/Collective Trust as there are no specific underlying securities and no stated minimum or maximum interest rates. The investment, as a deposit liability of Transamerica Life with no underlying assets, has no direct investments on behalf of the plan. The investment value is based on the general unallocated account of Transamerica Life and the risk of investment is based on Transamerica Life's insurance ratings. The effective annual interest rate is established every six months. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. The average yield earned by the fund was 2.26% in 2024 and 1.62% in 2023.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Transamerica Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. Although plan participants may direct withdrawals at any time without restrictions, a hold can apply in the event the plan sponsor requests a full distribution from the investment. The plan has no intention to request a full distribution as of the date these financial statements were available to be issued.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements were available to be issued, the plan sponsor was not aware of any events that are probable of occurring that may limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following description of the plan provides only general information. Participants should refer to the plan documents for a more complete description of the plan's provisions.

General - The plan was adopted effective January 1, 2018 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - All employees who have attained the age of twenty-one and have completed six months of service are eligible to participate in the plan. The service period was previously three months prior to the plan being amended in December 2023. An employee can enter the plan on the first day of the month after meeting the eligibility requirements.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made in the following ways:

- a. Participants may contribute a percentage of their compensation subject to certain limitations (elective deferral contributions). The plan also permits Roth elective deferral contributions. After meeting the eligibility requirements, new employees are automatically enrolled in the plan and have 4% of compensation withheld as elective deferral contributions. Effective January 1, 2024, the automatic deferral contribution was increased to 6% and the plan added a deferral escalation feature in which these participants' deferral percentages automatically increase by 1% each year until they reach a maximum of 10%. Participants have the option to increase, decrease or stop their deferral percentage by completing the necessary documentation.

- b. Rollover contributions are accepted by the plan from other qualified plans.
- c. Employer matching contributions may be made at the employer's discretion. Employer matching contributions equal to 25% of the first 4% of employee compensation contributed to the plan as elective deferral contributions were made in 2024 and 2023. These contributions are funded coinciding with the employer's payroll.
- d. Employer nonelective contributions may be made at the employer's discretion. No employer nonelective contributions were made in 2024 and 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of the employer's contribution. Participants are allowed to change their investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants accounts are always 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon termination of employment, death, disability or attainment of normal retirement age. Distributions may be in the form of a single lump sum, partial or installment payments. In-service withdrawals can commence upon attaining the age of 59½. In addition, hardship withdrawals are permitted under certain circumstances.

Administrative expenses - Certain administrative expenses of the plan are paid by the employer. Certain other administrative expenses are paid by the plan from plan assets and recorded as administrative expenses in the accompanying financial statements. Such expenses include participant directed charges for distribution and loan fees and nonparticipant directed charges for service and administrative fees. Nonparticipant directed charges are allocated to the participants on an account value basis.

Notes receivable from participants - Participants may obtain loans from their accounts with the approval of the plan administrator. The required minimum loan amount is \$1,000 and the maximum loan amount is the lesser of \$50,000 or 50% of the vested account balance. Participants may only have one loan outstanding at any given time. The maximum loan term for a general purpose loan is five years. The loan terms may be extended if the loan proceeds are used to purchase a primary residence. Notes receivable from participants are secured by the balance in the participant's account and bear interest at rates set by the plan administrator. As of December 31, 2024, the notes receivable from participants have various repayment schedules through August 2028 with interest rates from 4.25% to 9.50%. The notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value.

3. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were/are managed by Minnesota Life/Transamerica. Minnesota Life/Transamerica was/is the custodian of certain plan assets, as defined in Note 1, and, as such, these transactions qualify as party-in-interest transactions. In addition, these parties provided/provide certain administrative services to the plan pursuant to a service agreement between the plan sponsor and the custodians in which they received/receive indirect compensation from mutual fund service providers for services provided to the funds. This indirect compensation is used to offset certain amounts that would otherwise be owed for its administrative services to the plan. Direct fees paid by the plan to Minnesota Life/Transamerica were \$38,000 in 2024 and \$12,000 in 2023.

Notes receivable from participants also qualify as party-in-interest transactions.

All of the above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

4. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the plan subject to the provisions of ERISA and subsequent amendments.

5. INCOME TAX STATUS

Prior to December 5, 2023, the plan was operating under a Minnesota Life non-standardized pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. Effective December 5, 2023, the plan adopted a Transamerica Retirement Solutions, LLC non-standardized pre-approved profit sharing plan that received a favorable opinion letter on June 30, 2020. The letters from the Internal Revenue Service stated that the plans, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken by the plan that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023.
