## INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of the  
401(k) Profit-Sharing Plan for Employees of FCN Bank, National Association

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 401(k) Profit-Sharing Plan for Employees of FCN Bank, National Association, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be

independent of the 401(k) Profit-Sharing Plan for Employees of FCN Bank, National Association and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## 1. DESCRIPTION OF PLAN:

The following description of the 401(k) Profit-Sharing Plan for Employees of FCN Bank, National Association (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan established July 1, 1987, covering all eligible employees of FCN Bank, National Association (the Bank or Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC) of 1986, as amended (the Code).

There are no minimum age or service requirements to be eligible to participate in the Plan. Employees meeting eligibility requirements may enroll in the Plan on the first day of the month following the date of hire on which the eligibility requirements are fulfilled. To be eligible for employer contributions, employees must be at least 20.5 years of age and have completed 1 year of service and worked at least 1,000 hours within that 12-month period.

### **Contributions**

Each year, participants may contribute up to the maximum annual dollar limit permitted by law of pre-tax compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows Roth contributions. The combined pre-tax and after-tax contributions cannot exceed established Internal Revenue Service (IRS) limits. Additionally, the Plan accepts direct rollovers from other qualified plans and arrangements, and rollover contributions from participants. Contributions are subject to certain limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

In 2024, the Bank contributed matching contributions in an amount equal to 100% of the first 4% of compensation contributed by the participant. Employer discretionary profit-sharing contributions may be made on behalf of eligible participants. The Company elected not to make any discretionary contributions for 2024.

### **Participant accounts**

Each participant's account is credited with the participant's contributions and employer matching contributions, employer discretionary contribution, as well as allocations of plan earnings and losses. Participant accounts may also be charged with an allocation of certain administrative expenses of the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the vested amount that is in such participant's account at any given time.

### **Vesting**

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Bank's matching and profit-sharing contributions portion of their accounts, plus actual earnings thereon, is based on years of service. A participant is 100% vested in the Bank's matching and profit-sharing contributions after three years of credited service as follows:

### **Notes receivable from participants**

Participant loans are not permitted under the provisions of the Plan.

### **Payment of benefits**

Upon a participant's retirement, death, total or permanent disability, or other termination of employment with the Bank, the participant's vested account is distributed in single lump sum payment. Participants may also request a non-recurring partial payment.

In-service distributions are permissible from the Plan for participants that have obtained the age of 59 1/2. Participants electing in-service distributions may elect to receive all or a portion of their elective deferral contributions in a lump sum payment.

In conditions of financial hardship, as defined by the Plan, a participant may apply to the plan administrator for approval to withdraw that portion of their elective deferrals necessary to meet the financial hardship, subject to the limitations of the Plan and the IRC.

### **Forfeitures**

In the event a participant terminates employment prior to 100% vesting, the portion of the employer contributions which is not vested is forfeited at that time. The forfeited amounts may be used to reduce future employer contributions. There were no forfeited non-vested accounts available to offset future employer contributions at both December 31, 2024 and 2023. During 2024, there were no forfeitures used to offset employer contributions.

## **2. SUMMARY OF ACCOUNTING POLICIES:**

### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein at the date of the financial statements. Actual results could differ from those estimates.

### **Investment valuation and income recognition**

The Plan's Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits**

Benefit payments to participants are recorded when paid.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid directly by the Bank and are excluded from these financial statements. Fees related to the participant directed transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

**3. CERTIFIED INVESTMENT INFORMATION:**

The Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America Life Insurance Company, a qualified institution, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024, and to the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**4. FAIR VALUE MEASUREMENTS:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

*Mutual and money market funds:* Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's cash and investments at fair value. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

#### **5. INSURANCE COMPANY GENERAL ACCOUNT:**

The Plan's investment in the Mutual of America Interest Accumulation Account is an unallocated contract with The American Life Insurance Company of New York. Mutual of America Life Insurance Company maintains the contributions in a general account. This fund is considered to be a cash equivalent due to holding instruments such as interest-bearing cash. The value within the plan is \$1,217,023 and \$1,131,019 at December 31, 2024 and 2023, respectively.

The amount in this account at any time will be equal to the sum of all amounts that have been allocated to it less the sum of all amounts that have been withdrawn. The contract has no extraordinary transfer or withdrawal restrictions.

The contract issuer is contractually obligated to repay the principal and a separate rate of interest that will be declared from time to time by the insurance company in its discretion. Crediting interest will be allocated no less frequently than once in a calendar month to amounts within the account. The crediting interest rate will not be less than 3%.

#### **6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:**

Certain Plan investments are invested in funds managed by Mutual of America Life Insurance Company; therefore, these transactions qualify as party in interest. Total fees paid by the Plan to Mutual of America Life Insurance Company for the year ended December 31, 2024 were \$701.

Several employees of the Bank provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Bank for the services of the employees to the Plan.

#### **7. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Bank's contributions.

#### **8. TAX STATUS:**

The Bank adopted a prototype non-standardized profit-sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the IRS dated November 30, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has since been amended. While the Plan has not obtained its own determination letter, the plan administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **9. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **10. PLAN AMENDMENT CARES ACT:**

On March 27, 2020, the U.S. Congress passed the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provided temporary relief for retirement plan sponsors and their participants with respect to distributions and participant loans during 2020. The provisions of the CARES Act could be effective and operationalized immediately, prior to amending the plan document. The Bank elected not to adopt the optional provisions of the CARES Act.
