Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 – Description of Plan**

The following description of the Washington Auto Mall 401(K) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General: The Plan is a defined contribution plan covering all full-time employees of Washington Automobiles, Inc. d/b/a South Hills Toyota (the Company), Washington Honda, and Washington Hyundai, who have 90 days of service, have reached age 21 and are paid by the employer.

Employee Contributions: Participants may elect to defer up to 100% of pretax compensation, as defined in the Plan, not to exceed statutory limitations. Participants may also contribute rollovers, from other qualified plans. All contributions, including the employer contributions, may be directed at the discretion of each participant into the various investment options offered by the Plan. Effective October 1, 2019, the Plan adopted an automatic enrollment provision. All eligible participants are automatically enrolled in the Plan unless the employee elects otherwise.

Employer Contributions - The Company may match a discretionary percentage of the participants' salary reductions as determined annually. The employer matching contribution is calculated and remitted each payroll period. The employer matching contribution for the year ending December 31, 2024 was \$88,232. The Company may also contribute a discretionary amount to the Plan. Any discretionary employer contribution is calculated at the end of the Plan year and are allocated to eligible participants that completed 1,000 hours and were employed by the Company as of the last day of the Plan year. These requirements are waived in the event of death, disability, or retirement of a participant. There was no discretionary employer profit sharing contribution for the year ending December 31, 2024.

Participant Accounts: Each participant's account is credited with (a) the participant's contributions, (b) the Company's contribution, (c) forfeitures, (d) plan earnings or losses, and (e) charged with an allocation of administrative expense. Allocations are based on participant earnings or account balances as defined. Forfeited balances of terminated participant's nonvested accounts are allocated in the same manner as the employer's contribution. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. The following vesting schedule is used for the Company's discretionary contributions:

If a participant's employment is terminated due to death, disability, or retirement, all amounts credited to the participant's account shall become fully vested.

Payment of Benefits: On termination of services, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in their account.

**Note 1 – Description of Plan (continued)**

**Forfeited Accounts:** Forfeitures represent participant account balances that are not vested upon the termination of an employee. All forfeited amounts can be added to the employer's discretionary contribution, be used to reduce the employer contribution, or be used to pay plan expenses. Forfeitures of \$6,143 were used to reduce the employer contribution and forfeitures of \$549 were used to pay plan expenses during 2024. There were no unallocated forfeitures as of December 31, 2024 and 2023.

**Administrative Expenses:** The employer absorbs substantially all costs of the Plan. Investment advisor and manager fees are allocated to the participants' accounts. Fees for transactions such as distributions and loans are credited to the participant's account to which the fee applies.

**Notes Receivable from Participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at one time. Borrowings are considered to be collectible as they are secured by the balance in the participants' accounts. Interest is charged at a commercially reasonable rate as defined in the plan document. Interest rates ranged from 4.25% to 10.50% at December 31, 2024 and 2023. Loan interest earned by the Plan amounted to \$6,251 at December 31, 2024. Principal and interest is paid ratably through semi-monthly payroll deductions. Repayment terms may not exceed 5 years unless the loan is granted for the purpose of acquiring the participant's principal residence.

**Excess contributions:** Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding deduction in net assets recognized in the statements of changes in net assets available for benefits. A liability of \$3,463 and \$0 has been recognized at December 31, 2024 and 2023, respectively.

**Note 2 – Summary of Accounting Policies**

**Basis of Accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Investments:** Investments are valued at fair value or contract value (Note 10). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during year.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Contributions –** Participants' elective deferrals and Company contributions are recognized as additions to Plan assets in the year designated by the participant and Company, respectively.

**Payment of Benefits:** Benefits are recorded when paid.

**Subsequent Events:** The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**Note 3 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**Note 4 – Tax Status**

The Plan obtained a favorable advisory letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirement of the Internal Revenue Code. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the Plan's tax counsel believe that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 5 – Information Certified by the Plan's Custodian**

For the years ended December 31, 2024 and 2023, the plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal Trust Company, the custodian of the Plan, as complete and accurate, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

**Note 6 – Guaranteed Investment Contract**

The Plan holds a traditional guaranteed investment contract with the custodian. This investment meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions plus credited interest less participant withdrawals and fees. The account is credited with earnings based on the daily balance. There is no stated minimum or maximum interest rate for the investment choice.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**Note 6 – Guaranteed Investment Contract (continued)**

Certain events may limit the ability of the Plan to transact at Contract Value. Such events include but may not be limited to the following: (1) the complete or partial termination of the Plan; (2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including the removal of a group of employees from Plan coverage as a result of the sale or liquidation of a subsidiary or division or as a result of group layoffs or early retirement programs.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different than the contract value. The issuer will terminate the contract under the following circumstances: (1) any representation by the Plan becomes untrue, in a manner that materially affect the issuer's obligations and risks under the Contract, or the Plan breaches any material obligation under the Contract; (2) any entity acting as agent on behalf of the Plan fails to provide information and records requested by the issuer; (3) the Plan or person acting on behalf of the plan influencing a participant to withdraw from the fund; (4) the adoption of an amendment to the Plan or changes in practices or participant withdrawal rights that may be materially adverse to the issuer's obligations under the contract; (5) the participant retains a recordkeeper other than Principal Life Insurance Company and there is a misrepresentation of the Recordkeeper's enforcement of certain contract terms.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

**Note 7 – Party-in-Interest Transactions**

Certain plan assets are managed by the custodian. Therefore, these transactions qualify as exempt party-in-interest transactions. Additionally, asset-based fees paid by the Plan to the Custodian and investment advisor are party-in-interest transactions. These expenses, which are paid as a total amount to the Custodian, amounted to \$23,834 for the year ended December 31, 2024. Fees paid by the Plan for third party administration and participant-initiated transactions were \$5,146. Certain administrative fees related to the administration of the Plan were paid by the Company. These transactions qualify as party-in-interest transactions and are exempt from the IRC and ERISA's rules on prohibited transactions.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9 – Plan Amendment**

There were no plan amendments during the years ended December 31, 2024 and 2023.

**Note 10 – Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASB 820-10 are:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments measured at fair value:

Mutual funds are valued at the net asset value of shares held by the Plan at year end. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts (PSAs) invest in mutual funds and equity securities. PSAs are valued daily at their accumulation unit value multiplied by number of units held. The accumulation unit value determined daily based on the net asset value of shares of the underlying fund as provided by the Custodian.

Noninterest – bearing cash is determined based upon the deposit value as reported at year-end.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
