## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and participants of the  
Pratt Industries, Inc. 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Pratt Industries, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### 1. Description of Plan

The following description of the Pratt Industries, Inc. 401(k) Profit Sharing Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering eligible employees of Pratt Industries, Inc. and certain affiliated companies (collectively, the Company), as defined in the Plan document. All employees except certain leased and temporary employees are eligible to participate in the Plan. Employees are eligible to participate in the Plan on the first day of the payroll period after completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

An employee is automatically enrolled in the Plan at a pre-tax contribution rate of 3% of eligible compensation, beginning the first payroll period following the 30th day after he or she first satisfies the Plan's eligibility requirements, unless the employee elects otherwise. The Plan allows for an automatic increase of 1% of participant contributions annually up to a maximum of 8%, unless the employee elects otherwise. Each participant may make pre-tax and/or Roth contributions of up to 100% of eligible compensation as defined by the Plan document, generally not to exceed a maximum of \$23,000 in 2024, plus a catch-up contribution of up to \$7,500 for participants age 50 and older by the end of the Plan year. Additionally, the Plan allows participants to make after-tax contributions. In 2024, a participant may have total contributions to the Plan in the amount of \$69,000, or \$76,500 including catch-up contributions. The contributions will be invested in a target date fund based on the employee's date of birth and anticipated retirement at age 65, unless the participant directs otherwise. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company provides a safe-harbor matching contribution equal to 100% of the first 1% of participant deferrals and 50% of participant deferrals for the next 5% of eligible compensation. The Company may also make a discretionary profit-sharing contribution on behalf of eligible employees. In order to be eligible for discretionary profit-sharing contributions, an employee must be employed on the last day of the Plan year and work at least 1,000 hours during the Plan year. For 2024, the Company did not elect to contribute discretionary profit-sharing contributions.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, and earnings and losses on the investments in their account, and is charged for certain administrative expenses. Upon enrollment in the Plan, a participant may direct

contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Vesting in the Company contributions portion of their accounts is based on years of continuous service. Participants vest 100% in employer safe-harbor matching contributions after two years of service. Participants vest 20% after two years of service, 60% after three years of service, then 20% per year thereafter until they are 100% vested after five years in employer matching contributions made prior to January 1, 2023 and employer discretionary profit-sharing contributions. The Plan allows for recognition of service with some prior employers, as stated in the Plan document. All amounts will become fully vested upon the participant's attainment of normal retirement age, disability, or death.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,028,405 and \$503,729, respectively. Forfeitures are used to reduce the Company's contributions to the Plan or pay Plan administrative expenses. In 2024, \$625,903 of forfeitures were used to reduce the Company's contributions and no forfeitures were used to pay Plan administrative expenses.

### **Payment of Benefits**

At the time of retirement, death, disability, or termination of employment, a participant or their beneficiary, whose vested balance exceeds \$7,000, may elect to receive payment of the vested interest in their account in a lump sum distribution or installment payments. If the account balance is \$7,000 or less, the participant will automatically receive a lump sum distribution equal to the value of their account. In-service withdrawals are also permitted for participants who have attained age 59½. The participant's contributions may also be withdrawn for certain hardship situations.

### **Administrative Expenses**

The Company pays all administrative expenses of the Plan that are not paid by participants. The Company does not expect reimbursement from the Plan for any expense paid on behalf of the Plan. Administrative expenses for advisory services, recordkeeping, and certain participant transaction fees are paid by participants. Expenses are allocated proportionately based on the participants' account balances. Certain expenses specifically incurred by a participant, such as fees for taking a withdrawal from the Plan, are paid directly by that participant. These expenses are paid to service providers of the Plan and therefore qualify as party-in-interest transactions.

The Plan has established an ERISA account where the qualified institution deposits revenue sharing payments that are used to pay Plan administrative expenses. The account had an available balance of \$11,520 and \$10,920 as of December 31, 2024 and 2023, respectively, which is included in the stable value funds on the statements of net assets available for benefits. During 2024, \$600 of investment earnings was deposited into the account, and no expenses were paid from the account. Deposits to this account are included in net change in fair value of investments in the accompanying statement of changes in net assets available for benefits. Payments from this account are included in administrative expenses in the year paid. Fees incurred by the Plan for investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have one note outstanding at any time. The notes are secured by the balance in the participant's account and must bear a reasonable rate of interest as defined in the Plan document. During 2024, notes had fixed rates ranging from 4.25% to 9.50% for the term of the note, not to exceed 5 years unless the note is in connection with the participant's principal residence. Principal and interest are paid through payroll deductions.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The employer safe-harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. The discretionary employer profit-sharing contributions are considered payable to the Plan when approved to be paid by the Company.

### Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, realized and unrealized gains and losses on those investments, and fees charged for investment management and administrative services on those investments. Interest income is recorded when received.

### Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received, primarily monthly. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants qualify as party-in-interest transactions.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

The Plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

### 3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Bank of America, N.A. (Bank of America), the Plan's qualified institution.

### 4. Investments and Fair Value Measurements

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply

chain disruptions, global monetary policy decisions, significant exogenous economic influences, and significant cybersecurity attacks. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in stable value funds. Each stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The stable value funds trade daily at their net asset value (NAV) which is based on the contract value of the underlying investments (Level 1).

Investments in the common/collective trust are valued daily using its NAV. The NAV is based on the fair value of the mutual funds, stocks, debt instruments, and other securities in the account. Participants can trade the common/collective trust daily at the published NAV (Level 1).

### 5. Income Tax Status

The Plan is based on a non-standardized pre-approved profit sharing plan (pre-approved plan) created by Merrill Lynch Pierce Fenner & Smith Inc (Merrill Lynch). The Internal Revenue Service has determined and informed Merrill Lynch by a letter dated June 30, 2020, that the pre-approved plan document is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not received an individual determination letter, and has been amended, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, accordingly, has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by tax authorities and may change upon examination.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA and discontinue all contributions. In the event of Plan termination, participants will become fully vested in their Company contributions.
