## INDEPENDENT AUDITORS' REPORT

**To the Trustees of the  
Adjmi Apparel Group Retirement Program:**

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Adjmi Apparel Group Retirement Program (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Adjmi Apparel Group Retirement Program's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 and Note 4 to the financial statements, is complete and accurate.

### *Opinion*

## ***Responsibilities of Management for the Financial Statements***

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the Adjmi Apparel Group Retirement Program (the "Plan") provides only general information. Plan participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a qualified defined contribution plan covering all eligible employees, not covered by a collective bargaining agreement, of The Adjmi Apparel Group ("Principal Employer"), IFG Corp., Sister Sister Inc., Beluga, Inc., Consolidated Childrens Apparel, Inc., Sports Products of America, LLC, Mag Brands, LLC, J.T. Rose and Company, LLC, Fuller Road Enterprises Inc. and Copper Compression, LLC and any trade or business which, with the consent of the Principal Employer, becomes a party to the Plan, and any successor trade or business which assumes the obligations of the Plan (collectively, the "Employer" or "Company"). The Plan provides for retirement and death benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Company's Retirement Committee ("Committee"), which is a committee consisting of members of management of the Company and the Plan administrator. The Committee is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's executive management.

#### **Eligibility**

All employees who have attained the age of twenty-one with ninety days of service are eligible to participate in the Plan and are eligible for employer contributions. An employee can enter the Plan on the first day of the quarter coincident with meeting the eligibility requirements.

#### **Participant Contributions**

Each participant of the Plan can elect to contribute a percentage, not exceeding 100% of their compensation as pretax and Roth elective contributions, provided such amount will not cause the Plan to exceed certain limitations prescribed by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing pretax distributions from other qualified defined benefit or defined contribution plans (rollover). Additionally, participants who have attained age fifty or older before the end of the Plan year are allowed to make catch-up contributions as defined in the Plan.

### NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

#### Employer Contributions

The Employer can make discretionary contributions including matching contributions as defined in the Plan document. The Employer's matching contribution was 25% of the first 6% of compensation calculated each pay period of 2024. The Plan also provides for a discretionary profit-sharing contribution in an amount, if any, to be determined by the Employer. For the year ended December 31, 2024, a discretionary profit-sharing contribution of \$145,955 was contributed to the Plan. There was no profit-sharing contribution made for the year ended December 31, 2023.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's matching and discretionary profit-sharing contributions are based on years of continuous service. A participant will have a fully (100%) vested interest in his matching and discretionary profit-sharing contributions account in the event of death or disability. A participant is 100% vested after six years of credited service according to the following schedule:

#### Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's matching contribution, profit-sharing contribution, Plan earnings and are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

#### **Payment of Benefits**

In the event of a participant's death, disability or retirement, the participant or their beneficiary shall be entitled to receive the participant's entire participant balance. For termination of service due to other reasons, the participant is entitled to receive their vested participant balance. A participant or beneficiary who is entitled to receive a distribution may elect to receive either a lump-sum payment, a nontransferable annuity payable over the lifetime of the participant or their beneficiary, or equal installments over a certain period not more than the life expectancy of the participant or their beneficiary. The transfer to a participant of any life insurance policy, or the surrender of any policy on the participant's life for its cash value may be distributed in a lump sum or in installments. If the participant's total distribution is \$5,000 or less, the payment is made in a lump sum.

Under certain circumstances (hardship), and with approval of the Company, a participant can elect at any time to receive a portion of his or her vested account balance subject to the provisions of the Plan.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct their basic and matching contributions in increments of 1% in various investment options. Participants may change their investment options daily.

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loan is secured by the balance in the participant's account and bears interest at the prime rate plus 2% as of the date of the loan unless otherwise determined by the Plan trustee. The term of the loan is not to exceed five years unless the loan is used to buy or build a participant's principal residence, in which case the term cannot exceed beyond the normal retirement age of the participant or twenty years, whichever is earlier. Principal and interest are paid either ratably through payroll deductions or directly from the borrower and credited to the borrower's account balance. Participants may not have more than two loans outstanding at any time.

### NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

#### **Forfeited Accounts**

Forfeitures of the non-vested portion of the participant's matching contributions are first used to pay administrative expenses and if not used shall be applied to reduce the contributions of the employer. As of December 31, 2024 and 2023, there were \$11,334 and \$7,502, respectively of forfeited non-vested accounts. During the year ended December 31, 2024, \$22,892 of forfeitures from non-vested accounts were used to reduce employer contributions.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 4 for further discussion on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Contributions**

Contributions from Plan participants and the matching and profit-sharing contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged to the participant's accounts. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

#### **Plan Expenses**

In accordance with the Plan, all administrative expenses may be paid out of the Plan unless paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

### NOTE 3 - CERTIFIED INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

### NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED)

The Plan measures fair value in accordance with Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820, "Fair Value Measurement," which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan also utilizes a practical expedient to estimate the fair value of investments that have calculated net asset value ("NAV") per share. Accordingly, the Plan estimates the fair value of an investment using the NAV of the investment (or its equivalent) without further adjustment unless the Plan determines that the NAV is deemed to be not reflective of fair value.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

### NOTE 4 - FAIR VALUE MEASUREMENTS (UNAUDITED) (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. In evaluating the level at which the Plan's investments have been classified, the Plan has assessed factors including, but not limited to price transparency, the ability to redeem at NAV at the year-end and the existence or absence of certain restrictions at year-end.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual funds:*** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Common collective trust fund:*** Valued based on the NAV of units of the collective trust's underlying investments. The NAV, as provided by the trustee/custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Interests in each fund are represented by units of beneficial interest. Each unit represents an equal pro rata interest in the net assets of a fund. The investment objective is to seek a total return consisting of long-term growth of capital and current income, consistent with the investment strategy of an investor who expects to retire in the respective target year. There are no unfunded commitments with respect to the common collective trust.

The fund generally provides for daily redemptions by the Plan at reported NAV per share, without any advance notification. The fund may in its sole discretion, impose restrictions on issues and redemptions of units. The Plan Administrator does not believe that the occurrence of any such event is probable.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are funds managed by Fidelity Trust Company and its affiliates. Fidelity Trust Company is the custodian and trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.

### **NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

### **NOTE 7 - TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). Although the plan has been amended since adopting the pre-approved plan document. The plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require adjustment or disclosure in the financial statements. The Plan is subject to routine audits by IRS; however, there are currently no audits for any tax periods in progress.

### **NOTE 8 - RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 9 - SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
