Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of GreatAmerica Financial Services Corporation 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of GreatAmerica Financial Services Corporation 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

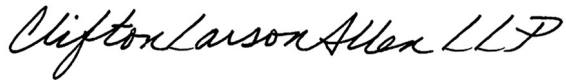

NOTE 1 DESCRIPTION OF PLAN

The following description of the GreatAmerica Financial Services Corporation 401(k) Profit Sharing Plan (the Plan) is provided for informational purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of GreatAmerica Financial Services Corporation (the Company) who meet the eligibility criteria described below. The Plan was originally established on January 1, 1994. The Company serves as the Plan Administrator and is responsible for the control and management of the operation and administration of the Plan. Bank of America, N.A. (Bank of America) serves as custodian, recordkeeper and trustee of the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was restated effective January 1, 2022. The restatement was made primarily to reflect periodic regulatory and legislative updates, as required on a periodic basis by the Internal Revenue Service (IRS). Bank of America received an opinion letter dated June 30, 2020, which states that this restated prototype plan document satisfies the applicable provisions of the Internal Revenue Code.

Eligibility

Employees are automatically enrolled in the Plan once eligible. Employees are also eligible to receive Company matching contributions on the first day of the calendar quarter after their hire date. Employees become eligible for Company profit sharing contributions on the first day of the calendar quarter subsequent to the employee's satisfaction of the Plan's service requirement of one year of employment; however, the employee must be employed on the last day of the Plan year in order to receive an allocation of the Company's profit sharing contributions, subject to certain exceptions.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants may contribute up to 100% of pretax or after-tax (which may include Roth contributions) annual compensation, as defined by the Plan, subject to certain IRC limitations. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, including annual automatic escalations, unless they affirmatively elect not to participate in the Plan and/or the automatic escalations. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, with annual automatic escalations of 1% of eligible compensation (capped at 10% of eligible compensation), and their contributions invested in the designated default fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollovers from other qualified benefit plans.

Contributions (Continued)

The Company's matching contribution is discretionary and is determined at the beginning of each plan year. For the year ended December 31, 2024, the Company match was 50% of the first 10% of eligible compensation a participant contributed to the Plan. The Company may also make profit sharing contributions at its discretion. The Company made profit sharing contributions of 4% of eligible compensation to all eligible employees for the year ended December 31, 2024.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit sharing contribution, and an allocation of Plan earnings. Participant accounts are charged with withdrawals, an allocation of administrative expenses that are paid by the Plan, and an allocation of Plan losses. Allocations are based on participant compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus earnings or losses thereon. Vesting in the Company matching and profit sharing contribution portion of their accounts, plus earnings and losses thereon, is based on years of credited service. A participant is 100% vested after five years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. Loans bear interest at rates equal to the prime rate as printed in the *Wall Street Journal* for the last business day of the month immediately preceding the date of the loan. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

Upon termination of service, a participant is entitled to receive his or her vested account balance in the form of a lump sum distribution, installment payments, or a joint and survivor annuity if the vested account balance exceeds \$1,000. If the vested account balance does not exceed \$1,000, the participant will receive the distribution in a lump sum. If the vested account balance exceeds \$1,000 but is \$7,000 or less, the Plan will pay the distribution as a direct rollover to an individual retirement account designated by the Plan Administrator. The Plan also allows for in-service withdrawals once a participant reaches age 59½, and hardship withdrawals subject to Plan provisions.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce Company contributions and then are used to offset the Plan's administrative expenses, with any remaining amounts allocated to participants. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$128,231 and \$4,783, respectively. There were \$206,400 of forfeitures used to reduce Company contributions during the year ended December 31, 2024. There were no forfeitures allocated to participants for the year ended December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds, collective funds, and the stable value fund are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions based on the terms of the Plan.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Plan administrative expenses are paid from direct participant fees which are deducted from participant accounts on a quarterly basis. Product fees, including loan set-up and maintenance fees and distribution fees, are charged to participant's accounts directly.

Subsequent Events

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Bank of America, the trustee of the Plan, has supplied the Plan Administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Funds: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. See Note 5 for a more detailed description of the stable value fund.

Money Market Fund: Investments in the money market fund are valued at the daily closing price as reported by the fund.

NOTE 5 STABLE VALUE FUND

The stable value fund (the Fund) is a collective trust fund established by Putnam. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund's constant NAV of \$1 per unit. Distributions to the Fund's unit holders are declared daily from the net investment income and automatically reinvested in the Fund when paid. It is the policy of the Fund to use its best efforts to maintain a stable NAV of \$1 per unit, although there is no guarantee that the Fund will be able to maintain this value. The Fund is reported at fair value in the statements of net assets available for benefits.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 8 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the prototype Plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore not subject to tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
