We have performed audits of the financial statements of Central Ohio Primary Care Physicians, Inc. Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 – DESCRIPTION OF PLAN

The following description of the Central Ohio Primary Care Physicians, Inc. Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Central Ohio Primary Care Physicians, Inc. (“the Company”) who have attained age 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions: Each year, participants may voluntarily contribute a portion of their pretax or after-tax annual compensation, as defined by the Plan. Participants may contribute employee deferrals up to the maximum amount allowed by law. The Plan allows participants who have attained age 50 by the end of the Plan year to make catch-up contributions in accordance with Code Section 414(v). Participants may also contribute amounts representing distributions from other qualified plans. The Company utilizes a safe harbor matching contribution formula. For the year ended December 31, 2024, the safe harbor matching contribution formula was 100% of the first 6% of salary deferred by the participant. The Company may make, at the discretion of the Board of Directors, an additional discretionary contribution. For the year ended December 31, 2024, a discretionary contribution equal to \$9,920,780 was made in 2025. For the year ended December 31, 2023, no discretionary contribution was made.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contributions and (b) plan earnings. Allocations are based on participant contributions, participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options: Each participant may direct their contributions in any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability regardless of years of services.

Vesting: Participants are immediately vested in their voluntary contributions, rollovers and employer safe harbor matching contributions plus actual earnings thereon. Vesting in employer discretionary contributions plus earnings thereon is based on years of continuous service. A participant is 100% vested in employer discretionary contributions after three years of credited service.

Forfeitures: The Plan provides that forfeitures of terminated participants’ non-vested account balances may be used to reduce employer contributions to the Plan or be reallocated to active participants based on the plan document. At December 31, 2024 and 2023, \$4,198 and \$10,863, respectively, were available to reduce future employer contributions. The Company used \$100,779 of forfeitures to reduce the Company’s matching contributions during 2024.

Notes Receivable from Participants: The Plan provides that participants can borrow from the Plan. These notes are secured by the balance in the participant’s account. These notes are limited to the lesser of \$50,000 or 50% of the participant’s vested account balance. The minimum note allowed is \$1,000. Note principal and interest payments are made in accordance with the note’s amortization schedule, and are made via payroll withholding. The interest rate on participant notes shall require a rate of return commensurate with the prevailing interest rates charged on similar commercial notes under like circumstances by persons in the business of lending money.

Payment of Benefits: On termination of service, disability, retirement, or death, a participant may elect to receive a lump sum amount equal to the value of his or her vested interest in the account. Benefit amounts under \$5,000 are automatically distributed to participants. In certain circumstances, participants may make “hardship withdrawals” as defined by the Plan. Active participants may also take distributions from the Plan upon attainment of age 59 ½.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and withdrawal fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Company.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan provides for various investment options including any combination of mutual funds, common stocks, collective trust funds, and other investment securities. The underlying investment securities are exposed to various risks, such as interest rate, market, liquidity and credit risks, as well as risks associated with ongoing global events. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants’ individual account balances.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants’ account balances.

Investment Valuation and Income Recognition: The investments of the Plan are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan’s principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair value of participation units in collective trusts are based upon the net asset values of funds as reported in the audited financial statements of the funds. The fund provides for daily redemptions by the Plan at reported net asset value per share.

Self-Directed Brokerage Accounts: Accounts consist of mutual funds, ETFs, common stocks and interest-bearing cash that are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Rowe Price Trust Company, the custodian of the Plan.

NOTE 4 – RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Certain professional fees for the administration and audit of the Plan were paid by the Company. Other professional fees were paid by the Plan to T. Rowe Price and Charles Schwab. Certain Plan investments such as the collective trust funds managed by T. Rowe Price Trust Company, the Plan custodian, and mutual funds managed by T. Rowe Price, an affiliate of the Plan custodian, qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Notes receivable from participants totaling \$2,448,470 and \$2,171,872 at December 31, 2024 and 2023, respectively, constitute party-in-interest transactions.

NOTE 6 – TAX STATUS

The Plan is qualified under the provisions of the Internal Revenue Code (“IRC”) and is not subject to federal and state income taxes. The Internal Revenue Service issued an opinion letter dated August 19, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original non-standardized pre-approved plan, Plan management believes that the plan is qualified and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 7, 2025, which is the date the financial statements were available to be issued.
